MINUTES OF THE MEETING EDUCATION AND CULTURAL RESOURCES COMMITTEE 50TH LEGISLATIVE SESSION HOUSE OF REPRESENTATIVES

The seventh meeting of the Education and Cultural Resources Committee was called to order by Chairman Jack Sands, on January 28, 1987, at 1:00 p.m., in Room 312-D of the State Capitol.

ROLL CALL: All members were present except Rep. Thomas who was excused.

CONSIDERATION OF HOUSE BILL NO. 198:

REP. RANDE ROTH, House District No. 96, sponsor of the bill, stated that HB # 198 is a housekeeping bill that requires teachers and specialists of special ed cooperatives to notify the superintendents of their certification. He noted that is already the law for all other teachers and specialists of regular school districts.

PROPONENTS:

GAIL GRAY, Director of Special Education for the OPI, said she would only emphasize what REP. ROTH had said. The bill was primarily housekeeping in nature it just requires that cooperative teachers and school school psychologists register their certificate with the county superintendent as every one else does. See EXHIBIT # 1.

BRUCE MOERER, representing the Montana School Boards Association rose in support of the bill.

OPPONENTS: None.

QUESTIONS FROM THE COMMITTEE:

In response to a question by REP. LORY, GAIL GRAY answered that cooperative teachers who teach in more than one county would only be required to register their certificate in one county.

CHAIRMAN SANDS questioned Gail Gray why it was important to register a certificate with the county superintendent under any circumstances. Ms. Gray replied that historically it has always been required, possibly because if someone questions the qualifications of a person to do a certain job he can go and check.

REP. ROTH simply stated he closed.

CONSIDERATION OF HOUSE BILL NO. 186:

REP. DENNIS NATHE, House District No. 19, sponsor of the bill, stated that HB # 186 was introduced at the request of the Montana School Business Officials. There is a problem with not having a fund to deposit lease or rental payments into and clerks have been using the "housing and dormitory" fund. The bill would delete the words "housing and dormitory" and insert the words "lease or rental agreement".

PROPONENTS:

GILE MITCHELL, OPI, stated there is no other fund to put rental or lease money into and this bill would allow it to be explained better on the school budget.

OPPONENTS: None.

QUESTIONS FROM THE COMMITTEE: None.

REP. NATHE simply stated he closed.

CONSIDERATION OF HOUSE BILL NO. 118:

REP. DENNIS NATHE, House District No. 19, sponsor of the bill, stated HB # 118 is a bill that again was brought up by the Montana School Business Administrators Association. the bill attempts to do is correct a problem in the debt service fund. The debt service fund is used when the bonds or the coupons have to be paid, usually in the month of December, and people don't bring in those bonds or coupons at the time they should. What the bill is attempting to do is to establish a debt service fund cash reserve that may not exceed 50% of the final debt service fund budget. However, the Montana Taxpayer's Association pointed out if this bill was passed and every school district did this state-wide, there would be one time extraction of about \$16.5 million dollars statewide into funds like this. The MTA has proposed an amendment which I will have them explain.

PROPONENTS:

SANDRA WHITNEY, representing the Montana Taxpayers Association, read her prepared statement, see EXHIBIT # 2. She submitted the following amendments; 1) Strike all of the amendments currently shown in sections 1 and 2.

2.) On line 19, page 1 insert after the first word the phrase "and any principle and interest amounts due between July 1 and Nov. 30 of the following school year," 3) On line 18, page 3 after the words debt service fund, insert the phrase, "and any principle and interest amounts due between July 1, and Nov. 30 of the ensuing school year, as provided in 20-9-438." She urged the committee's support of the proposed amendments and the alleviation of the problems in the school district.

BRUCE MOERER, representing the Montana School Boards Association, stated he supports the concept of HB # 118 and from his brief review of the amendments, would also support the concept that is contained in the amendments given the problems with perception they sometimes have with large reserves.

OPPONENTS: None.

QUESTIONS FROM THE COMMITTEE:

In response to a question from REP. LORY, Sandra Whitney stated she did think the title would also have to be amended to read "AN ACT TO ALLOW THE TRUSTEES OF A SCHOOL DISTRICT TO ESTABLISH A LIMITED DEBT SERVICE FUND CASH RESERVE AND AMENDING SECTIONS 20-9-438 AND 20-9-439, MCA."

REP. NATHE simply stated he closed.

CONSIDERATION OF HOUSE BILL NO. 279:

REP. DENNIS NATHE, HOUSE DISTRICT NO. 19, sponsor of the bill, stated that HB # 279 is a bill he introduced because superintendents across the State of Montana have had problems complying with any strict interpretation of the buildings codes in the State of Montana when it concerns typical maintenance. He noted there were some amendments that would be offered by the people from the building codes division that are acceptable to him.

PROPONENTS:

JIM KEMBEL, representing the Business Regulation Division of the Department of Commerce, read his prepared statement, see EXHIBIT # 3, and offered the proposed amendment to recfify his concerns, see EXHIBIT # 4. It reads Page 2, line 4 through line 8, following "the" strike line 4 through line 8 in their entirety. Page 2, line 4, following "the" insert "provision of the state building code relating to routine or preventative maintenance and other minor alterations for buildings owned or occupied by a school

district when the school district board has determined, and the appropriate county attorney concurs, that the proposed maintenance, alteration or repairs do not violate the state building code, nor cause the existing structure or building to become unsafe. An unsafe condition shall be deemed to have been created if such maintenance, repair, addition or alteration will cause the existing building to become structurally unsafe or overloaded; will not provide adequate egress in compliance with the provisions of the state building code; or will obstruct existing exits; will create a fire hazard; will reduce required fire resistance or otherwise will create conditions danderous to human life."

OPPONENTS:

GENE FENDERSON, representing the Montana State Construction Trades Council, spoke in opposition to the bill. He stated that out of all the public structures in the State of Montana, the schools should be the ones that are the most strictly enforced by the Montana State Building Codes.

ERIC FEAVER, President, Montana Education Association, spoke in opposition to the bill as written. He stated he was not ready to comment on whether the amendment would correct the deficiencies that he sees.

TIM BERGSTROM, Montana State Fireman's Association, stated he also opposed the legislation as it was written, but felt the amendment may satisfy some of his concerns.

QUESTIONS FROM THE COMMITTEE:

REP. WILLIAMS asked REP. NATHE what were the problems that caused the need for this legislation. REP. NATHE replied that the school superintendents just want the freedom to do routine typical maintenance on the buildings.

CHAIRMAN SANDS asked Jim Kembel about the amendment - that one of the conditions were that alterations or repairs could not violate the state building code - so wouldn't that do away with the flexibility that was intended to be given in the bill. Mr. Kembel responded that wording was added to insure that when repairs are made, such as the replacement of a glass door, it would meet the specifications required by the building codes.

REP. NELSON asked why it was necessary to get approval from the county attorney when he may be fifty miles from the school district, and why couldn't the local building Education and Cultural Resources Committee January 28, 1987 Page Five

building inspector of the local community inspect. Mr. Kembel stated that most of the county attorneys they have worked with in the past were willing to make those decisions by verbal communication with the school districts.

REP. NATHE noted in closing the intent of the bill is to give those superintendents some leeway and some flexibility from strict interpretation of the building codes.

CONSIDERATION OF HOUSE BILL NO. 333:

REP. KEENAN, House District No. 66, sponsor of the bill, stated that HB # 333 is basically an issue of taxation without representation. The bill provides that even if the taxable valuation isn't fair, the mathematical formula can be adjusted to enable a trustee to be elected in a district and sit on the board in Anaconda and have a say in how dollars are spent on the high school level. She noted that the bill is much more complex than she has simply stated it and would refer the committee to Bob Stockton, from OPI to answer any technical questions.

PROPONENTS:

DALE KUNZ, resident of Deep Creek, located between Wisdom and Wise River. Mr. Kunz explained to the committee that he was paying taxes along with many other people in his area and they did not have a vote for a board member in the Anaconda school district. He stated that was unconstitutional taxation without representattion.

OPPONENTS:

ERIC FEAVER, President, Montana Education Association, stated he opposed HB # 333. Mr. Feaver remarked if it is that people have lost their franchise because they don't represent enough property, that is a problem that needs to be corrected. But by allowing the continuance of representation based on property we are apparently in violation of federal law, constitutional law, and perhaps our own constitution that would require one person, one vote. The federal judge's decision in Windy Boy in Big Horn County basically divided that county up into alderman districts, so you will have school board trustees now elected out of specific districts in that county. The state probably needs to look at that decision as applicable to every county and every school district in the state and not exacerbate the current inequity of having property be the basis for representation but get to the notion

that people are the basis for representation.

QUESTIONS FROM THE COMMITTEE:

REP. SWYSGOOD asked Mr. Kunz if he had an option as to where he could send his children to high school. Mr. Kunz replied he did, but that did not pertain to where his taxes go, and the reason he had an option was that he could send his high school students to any school in the state, because where he lives in Deer Lodge County, they do not provide a bus system.

REP. DAILY noted that Butte-Siver Bow had eight trustees in the high school district -- seven who are elected from the community, and a rural trustee. Could the same concept apply in this situation? Mr. Stockton responded that technically it could, that the procedure would be to take the taxable valuation of the elementary school district and divide it by the number of elementary trustees who by law also sit on the high school level. He said you would come up with a dollar figure and divide it into this territory that lies outside the elementary district but inside the high school district which is the situation they have down there in Mr. Kunz' area. He further explained that you round that figure off and that is the number of additional trustees that are elected from the rural area to be on the school board. He said in their particular case the figure comes to less than .5 and when rounded off is zero, so they do not get an outlying trustee in that area. REP. DAILY then asked if Mr. Kunz could run as a trustee from Deer Lodge County right now. Mr. Stockton replied, no.

REP. WILLIAMS asked if those people could vote on school board elections, but would have no representation from their territory. Mr. Stockton replied they could vote on the levies but could not vote on the trustees.

REP. KEENAN closed by addressing a couple of issues. She explained there was enough taxable value in that area prior to the State of Montana and the Montana Fish and Game Department purchasing the Mount Hagin Ranch. She noted if the elementary and high school districts were not separate but were just one district K-12 the problem would be solved statewide. She suggested the committee consider addressing the districts being called K-12 versus elementary and secondary, which would be a major overhaul of the present system. She reiterated that the issue at hand was taxation without representation.

CONSIDERATION OF HOUSE BILL NO. 349:

REP. TOM HANNAH, House District No. 86, sponsor of the bill, stated he was presenting HB # 349 on behalf of the OPI. He said it was a very simple straightforward bill. He explained that currently under the special education budgets you can buy equipment but you don't have the right to repair it. He said the bill simply inserts on page 4, lines 3 and 4, the words ""repair and maintenance of equipment — the actual total cost".

PROPONENTS:

GAIL GRAY, representing the OPI, stated there was very little she could add, that it was a straight forward bill and that she would emphasize that this bill does not propose any type of funding for the repair and maintenance of the equipment. It simply adds flexibility for the use of already existing special education dollars. She urged the committee's support of the bill.

BRUCE MOERER, representing the Montana School Board's Association, rose in support of the bill.

REP. WILLIAMS, cosponsor of the bill said he thought it was ironical they have all the provisions for getting the equipment and then no provision for repairing it.

OPPONENTS: None.

QUESTIONS FROM THE COMMITTEE:

REP. SCHYE asked if this was just for the equipment from the special ed money. REP. HANNAH replied it was his nderstanding this was just for the special ed portion. REP. PHILLIPS noted that the cost of repairs can go up to the actual cost of replacement. REP. HANNAH stated he thought that language was included to try and avoid any spillage of money.

REP. HANNAH closed by saying, "another easy bill," Mr.Chairman.

EXECUTIVE SESSION:

ACTION ON HOUSE BILL NO. 349:

REP. DAILY moved DO PASS on HB # 349, the motion CARRIED unanimously.

Mr. Chairman and members of the committee:

For the record, I'm Sandra Whitney representing the Montana Taxpayers Association.

The intent of HB 118 is to solve some cash flow problems in the debt service funds which are created by a combination of bond principle and interest payment dates and the laws regarding the budgeting process. We support that intent. We do not support a debt service cash reserve of any percentage of the debt service budget.

In fiscal 1984 the debt service appropriations for elementary and high schools were \$28.4 million - in fiscal 1985, \$29.3 million - fiscal 1986, \$32.8 million - and fiscal 1987, \$34.9 million, demonstrating an increasing trend. Under this bill as it is written, if all schools took advantage of the reserve, the impact of a 50% reserve would have been over \$17 million this year. That is a one-time impact, but we believe it is not necessary.

Therefore, we would like to suggest amendments which would allow for a

limited cash reserve as follows:

- 1. Strike all of the amendments currently shown in sections 1 and 2.
- 2. On line 19, page 1 insert after the first word the phrase, "and any principle and interest amounts due between July 1 and Nov. 30 of the following school year,"
- 3. On line 18, page 3 after the words debt service fund, insert the phrase, "and any principle and interest amounts due between July 1 and Nov. 30 of the ensuing school year, as provided in 20-9-438."

The change in budgeting authority on page 1 would allow a limited reserve to be created to provide, not only for payments which would actually be due in a fiscal year, but for payments for which the liability had been accrued or will have been accrued before the November taxes are collected. The district would then levy enough money to have cash on hand to pay installments, as demanded by law.

The second amendment is necessary because the law requires the treasurer to calculate the cash to be reappropriated to reduce the levy. As the law is now, the only thing a treasurer can subtract from the cash balance is the outstanding warrants. The amendment on page 3 would allow the treasurer to hold that cash that is obligated for payments between July 1 and Nov. 30.

Therefore, we urge that you not enact a 50% reserve, but that you amend the bill to allow for a limited reserve to solve the cash flow problems in the debt service fund.
