

MINUTES OF THE MEETING  
APPROPRIATIONS COMMITTEE  
50TH LEGISLATIVE SESSION

The meeting of the Appropriations Committee was called to order by Chairman Rep. Gene Donaldson on March 4, 1987, at 1:00 p.m. in Room 104 of the State Capitol.

ROLL CALL: All members were present at the meeting except Reps. Winslow, Iverson, and Spaeth who were excused and Reps. Nathe and Switzer who were also excused but arrived late. Also present were Judy Ripplingale, LFA and Denise Thompson, Secretary.

HB 660: (38:A:0.45)

Rep. Peck presented amendments to the committee on HB 660 (Exhibit 1).

EXECUTIVE ACTION:

(38:A:7.12) Rep. Thoft moved the Peck amendments be adopted. Rep. Devlin called the question. The motion CARRIED unanimously.

Action on the bill as amended was postponed.

(The recorder was temporarily unplugged.)

HB 578: Rep. Swift moved to TABLE HB 578 by Rep. Cohen for PSC-Safety Inspector, which was previously tabled in subcommittee on February 18, 1987. The motion CARRIED.

HB 29:

Rep. Swift, Chairman of the Natural Resources Subcommittee stated the subcommittee passed the bill out with a do pass recommendation. The fiscal note is not needed as there is no expenditure for fiscal 1989.

Rep. Bardanoue, sponsor of the bill stated the bill would consolidate all of the land into one department. There are currently some lands in the State Lands Department, some in Fish, Wildlife, and Parks, and a few in the Highway Department. He said the easements will remain with Fish, Wildlife and Parks. The highway right-of-way will remain with the Highway Department, but it would coordinate all other lands into one central agency. The bill had no opposition in the subcommittee.

EXECUTIVE ACTION:

Rep. Swift moved HB 29 DO PASS. Rep. Peck called the question. The motion CARRIED unanimously.

HB 259: It was decided the hearing on HB 259 would be postponed until sometime after another bill which is in taxation is heard.

(38:A:14.50) HB 316: Rep. Bradley gave the committee a brief summary on the bill saying the Human Services Subcommittee heard the bill earlier and voted a do pass unanimously in that subcommittee. It had strong supporters from the Mental Health Group. The bill sets up a process for involuntary mental illness assistance. The fiscal impact was based on 20 individuals who would be pulled into mental health centers or community systems with an anticipated number of 5 days of treatment. That conclusion would be the fiscal impact of approximately \$38,000 each year.

Rep. Menahan spoke in support of the bill stating it is necessary to take care of these people and help them.

Rep. Bradley remarked it changes the definition of mentally ill by taking someone who is not necessarily potentially dangerous and helping the family get them the aid they need.

EXECUTIVE ACTION: (38:A:24.50)

Rep. Menahan moved to DO PASS HB 316. Rep. Quilici called the question. The motion carried unanimously.

HB 760 and HB 777:


Rep. Connelly moved to DO PASS HB 760. Rep. Bradley stated this is the technical bill that provides the authority for the Board of Examiners to issue bonds for the clean up of Hazardous Wastes and it is tied to HB 777 which provides for the RIT interest income for federal matching in the cleanup sights the match being a 9-1 federal match for cleanup or litigation.

Rep. Donaldson asked that the bills be referred to Rep. Thoft for his committee to look at them a determine the RIT funding levels.

Rep. Connelly withdrew her motion and the bills were held until Rep. Thoft's committee, Long Range Planning, had examined them.

ADJOURNMENT:

There being no further business before the committee the meeting was adjourned at 1:40 p.m.
