The first meeting of the Institutions and Cultural Education Subcommittee was called to order in room 202-A of the State Capitol by Chairman Ron Miller on January 6, 1987 at 8:08 a.m.

ORIENTATION:

Chairman Miller announced that the committee was going to tour the central office of the Department of Institutions this morning and they were going to the mental health centers in Helena tomorrow. He also advised that a tour was planned of the Youth Evaluation Program (YEP), the School for the Deaf and Blind, the Easter Seal facility (which teaches the developmentally disabled), and the Pre-Release Center in Great Falls on Saturday, January 10. See itinerary (exhibit 1).

Representative Miller informed the committee that the legislature may be studying the impact that vacancy savings has on the state, and on small agencies in particular, and this issue may come to this committee.

Representative Menahan said that he and Tom Gomez, Legislative Researcher for the Legislative Council, met with the staff at Warm Springs and there was a bad report from the Board of Visitors from Warm Springs and one of the things that led to the demise of good treatment and care of the patients has been vacancy savings. He indicated that there were only two doctors for approximately 300 patients and one of the doctors is 72 years old. He advised that Sandy Hill,

a young girl just out of school, told them that she could get relieved of her duties by writing to the school and letting them know what the state of Montana is doing to her - working her seven days a week and being on call and she indicated that they were only 'warehousing' the people there.
