MINUTES OF THE MEETING LONG RANGE PLANNING SUBCOMMITTEE 50TH LEGISLATURE SESSION

The meeting of the Long Range Planning Subcommittee was called to order by Chairman Rep. Robert Thoft on January 16, 1987 at 8:00 a.m., in Room 202B of the State Capitol.

<u>ROLL CALL</u>: All members of the Long Range Planning Subcommittee were present.

Executive Session:

Grant #208 Livingston Depot Foundation:

Action: Sen. McLane MOVED to reconsider grant #208. The MOTION CARRIED unanimously.

CULTURAL AND AESTHETIC PROJECTS

Grant #208 Livingston Depot Foundation: (050)

Aileen Storey, said the Livingston Depot Foundation needs monies to hire a professional curator. Ms. Storey said this would be the only time the Foundation would ask for grant monies.

Ms. Storey said the Foundation would open July 1, 1987.

Ms. Storey said the county does allocated .3 mills to another museum in the area.

Rep. Bob Raney said he supports the project. Rep. Raney said the designer of the Depot was from France.

Sen. Walker said he wanted to confirm the statement that the Depot Foundation would only be asking this once for a grant. Ms. Storey said yes. Chairman Thoft asked if they get less funds could they still do the project. Ms. Storey said no. Sen. McLane asked if there was a membership fee for the Foundation. Rep. Raney said yes, \$50 per couple. (100)

Grant #182 St. Ignatius Mission: (123)

Sen. Pinsoneault said the St. Ignatius Mission Restoration Committee will conduct the restoration and preservation of the murals on the vaulted ceiling of the St. Ignatius Mission Church, and the cleaning and painting of the interior walls.

Sen. Van Valkenburg said the separation of church and state is an issue here, and should not be over looked.

Mary Pinsoneault presented the Long Range Planning Subcommittee a brochure (Exhibit 1), and a video tape called the Mission Journal. Mrs. Pinsoneault said the church was declared a historic site in 1983.

Rep. Bardanouve asked if the church was still used as a church. Sen. Pinsoneault said yes.

Sen. McLane asked if the Attorney General's opinion said that we could not do this project even if we wanted to. Chairman Thoft said correct.

Grant #233 Fox Theatre Corporation: (374)

Ann Miller, Fox Theatre, said the theatre was designed in the 1920's, and in the late 1970's was no longer feasible to show movies. The Theatre was renovated to be a performing arts center. Ms. Miller said the theatre is being further renovated and is scheduled to reopen on January 24, 1987, after being closed for 1 and a half years. Since performing art centers virtually never generate enough income to cover expenses, the \$500,000 endowment is a necessary part of the project.

Ms. Miller said the Fox Theatre Corporation will need \$71,210 in endowment income and fund raising to balance the \$170,000 budget and will be charging local arts groups \$900 per performance. If they tried to cover their operations budget through renting the theatre, they would have to more than double their rental rates, making the theater's cost prohibitive to most groups. Interest from the endowment will help to maintain access to the Fox for local groups. Ms. Miller presented an invitation to the Theatre (Exhibit 2).

Kay Foster, said she is in support of the project, and the City of Billings is behind them all the way.

Chairman Thoft asked the Montana Arts Council (MAC) if challenge grants are given, can the recipients request a second grant. Dave Nelson, MAC, said yes if they are successful with the first one, they are not prohibited to try for a 2nd.

Grant #207 Billings Symphony Society:

Ann Miller said the Billings Symphony Society will create a \$60,000 endowment to help support the Billings Symphony

general operation. Ms. Miller said the Symphony's long range goal is to build an endowment to \$250,000 by 1990. The symphony will use its own resources to hire a part time development director for the purpose. Ms. Miller said the Symphony has received a donation of \$25,000. Sen. Walker asked if \$25,000 was all they had for the endowment fund. Ms. Miller said no, they had received \$5,000 in small donations.

Ms. Miller presented the Long Range Planning Subcommittee with a brochure on the Symphony (Exhibit 3).

Grant #176 Missoula Symphony Association: (140)

Joe Mussulman, Missoula Symphony Association, said the Symphony has been working with an attorney to establish a permanent endowment of \$400,000. Mr. Mussulman said they agree with the Citizen Review Committee's recommendation of \$40,000, and the contingency of one third of the monies being in cash. Sen. Walker asked how much they have for the endowment. Rae Dabbert said \$100,000, a majority of which is paid up life insurance.

Grant #212 Missoula Museum of the Arts: (338)

Mary Cummings, presented the Long Range Planning Subcommittee with a brochure on the Missoula Museum (Exhibit #4). Ms. Cummings said the Museum received .9 mills from the county, which is a value of \$112,620 in 1986. Ms. Cummings said the endowment funds won't replace the operational support funds. Ms. Cummings said they are one third of the way toward meeting their endowment with cash.

Grant #238 Montana Art Gallery Directors Association: (416)

Mary Cummings, member of Board of Directors, said they are essentially a coop. There are 30 art organizations that belong to the Montana Art Gallery Directors Association. Sen. Van Valkenburg asked if their organization is the same as the Montana Arts Consortium. Ms. Cummings said it is cheaper to have different associations do as much of the coordinating as possible. Rep. Bardanouve said the should form one organization then they would just have one administration, endowment, etc. Ms. Cummings said there is a problem because of the large geographic area of Montana. Rep. Bardanouve asked Ms. Cummings if the Montana Art Gallery Assoc. was more concerned with their community than art. Ms. Cummings said essentially yes they are. Dave Nelson, MAC, said the associations of the this kind are properly run.

Grant #200 Montana Chorale

Grant #241 Montana Chorale
Grant #239 Montana Chorale: (524)

Verna Strand, Montana Chorale, said the Chorale is a state wide professional touring chamber established in 1976, which conducts workshops for college and high school students. (20:A:000) Ms. Strand presented the Subcommittee with a brochure titled Festival of the Rockies (Exhibit #5), this brochure deals with grant #239 which is their lowest priority of the three grant requests.

Sharon Weaver, Founder and Co-Manager of the Montana Chorale, said grant #200 is their priority in order to provide long term support. Ms. Weaver said the Chorale received a cash donation of \$30,000 to match the endowment.

Ms. Weaver said grant #241 is their second priority. Ms. Weaver said they need the grant to strengthen the Administration of the Chorale. The Problem with the Citizen Review Committee's decision is that it may be difficult to hire a business manager for \$6,000.

Rep. Bardanouve asked if you pay their singers. Ms. Weaver said just a portion of them.

Grant #261 Copper Village Museum Art Center Grant #232 Copper Village Museum: (229)

Susan Barnett, Copper Village Museum Art Center, said grant #261 was not recommended for funding by the Citizen Review Committee because of lack of preparation. Ms. Barnett submitted a revised budget (Exhibit #6), which asks for \$4,000 for art studio equipment.

Ms. Barnett said the Museum used to receive \$25,000 from local government, and now receives \$5,000 from local government. Ms. Barnett said their endowment goal is \$40,000.

Grant #216 MSU - KUSM Television: (392)

Ed Groenhout said KUSM Television wants to increase the power on the KUSM signal in order to extend it to surrounding communities. Mr. Groenhout said there are no local funds involved.

Rep. Bardanouve asked if it is hard to get a license granted by the FCC to increase power. Mr. Groenhout said no. The FCC is encouraging them to extend their signal to 30,000 watts.

Grant #249 Garnet Preservation Association: (450)

Dick Fickler, Project Director, Garnet Preservation Association, said in the last two years the Association has tripled its memberships.

Mr. Fickler said the Association used their 1987 biennium grant monies to preserve four buildings.

Mr. Fickler said this noncommercial ghost town's fund raising goal is \$100,000 for endowment. 20% of the interest from the endowment will go back into the endowment.

Mr. Fickler said the Garnet Preservation Association has three 16'x 22'Paxton oil paintings, appraised at \$65,000, that have been donated for fund raising. Mr. Fickler said the paintings will be marketed at the end of two years, and the monies from the sale of the paintings will be used as the match for the grant.

Mr. Fickler said 2/3 of the Mary Anderson claim has been donated to the Garnet Preservation Society.

Sen. Aklestad asked how many visitors come through the town. Mr. Fickler said there were 16,000 visitors in 1986. (20:B:000)

EXECUTIVE SESSION

Grant #209 Billings Preservation Society: (150)

Discussion: Bob Archibald said the Society was appropriated \$50,000 toward the purchase price of the Moss Mansion in 1983. There is presently a bill bill before the 1987 legislature to forgive \$113,000 in inheritance taxes as an in-kind ocntribution toward the purchase of the mansion. Mr. Archibald gave the Long Range Planning Subcommittee some more information on the Moss Mansion.

Rep. Bardanouve asked Mr. Archibald what will happen to the furniture in the mansion. Mr. Archibald said it is in the mansion, but is not included in the \$670,496 appraised value of the mansion.

Rep. Bardanouve asked what is the repair bill on the Moss Mansion. Mr. Archibald said he does not know.

Rep. Bardanouve asked how the Moss Mansion compares with the Daly Mansion. Mr. Archibald said the Daly Mansion was not a

permanent home for the Daly family, it was more of a summer home for them. Mr. Archibald said the Moss family always lived in their home.

Grant #189 Salish Kootenai College: (382)

Discussion: Bill Pratt, Montana Arts Council, said he talked to Joe Mc Donald and they said they could handle a \$5,000 decrease in funds.

Grant #256 Northern Montana College:

Discussion: Sen. Van Valkenburg tried to find out information about this project from KUFM, but KUFM has had little contact with the group from NMC.

Grant #209 Billings Preservation Society:

Action: Sen. Van Valkenburg MOVED to APPROVE grant #209 as recommended by the Citizen Review Committee. Rep. Bardanouve made a SUBSTITUTE MOTION to not pass grant #209. The MOTION FAILED with Rep. Bardanouve, Thoft and Sen. Aklestad voting yes. The subcommittee returned to the ORIGINAL MOTION; the ORIGINAL MOTION FAILED with Rep. Bardanouve, Chairman Thoft and Sen. Aklestad voting no.

Action: Sen. Van Valkenburg MOVED that when they APPROVE a project that they include the contingencies recommended by the Citizen Review Committee. The MOTION CARRIED unanimously. 21:A:000

Grant #208 Livingston Depot Foundation:

Action: Rep. Bardanouve MOVED to APPROVE grant #208 as recommended by the Citizen Review Committee. The MOTION CARRIED unanimously.

Grant #189 Salish Kootenai College:

Action: Sen. Van Valkenburg MOVED to APPROVE \$15,000 for grant #189. The MOTION CARRIED unanimously.

Grant #256 Northern Montana College:

Action: Sen Aklestad MOVED to NOT APPROVE grant #256. Sen. Van Valkenburg made a SUBSTITUTE MOTION to pass consideration. The MOTION CARRIED unanimously.

Grant #200 Montana Chorale: (099)

Action: Rep. Bardanouve MOVED to APPROVE grant #200 as recommended by the Citizen Review Committee. The MOTION CARRIED unanimously.

Grant #241 Montana Chorale:

Action: Rep. Bardanouve MOVED to APPROVE grant #241 as recommended by Citizen Review committee. The MOTION CARRIED unanimously. Sen. Walker made a SUBSTITUTE MOTION to increase funds from \$6,000 to \$8,000. The MOTION FAILED with Sen. Van Valkenburg, Sen. Aklestad, and Chairman Thoft voting no.

Grant #239 Montana Chorale:

Action: Rep. Bardanouve MOVED to NOT APPROVE grant #239. The MOTION CARRIED with Sen. Walker voting no.

Grant #261 Copper Village Museum Art Center:

Action: Rep. Bardanouve MOVED to NOT APPROVE grant #261. The MOTION CARRIED unanimously.

Grant #175 Montana Historical Society: (304)

Discussion: Bob Archibald said as the use of written records declines, oral records across the country become more important.

Action: Rep. Bardanouve MOVED to APPROVE grant #175 as recommended by the Citizen Review Committee. Sen. Walker made a SUBSTITUTE Motion to PASS CONSIDERATION. The MOTION CARRIED unanimously. Rep. Bardanouve withdrew his MOTION.

Grant #223 MSU - Vigilante Players:

Action: Sen. Walker MOVED to APPROVE grant #223 as recommended by the Citizen Review Committee. The MOTION CARRIED unanimously.

Grant #181 MSU - Shakespeare in the Park:

Action: Sen. Van Valkenburg MOVED to APPROVE grant #181 as recommended by the Citizen Review Committee. The MOTION CARRIED unanimously.

Grant #231 Hockaday Center for the Arts:

Discussion: Sen. Van Valkenburg said he had reservations because they didn't apply for an endowment grant. Dave Nelson, Montana Arts Council, said the company is in a unique financial bind. Rep. Bardanouve asked if their budget is too high. Dave Nelson, MAC, said no they provide high quality service. (609)


I spoke to Mr. Bill Pratt about this and he advised us to get these letters to you so you can present them to the Conmittee at the hearing.
