NATURAL RESOURCES SUBCOMMITTEE  
50TH LEGISLATIVE SESSION  
HOUSE OF REPRESENTATIVES

February 10, 1987

The meeting of the Natural Resources Subcommittee was called to order by Chairman Swift on February 10, 1987, at 8:10 a.m. in room 317 of the State Capitol.

ROLL CALL: All subcommittee members were present. Also present were Carl Schweitzer, Senior Fiscal Analyst, from the Office of the Legislative Fiscal Analyst (LFA) and Karen Vollstedt, Budget Analyst, from the Office of Budget and Program Planning (OBPP).

Commerce (EXHIBIT 1)

Tape 69A

Lottery Bureau

Chairman Swift said that that this subcommittee needs to clear the recommendation for the Lottery Bureau appropriation level.

Keith Colbo, Director, Department of Commerce, in answer to a question from Sen. Smith, said that the referendum included the loan for the Lottery Bureau. Sen. Smith said that the referendum stated that the administrative costs could not exceed 15%. There is a bill this session to raise that to 20%.

Carl explained that the issue is whether this subcommittee going to recommend what the House has passed on second reading.

Rep. Devlin MOVED that this subcommittee accept HB 374 as it came off the House floor after second reading, with the adjustments that bring administrative costs close to 20%. Motion passed with Sen. Smith and Sen. Boylan voting no.

Diana Dowling, Director, Lottery Bureau, distributed to subcommittee members an organization chart of the Lottery Bureau (EXHIBIT 2).

Video Poker

In answer to a question from Sen. Boylan, Andy Poole, Administrator, Management Services Division, Department of Commerce, said the enforcement of the video poker

program would be contracted to the Department of Revenue.

Rep. Devlin MOVED to transfer the administration of the video poker program from the Department of Revenue to Commerce. Motion passed unanimously.

#### Business Assistance Division

##### Advertising

Carl explained that the subcommittee eliminated the general fund appropriation for this program which eliminated the staff to prepare and solicit the advertising. The advertising program is funded with private funds. Carl asked if the subcommittee wished to reconsider the advertising budget.

Mr. Colbo said that the Business Assistance Division would have neither the staff or the purpose to spend private funds at this point. Rep. Spaeth stated that Red Lodge has benefited from the Business Assistance Division. Rep. Devlin asked the Mr. Colbo to furnish him with the ad that the Business Assistance Division ran in the Wall Street Journal. Mr. Colbo said he could show him 11 ads.

Sen. Smith said he could not appropriate general fund money without knowing what the Division had accomplished.

Rep. Spaeth MOVED to delay action on the Business Assistance Division and the MOD for small business development centers as they involve general fund match. Motion passed unanimously.

#### MOD Pacific Rim Trade Office

Rep. Devlin asked if the three agencies that put money into this program have committed funds. Mr. Colbo replied that one has and one has not; the wheat interests have committed, the beef industry has not. The Department is still looking at the cost sharing to be 1/3 by wheat interests, beef industry, and tourism. Rep. Spaeth explained that the issue is spending authority.

Rep. Spaeth MOVED to recommend monies for Pacific Rim Trade Office because it does not require general fund monies, pending the legislation approval. Motion passed with Rep. Devlin voting no.

Science and Technology

MOD Seed Capital

Carl explained that the MOD for the seed capital is related to the proposal of using the coal trust fund to back up funds for seed capital program. The Department asked for two additional FTE's in '88 and three in '89. Sam Hubbard, Director, Montana Science and Technology Alliance, said that legislation for the proposal would be introduced today.

Tape 69B

Sen. Smith MOVED that the subcommittee withhold action on the MOD for seed capital. Motion passed unanimously.

MOD Secretarial Position

Carl explained that MOD for the secretarial position was to be funded with alternative energy funds. Rep. Spaeth questioned if the bonding program did not pass, would there be a need for this position. Mr. Hubbard replied that they would still need the secretarial position. This is not an increase in the appropriation; it is a transfer within that appropriation.

Rep. Spaeth MOVED to approve the MOD for the secretarial position. Motion passed with Sen. Smith and Sen. Story voting no.

Hard Rock Board

Chairman Swift explained that the question was whether or not the subcommittee wanted to review this as is presently being done, or whether this should be placed in a statutory appropriation where it wouldn't have to be considered at every budget process.

Sen. Story said that he did not like statutory appropriations. Sib Clack, budget analyst, Governor's office, explained that monies are subaccount that are set aside for each specific county in which there has been specific development. Those monies, by law, can only be spent for those counties.

Carolyn Doering, Budget Analyst, Department of Commerce, said that LC 963, that the appropriation to the trust fund be a statutory appropriation. Carolyn said that the subcommittee had approved the operating

expenses and held off on the trust fund appropriation pending the legislation.

Chairman Swift said that the sense of the subcommittee is that they have made their decision on this matter.

#### Director's Office - County Printing

Carl explained that the director's office and management services are financed by priorities funds. There is one general fund amount in the director's office and that \$975 for county printing.

Sen. Smith MOVED to approve the item for county printing. Motion passed unanimously.

#### Director's Office - Dues

Carl explained that there had been some question about the Department paying for the National Governor's Association dues of \$2,050 per year. Carolyn Doering said that the total amount for NCSL is \$26,000; \$21,000 of that is paid by the governor's office, \$3,000 is paid by the budget office for National Association of State Budget Offices, and \$2,050 is paid for by the Department of Commerce for the Council of State Planning Agencies.

Rep. Devlin asked what the consequence would be if this expenditure were not allowed. Andy Poole answered that that would not have a significant effect on the Department of Commerce.

Rep. Devlin MOVED to not accept the item for National Governor's Association dues. Motion passed with Rep. Manuel and Rep. Spaeth voting no.

#### Milk Control Board

Carl explained that this item is on the agenda for clarification. This had to do with putting language in the bill that if a petition was started the Department could come in for a budget amendment. Rep. Devlin MOVED to accept this item to add boiler plate language, if a petition was filed. Motion passed unanimously.

#### Board of Investments

The subcommittee needs to take action on the executive proposal to transfer the Board of Investments to Commerce and incorporate the Montana Economic Development Board with the Board of Investments--SB

298. Chairman Swift commented that if the bill is just being introduced, it would be premature to take action on it.

Fish, Wildlife, and Parks Budget (Continued) EXHIBIT 3

Wildlife

17. MOD, R-1 Landowner/Hunter Asst. Mr. Flynn explained that this is one-half of the Thompson Falls person that was approved yesterday.

Rep. Devlin said he had requested that the department provide him with the budget was for FW&Ps in '81. Mr. Flynn replied the department was preparing a worksheet. The budget in '81 was approximately \$19.6 million per year.

Rep. Manuel MOVED to accept MOD 17. Motion passed unanimously.

18. MOD, Weed Control. Mr. Flynn explained that this item is in two budgets, the wildlife budget, and the parks division. Sen. Smith MOVED to accept MOD 18. Motion passed unanimously.

19. MOD, SW enhancement enforcement survey. In answer to a question from Rep. Devlin, Mr. Flynn explained that the department would like to establish permanent check stations in Lewistown, Glendive, and Billings.

Sen. Boylan MOVED to accept MOD 19. Motion passed with Sen. Smith voting no.

Tape 70A

20. MOD, Hunter Opportunity/Game Damage. Mr. Flynn explained that the Bozeman region wildlife program is of such a magnitude that the department is proposing one FTE to be an assistant regional manager. Forty percent of the Montana's elk harvest is in this region.

Sen. Smith asked how many game biologists the department has now. He said that the biggest complaint he gets from hunters concerns the large number of biologists. Mr. Flynn answered that there were 93.5 FTE's for wildlife last session, and 90.3 FTE's are requested this season.

Sen. Smith MOVED to not accept MOD 20. Motion passed unanimously.

Rep. Spaeth MOVED to accept MOD 21. Motion passed unanimously.

Adjustments

Sen. Smith MOVED to accept the following adjustments:

1. Adding more dollars into Big Horn Sheep program to agree to the revised revenue estimate.

2. Adding back .20 FTE inadvertently cut in the non-game program.

Motion passed.

Rep. Manuel MOVED to accept MODS:

3A. Taxes on wildlife management areas. Increase in taxes greater than expected.

3B. Some wildlife management areas are not being taxed by counties.

Motion passed.

Mr. Flynn distributed to members: Changes to Grounds Maintenance Contracts, EXHIBIT 4, and 1988-89 Maintenance Contracts, EXHIBIT 5.

Sen. Smith MOVED to accept this capital grounds maintenance program. Motion passed unanimously.

Parks

Sen. Smith MOVED to accept the executive budget on Item 1. Motion passed unanimously.

Sen. Smith MOVED to accept the executive budget on Item 2. Motion passed unanimously.

Rep. Devlin MOVED to accept the executive budget on Item 3. Motion passed unanimously.

Rep. Spaeth MOVED to accept the executive budget on Item 4. Motion passed unanimously.

Rep. Devlin MOVED to accept the executive budget on Item 5. Motion passed unanimously.

Rep. Spaeth MOVED to accept the executive budget on Item 6. Motion passed unanimously.

Item 7. Sen. Smith asked if park security was going to be contracted services. Mr. Flynn said he assumed it would be both contracted services and department employees.

Sen. Smith asked what the present security budget was. Mr. Flynn answered that the current level is \$9,000 for FY 86.

Rep. Manuel MOVED to accept the executive budget on Item 7. Motion passed unanimously.

Sen. Smith MOVED to accept executive budget on Item 8. Motion passed unanimously.

Item 9. Parks Planning Document & Park Signing. Mr. Flynn explained that the majority of this item is in one document, the \$23,000 to publish the statewide outdoor recreation plan. This plan is necessary for Montana to qualify for Land and Water Conservation Funds. The department is required every five years to produce this document for federal requirements. Mr. Flynn pointed out that there is discussion at the federal level of eliminating Land and Water Conservation Funds. If that happened, the plan would not be necessary.

Sen. Story MOVED to accept the executive budget on Item 9, and this item would revert back to current level rather than the high level of this biennium. Motion passed.

Rep. Manuel MOVED to accept executive budget on Item 10. Motion passed unanimously.

Sen. Smith MOVED to accept executive budget on Item 11. Motion passed unanimously.

Item 12 and 14. Snow and Compaction Meter. Rep. Devlin asked what a compaction meter was. Mr. Flynn explained that the department does quite a bit of work for contractors for paving. At the present time, a contracted engineer comes in with a compaction meter to make sure that the project was done according to specifications. Department people are qualified to use these instruments. Mr. Flynn explained that this is paving that the department does for at various headquarters and some of the park sites.

Tape 70B

Mr. Flynn said that the compaction meter would be a one time purchase. Sen. Story suggested asking the highway department about using their local compaction meter.

Sen. Smith MOVED to accept the executive budget on Item 12. Motion passed unanimously. (Item and 13 and 15 are the same.)

Sen. Smith MOVED to accept Item 15. Motion passed unanimously.

Parks Adjustments

Rep. Spaeth MOVED to accept the following adjustments:

3. Transfer functions to Field Services. With the deemphasis on acquisition and development of Parks, and an increasing program for boat facilities and sheep and waterfowl habitat, it is recommend to transfer some support services to the Field Services Division.

4. As a result of the refunding of the functions listed in 3 above, Parks funding sources will be freed up for increased operations and maintenance support.

Motion passed unanimously.

Rep. Devlin MOVED to accept Adjustment 2:

Some counties are not submitting tax notices on fishing access sites.

Motion passed unanimously.

Conservation Education

Rep. Spaeth MOVED to accept the executive budget on Items 1 and 5 (hunter safety and boater safety awareness). Motion passed unanimously.

Item 2. Mr. Flynn explained that the department sends films out to schools, organizations, and clubs on request. The continual use is eroding the quality of the film. This money is to redo some films. Rep. Spaeth MOVED to accept the executive budget on Item 2. Motion passed unanimously.



Item 3. Mr. Flynn explained that Project Wild is an education program that the department participates in with the Office of the Superintendent of Public Instruction (OSPI) over the last four years. It is a teaching aid that is available to elementary and secondary teachers. Dave Mott, Administrator, Centralized Services Division, explained that the department is contributing one-half and OSPI is contributing one-half to this project. OSPI funding is possibly drying up. The department wants to replace OSPI funding with license dollars.

Rep. Devlin MOVE to not accept MOD-Item 3. Motion passed unanimously.

Rep. Manuel MOVED to accept MOD-Item 4. Motion passed unanimously.

#### Administration

Rep. Spaeth MOVED to accept the executive budget on Item 1. Motion passed unanimously.

Sen. Story MOVED to insert some boiler plant language that no monies can be used in lawsuits between state agencies (in which the agencies is the plaintiff) without the written permission of the governor. Motion passed unanimously.

#### Fisheries

6. MOD, Expanded Fish Hatchery. Rep. Manuel asked Mr. Flynn whether the level that the department asked for this MOD was adequate. This money is eligible for matching federal Dingell/Johnson funds. There would be no additional FTEs. Rep. Manuel said that this hatchery project is important to Montana.

Rep. Manuel MOVED to add \$60,000 federal funds for each year in MOD-Item 6. Motion passed unanimously.

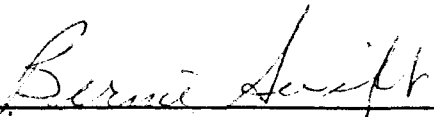
#### Centralized Services

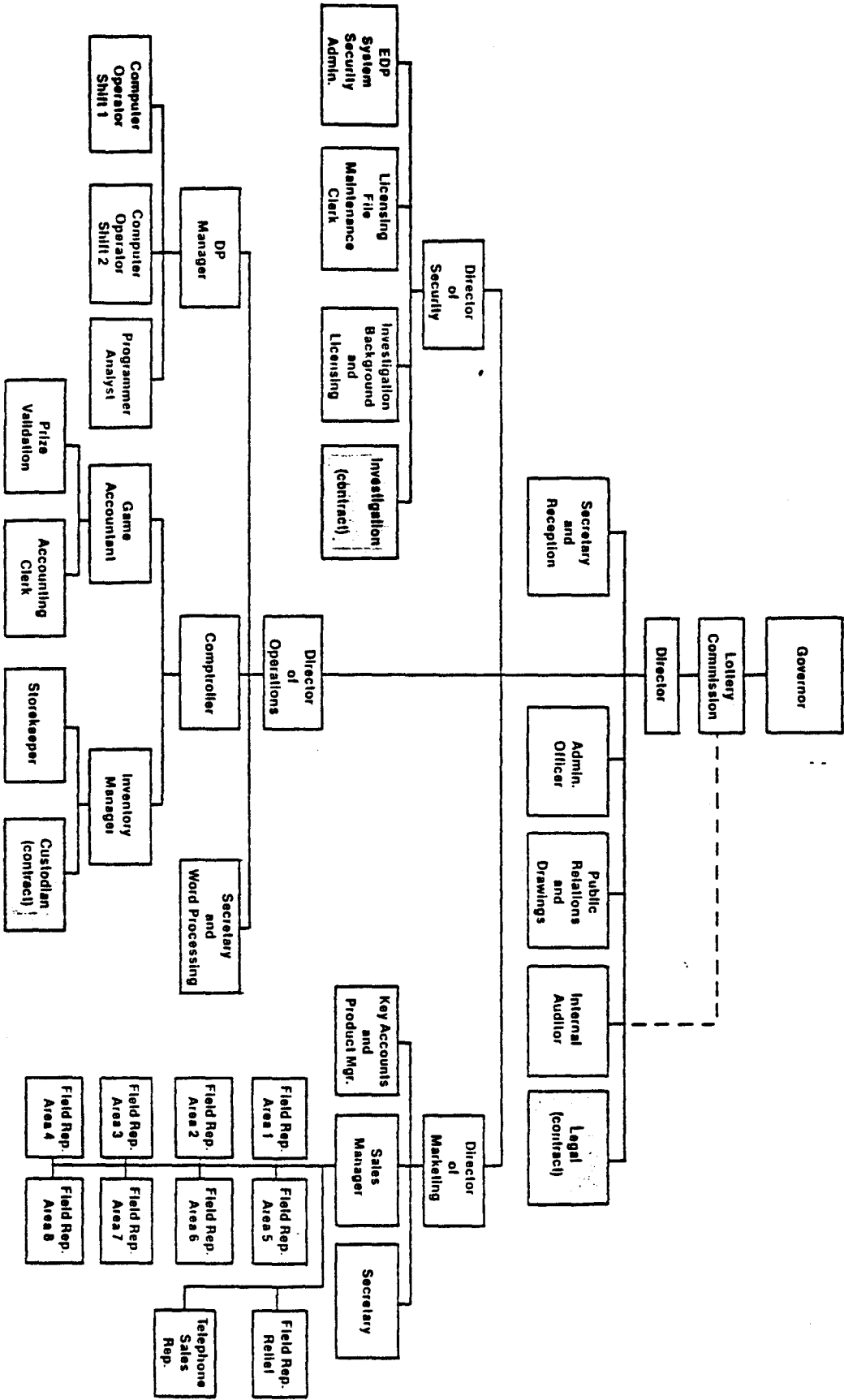

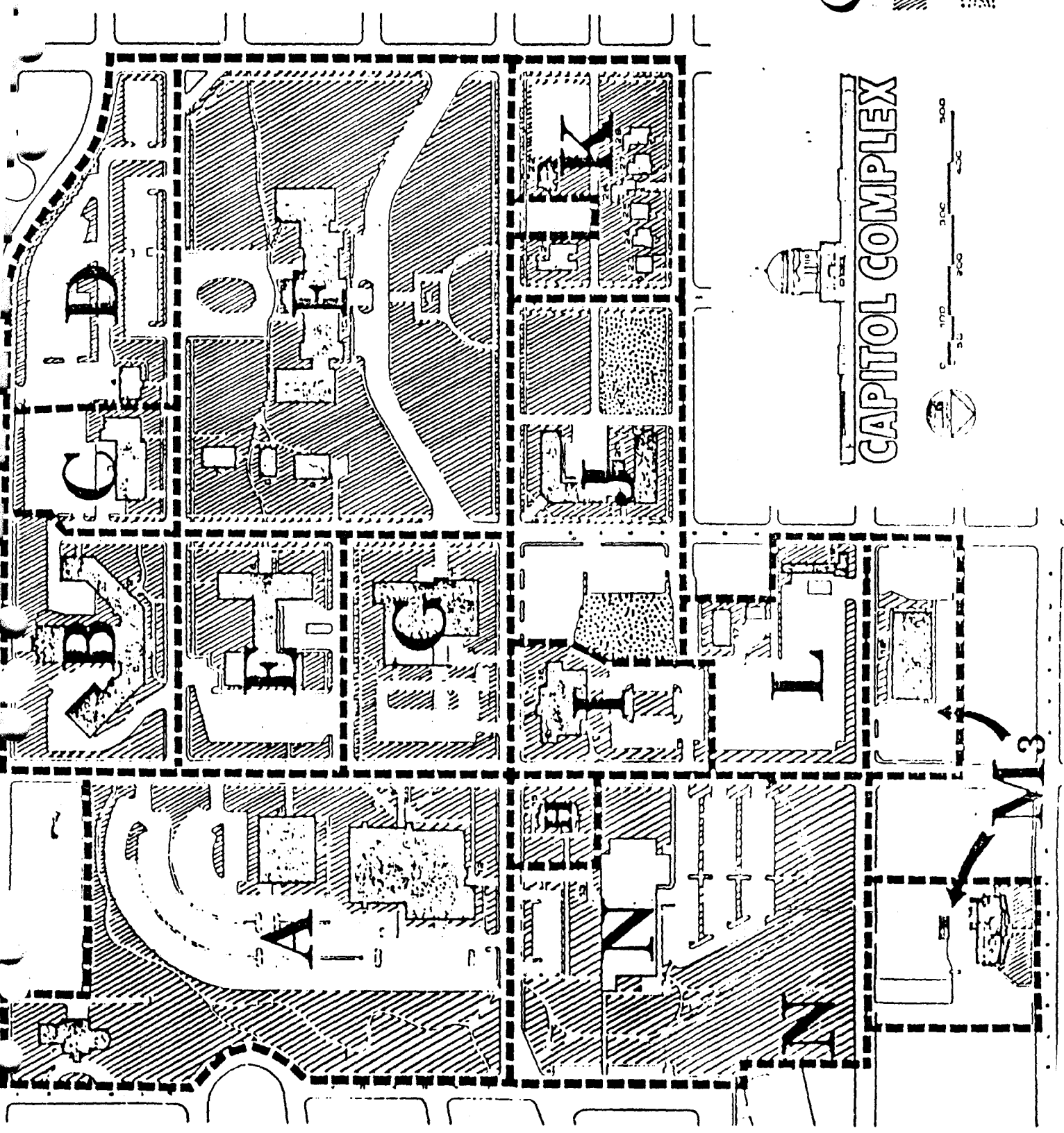

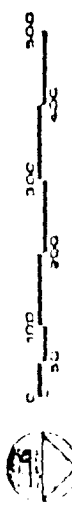
