COMMITTEE ON APPROPRIATIONS

Call to Order: By Chairman Bardanouve, on March 18, 1989, at
8:04 a.m.

ROLL CALL

Announcements/Discussion: Chairman Bardanouve said the Pay Plan subcommittee requests permission for a committee bill. He said it seems they have about resolved the pay plan issue. He said in this plan the employees will not pay more insurance.

Representative Quilici said he had gone over the proposed pay plan with Terry Johnson and with Sundsted, and asked if this is the plan they want the select committee to use? He said there are a couple things they need some direction on, one is there are 4400 out of 5600 employees that their leadership has ratified the contract, but the rank and file has not done so yet. He said he would like to ask, what about the employees in the University System? Rep. Bardanouve said the classified employees are, but not the academic employees. Rep. Quilici said some of the classified are not. Rep. Bardanouve said this is just a request for a committee bill, we can act on that bill later.

***Motion: Motion by Representative Marks that the select committee on the pay plan be granted permission to introduce a committee bill.

Recommendation and vote: Voted, passed, unanimous vote of those present.

DISPOSITION OF house bill 117

Motion: Motion by Representative Thoft to table House Bill 117.

Discussion: Representative Thoft felt this was not really needed if it is in the Governor's bill. Representative Bardanouve said this machine shop has been put in the Governor's bill which we will have about Monday.

Amendments, Discussion, and Votes: None

Recommendation and Vote: Voted, passed, 10 members voting yes, 9 members voting no.

HB 200

House Bill 200 sponsored by Vincent was discussed. There was a motion by Representative Kimberley that this bill do pass. Representative Grady said there were some amendments he wanted to put on the bill, and asked that the bill be held until later. Representative Bradley said the 2.5 FTE are already appropriated for. Representative Bardanoue said he would hold the bill until Monday morning. Representative Bradley expressed concern that since these bills were in the committee to look at the appropriations, that further amendments on the contents of the bill should not be made. Members of the committee pointed out that contents had been amended before on bills that had passed other committees and were in Appropriations to look at the money.

Representative Grinde said there was no fiscal note on this and we gave the 2.5 FTE in our subcommittee, and asked if this had been taken off this number. He said he did not feel we were dealing with the correct numbers. He said the committee should know they are voting on \$60,000 Research and Referral per year. Rep. Bradley said the 2.5 FTE needed for the additional work load in the Department are already in the budget, we did not incorporate the R and R money. Rep. Grinde said they had a lot of debate on this in the subcommittee, and asked just how far \$60,000 would go in one year and who was going to get it. Rep. Grady said he did not have a problem with the concept, but felt it goes further than the intent of the legislation.

Representative Kimberley said he had asked SRS to amend the statement of intent because in previous action on the bill they amended out the low income day care support program and transitional program and the statement of intent needed to be amended.

*** Motion: Motion by Representative Kimberley to adopt the amendment by SRS, EXHIBIT 1, Statement of Intent.

Recommendation and Vote: Voted, passed, roll call vote 15 members voting yes, 4 voting no.

Substitute Motion: Motion by Representative Bradley to postpone further action until other amendments can be prepared.

Recommendation and Vote: Voted, passed, roll call vote with 15 members voting yes, 4 members voting no.

DISPOSITION OF HOUSE BILL 510

Motion: Motion by Representative Quilici that House Bill 510 do

pass.

Recommendation: An oral vote was taken, it was inconclusive and the Chairman said we would have a roll call vote

Discussion: Representative Marks said this bill needs amendments because the intention of the sponsor is that this scholarship is supposed to go to anyone, anywhere, but the bill does not say that. He said, if you say it in one place, it has to be coordinated in the other place. He said in section 6, line 15 we should strike "system" and insert after "three" "College or".

Amendments, Discussion, and Votes: Motion by Representative Marks to move the above proposed amendment.

Recommendation: Voted, passed, unanimous of those present.

Discussion: Representative Thoft asked about private High Schools, or parochial schools. He said he did not think they were covered in this bill. Rep. Bardanouve said parochial colleges are covered, and Rep. Menahan said the bill states accredited High Schools.

Motion: Motion by Representative Marks to amend page 6, line 17 to strike "." following "year" and insert "as provided in section 5 subsection 1, 2 and 3".

Discussion: Rep. Marks said that would refer back to the part where it refers to the kind of scholarships that are offered. He said he felt it would really clean up the language.

Recommendation: Voted, passed, unanimous of those present.

Motion: Motion by Representative Kadas that House Bill 510, as amended, do pass.

Recommendation and Vote: Voted, passed, roll call vote with 10 members voting yes, 9 members voting no.

DISPOSITION OF HOUSE BILL 535

Motion: Motion by Representative Menahan that House Bill 535 do pass.

Discussion: Representative Grinde asked if this was the bill that is mandated to fall in line with the federal government regulations, and was told yes.

Amendments, Discussion, and Votes: None

Recommendation and Vote: Voted, passed, Representative Swysgood voting no.

DISPOSITION OF HOUSE BILL 547

Motion: Motion by Representative Kimberley to amend House Bill 547, EXHIBITS 1, 2 and 3.

(588) Discussion: Explanations were given by Representative Kimberley and a man from the Veterans Affairs on the amendments, showing where they coordinate with H. B. 202. They said the cigarette tax had originally been for the veteran's bonus and was then diverted to the Long Range Planning, so the intent was to restore that to the Veteran's State Home, and if that passes, it would coordinate and take care of the cost of this bill. He said another set of amendment was brought in by the Dept. of Administration and clear up some references and the third changes the dates.

Amendments, Discussion, and Votes:

The amendments were voted on as a group, passed, unanimous of those present.

Discussion: Representative Bradley asked why this bill had not been considered in Long Range Planning, and was told this was another end run around the committee.

Discussion was held on the bonding program, the planning that is or should be done in Long Range, and the problem of having the money to support the bonding program.

Tape 1, side B, 000.

Motion: Motion by Representative Kimberley that House Bill 547, do pass as amended.

Substitute Motion: Motion by Representative Bradley to assign this bill to Long Range Planning subcommittee.

Discussion: Discussion was held on it being too late to put bills into subcommittee now, but it should be looked into in the future so only one committee reviewed a project, and there was not a second chance to go to another subcommittee to try again.

Recommendation: Voted, roll call vote, motion failed with 8 voting yes, 11 voting no.

Recommendation and Vote: Vote was taken on the original motion of do pass as amended. Voted, passed, roll call vote, 13 members voting yes, 5 members voting yes.

DISPOSITION OF HOUSE BILL 555

Motion: Motion by Representative Quilici that House Bill 555 do pass.

Substitute Motion: Motion by Representative Thoft to amend the bill so they would start repayment in 2 years the ANB funds, and that those funds be taken out before they get the payment, 2 years before payment, 5 year payments and at prevailing rate.

Discussion: Rep Peck said he had a letter from the Superintendent of the Hayes Lodgepole school and he indicated the employees are now bonded in that school district.

Rep. Quilici asked if this school district can pay off any of this with 847 money? Rep. Bardanoue said no, it will have to come out of the foundation program money.

Amendments, Discussion, and Votes: The amendment was voted, passed, roll call vote, 15 members voting yes, 4 voting no.

Motion: Motion by Representative Kadas that House Bill 555, do pass as amended.

Recommendation and Vote: Voted, passed, Representative Swysgood voted no.

DISPOSITION OF HOUSE BILL 666

Representative Thoft said he had talked to Rep. Ramirez and he said he could get by with \$230,000 for the first year and \$350,000 for the second. He said that would be \$550,000 for the biennium, and Rep. Marks said last night he had come down to \$500,000. He said the new section he wanted amended into the bill would not let them compete with private enterprise.

Motion: Motion by Representative Thoft to amend House Bill 666 (258) to reduce subsection 2 dealing with equipment to \$300,000. He said this would reduce the \$1 million to \$300,000 in section 3, subsection 2, and delete section 2. (It was decided this motion should be prepared by Ms. Joehler, LFA, including the language in the title)

Recommendation: Voted, passed, 2 members voted no.

Motion: Motion by Representative Kadas to adopt the amendment EXHIBIT 1, a new section.

Discussion: The committee discussed the results of the amendments and decided it could be worked out on the floor.

Recommendation: Voted, passed, unanimous of those present.

Discussion: Representative Menahan asked if we really need this bill. Ms. Wessel said the use of translators are a part of public television expansion in the state, but this bill is

taking about a system that would be dedicated exclusively to courses for credit, and would be two way reception.

Representative Swysgood said the idea is great but felt the system is already in place in the current University System can enhance this and do what this bill would do without the state being involved. Ms. Wessel said the systems are not totally in place, but they are working in that direction. She explained (394) what was missing.

Representative Swysgood asked if the program at Western Montana College that goes to every one room school house in Montana, could not be enhanced upon, or some other existing program, and do the same thing. Ms. Wessel said the Big Sky Network is a computer network that provides an opportunity for data to go to any place there is a telephone line, but there is no way video could go on that network at this time. Rep. Swysgood asked if that system or one in the University System like the one in Missoula and Eastern be expanded? Ms. Wessel said it could be if there was money to buy additional microwave equipment or satellite uplinks. She said the reason the bill came in this way is that the bill is broader than the current system, it includes the office of Public Instruction and part of the private system as well.

Motion: Motion by Representative Marks to amend page 4 where it talks about the telecommunications engineering consultant shall seek, advise, etc. to insert "local school districts".

Recommendation: Voted, passed, unanimous vote of those present.

Motion: Motion by Representative Bradley that House Bill 666 do pass as amended.

Recommendation and Vote:

Voted, failed, roll call vote, 9 members voting yes, 10 members voting no.

Motion: Motion by Representative Quilici to table House Bill 666.

The Committee agreed to reverse the vote, House Bill 666 was tabled.

DISPOSITION OF HOUSE BILL 718

Motion: Motion by Representative Menahan that House Bill 718 do pass.

Discussion:

Rep. Menahan said this would be the Veteran's Home at Galen, it is about \$700,000, and he said they wanted to get some of the money out of the tax increase on cigarettes.

Motion to amend: Motion by Rep. Marks to amend by coordinating with the cigarette tax in 202.

Recommendation: Voted, passed, unanimous of those present.

Amendments, Discussion, and Votes: Motion by Representative Marks that House Bill 718, as amended, do pass.

Recommendation and Vote: Voted, passed, roll call vote, 13 members voting yes, 6 members voting no.

Chairman Bardanouve said that Ms. Joehler would prepare the amendments with the proper language.

DISPOSITION OF HOUSE BILL 748

Representative Marks asked if this could be included in 507 the LRP bill? Rep. Connelly said they did have an application in. We gave them some money, and yes, we could add this at the bottom of the list. She said that bill is prorated.

Motion: Motion by REpresentative Thoft to table House Bill 748.

Discussion: It was suggested to table this bill and tell Rep. Addy to put this in House Bill 507.

Amendments, Discussion, and Votes: None

Recommendation and Vote: Voted, passed, roll call vote, 14 members voting yes, 5 members voting no.

DISCUSSION OF HOUSE BILL 760

Representative Bardanouve said Natural Resources Committee had heard this bill with our committee and they were to have a recommendation to us and we have not received it.

Representative Swysgood said during the hearing they said they wanted to change the money from the water development account to general fund.

Representative Connelly said she had talked to Mr. South yesterday and Water Development was the only one with any money in it.

Chairman Bardanouve suggested not taking action on this bill until a little later.

DISPOSITION OF HOUSE BILL 761

Chairman Bardanouve said House Bill 761 should have been amended

to include the amendment Sheriff O'Reilly had recommended to have it approved by the Sheriff's Association.

Motion: Motion by Representative Nisbet to reconsider committee action on House Bill 761.

Recommendation: Voted, passed, unanimous of those present.

Motion: Motion by Representative Thoft to accept the amendment.

Discussion: None

Amendments, Discussion, and Votes: Voted, passed, unanimous of those present.

Motion: Motion by Representative Thoft that House Bill 761, as amended do pass.

Recommendation and Vote: Voted, passed, unanimous vote of those present.

DISPOSITION OF HOUSE BILL 763

Motion: Motion by Representative Menahan that House Bill 763 do pass.

Discussion: Representative Bardanouve said, this is the In-home services. He asked what the Human Services had done on this, and Rep. Cody said they did not do anything for these people. He said they only took care of those under the medicaid section. Representative Bradley said it was never assigned to the subcommittee, if that is what they wanted, she would call the subcommittee in and discuss it.

Recommendation: Voted, passed, roll call vote, 13 voting yes, 6 voting no.

Motion: Motion by Representative Swysgood to reconsider the action on House Bill 763.

Recommendation: Voted, passed.

Motion: Motion by Representative Menahan that House Bill 763 do pass.

Substitute Motion: Motion by Representative Marks that this bill be referred to the Human Services Subcommittee.

Amendments, Discussion, and Votes: None

Recommendation and Vote: Voted, passed.

DISPOSITION OF HOUSE BILL 765

Motion: Motion by REpresentative Bradley that House Bill 765 do

pass.

Discussion: Representative Bardanouve said there were some amendments submitted.

Substitute motion: Motion to leave this bill temporarily and come back to it later.

This was agreed to by the committee without a vote.

DISPOSITION OF HOUSE BILL 768

Motion: Motion by Representative Thoft that House Bill 768 be tabled.

Discussion: Representative Thoft said this was the Museum of the Rockies bill, and he did not feel this money was necessary.

Substitute Motion: Motion by Representative Iverson that House Bill 768 do pass.

Amendments, Discussion, and Votes: Representative Marks referred to the last section and said if this bill passes with that in it would become a part of the base budget.

Motion: Motion by Representative Marks to delete section 2 on page 2, lines 12 through 15.

Representative Peck said this was a modified on the subcommittee list, but it was one of the modifieds the Board of Regents did not approve.

Recommendation: The amendment was voted, passed, there were 4 no votes by the committee.

Recommendation: The substitute motion for a do pass was voted, roll call vote, failed, 9 members voting yes, 10 voting no.

Recommendation and Vote: The committee agreed to a reverse vote of the substitute motion for the original motion to table the bill. House Bill 768 was tabled.

DISPOSITION OF HOUSE BILL 773

(366)

Motion: Motion by Representative Quilici that House Bill 773 do pass.

Discussion: Chairman Bardanouve said the budget office just brought the fiscal note which has not been printed yet. He said there will be general fund \$107,837 the first year and \$106,665 the second year and SRS medicaid \$21,132 the first year and \$5,112 the second year. He said the money falls off rapidly for some reason. He said this makes a biennium total of \$240,746 and federal fund assumption 100% of

poverty eligibility.

There was some discussion on what this money will be doing, whether it should be in House Bill 100, etc., and how it would save the state money not to have so many low birth weight babies.

Amendments, Discussion, and Votes: Motion by Representative Kadas to sunset the bill at the end of this coming biennium.

Recommendation: Voted, passed, unanimous of those present.

Motion: Motion by Representative Marks to move the medicaid item of 21,132 the first year and 5,112 the second under line 12.

Recommendation: Voted, passed.

Motion: Motion changed to do pass as amended.

Recommendation and Vote: Voted, passed,

The meeting was recessed to adjournment of the House, and reconvened at 5:16 p.m.

Chairman Bardanouve said House Bill 200 would be left for Monday morning.

DISPOSITION OF 760

(537)

Chairman Bardanouve said this is Rep. Hannah's bill that we had a joint hearing with Natural Resources on and they have sent us a memo. "The House Natural Resources Committee reviewed House Bill 760 reached the following conclusions: The committee finds value in the bill and approves the concept of pursuing the possibility of an off stream reservoir in the Yellowstone River valley. The committee recommends that the Appropriations Committee approve the bill with \$10,000 of Water Development funds, and any other general fund money that the Appropriation Committee may deem fit." He said he had talked to Representative Raney and was told the committee was not too enthused, but felt maybe there should be some investigation of the possibility.

Representative Thoft asked if there was any reference to Valley Creek in the bill? He was told it was on page 2, and said he would like to remove the reference to Valley Creek, and leave some money in to study the whole area.

Motion: Motion by Representative Thoft to remove any reference to Valley Creek and the amendment would include \$5,000 for the study of the Yellowstone Basin for off stream storage.

Discussion: Discussion was held on whether the study could be done for \$5,000, reference to a prior study that the community had not wanted, the DNRC study, and the Department said an actual feasibility study of a site specific location and that would cost about \$100,000. The man from the department said his problem was he did not feel the site was worth spending \$100,000 on.

Motion: Representative Thoft changed his motion to read \$7500 rather than the \$5,000 and remove all reference to Valley Creek.

Amendments, Discussion, and Votes: Substitute Motion by Representative Kimberley to leave \$10,000 in the bill, but remove all reference to Valley Creek. This motion was withdrawn.

Recommendation: The vote for Thoft's motion to leave \$7500 in the bill and remove all reference to Valley Creek was voted, passed, 4 members voted no.

Motion: Motion by Representative Thoft that House Bill 537, as amended, do pass.

Recommendation and Vote: Voted, passed, roll call vote, 12 members voting yes, 7 voting no.

Chairman Bardanouve said House Bill 763 would be acted on Monday p.m.

DISPOSITION OF HOUSE BILL 765

Motion: Motion by Representative Kadas that House Bill 765 do pass.

Discussion: Representative Kadas said he wanted to make some amendments.

Amendments, Discussion, and Votes: Representative Kadas moved to amend the bill to change the limit from \$20,000 to \$25,000 per loan.

Recommendation: Voted, passed.

Motion: Representative Kadas moved to put a termination date of July 1993, which would limit this to 4 years.

Recommendation: Voted, passed.

Motion: Motion by Representative Kadas to limit the number of projects to 6.

Recommendation: Voted, passed.

Motion: Representative Kadas changed his motion to do pass as

amended.

Discussion: There was discussion on the totals, and said each project had a price. Ms. Joehler was asked to adjust the totals.

Recommendation and Vote: Voted, passed, Representative Marks, Grinde, Swift and Bardanouve voting no.

DISPOSITION OF HOUSE BILL 238

Motion: Motion by Representative Marks to table House Bill 238.

Discussion: Rep. Cody said this is the insurance money that goes into the general fund.

Amendments, Discussion, and Votes: None

Recommendation and Vote: Voted, passed.

Representative Bradley asked to change her vote to aye, and the committee agreed since it did not change the outcome of the vote.

DISPOSITION OF HOUSE BILL 294

Motion: Representative Kadas moved to reconsider House Bill 294.

Discussion:

Rep. Kadas said this is the pharmacy school and he would amend it down to \$50,000. He said the school is on the verge of losing its accreditation. He said we have already required students to pay an additional thousand dollars and he said they tried in the subcommittee to put some money in through the faculty salary increases. He said he thought it was important the legislature make at least a show on the accreditation business.

Representative Peck said this is part of the modifieds that were presented to the Board of Regents, and they basically endorsed what the Board of Regents had recommended. He said he would support Rep. Kadas. He said a lot of students had contacted him and said they had been told the pharmacy school cannot take the continuing education classes out in the field if they don't get some help, and the accreditation would be lost. He said every pharmacist has an annual requirement for continuing education requirements or credits.

Recommendation: The motion to reconsider was voted, passed.

Motion: Motion by Representative Kadas to insert a new section,
EXHIBIT 1.

Recommendation: Voted, passed.

Motion: Motion by Representative Kadas to strike \$200,000 and insert \$50,000.

Recommendation: Voted, passed, Representative Cobb voted no.

Motion: Motion by Representative Kadas that House Bill 295, as amended, do pass.

Recommendation and Vote: Voted, Passed, Representative Swift voted no.

DISPOSITION OF HOUSE BILL 300

Motion: (978) Motion by Representative Kadas to take the effective date out and reinsert the sections 6 and 7.

Discussion: He said this would read effective date, if approved by electorate.

Representative Kadas said this would make it effective July 1, 1991, and it would reinsert the ballot language.

Amendments, Discussion, and Votes:

Recommendation: Voted, failed, 8 voting yes, 10 voting no.

Motion: Motion by Representative Kadas that House Bill 300 do pass.

Substitute Motion: Motion by Representative Thoft that House Bill 300 be tabled.

Recommendation and Vote: Voted, passed.

DISPOSITION OF HOUSE BILL 550

Discussion: Rep. Marks said this is a feasibility study, and he would like to make some amendments.

Motion: Representative Marks moved to amend page 2, line 10, have it read "The Department of Commerce in conjunction with the school of architecture, MS, and leave the money out of the bill.

Discussion: Representative Swysgood said he questioned the feasibility study. He said the concept is great, but he said in his community they went through the whole process of seeing about a tourist information center. He said the community went through in cooperation of the college, and came up with a plan on their own which did not cost them anything but volunteer help to see if it was possible to do it. He said they even went into the construction of the

building, and had the figures at cost, etc., and said he felt communities could do this as a community project and save the state a lot of money. Representative Marks said that was all that was needed, just don't fund the bill.

Representative Swysgood said last summer they had the kids from the school of architecture come down to our community and they put in a lot of time going over a project we had asked them to do. He said they did it with their professor and went back to MS and put it together then came back 3 months later and showed the schematics and the buildings, etc. as located on a large piece of plywood, and it was fantastic. He said they could use this as educational enhancement with hands on experience.

Amendments, Discussion, and Votes: Vote was taken on Rep. Marks amendment. Voted, passed, unanimous of those present.

Motion: Motion by Representative Kadas that House Bill 550 do pass as amended.

Recommendation and Vote: Voted, passed, unanimous of those present.

DISPOSITION OF HOUSE BILL 600

Representative Thoft asked if this was the licensing bill, and said it seemed the agencies had some real problems with this bill. He said he would rather have them just look at it for a couple of years and see if they can get together on it, and then pass it.

Motion: Motion by Representative Kadas that House Bill 600 do pass.

Voted, Roll call vote, motion failed, 9 members voted yes, 10 members voted no.

Motion: Motion by Representative Connolly to reconsider the vote on House Bill 600.

Discussion: Rep. Kadas said they were always hearing the agencies have such a tough time. He said the whole point of this bill is that it is for the people who have to get licenses.

Recommendation: Voted, passed, roll call vote with 10 members voting yes, 9 voting no.

Motion: Motion by Representative Kadas that House Bill 600 do pass.

Recommendation and Vote: Voted, passed, Roll call vote, 12 members voting yes, 7 voting no.

DISPOSITION OF HOUSE BILL 717

Motion: Motion by Representative Grinde that House Bill 717 do
pass.

Discussion: None




