#### HEARING ON HJR 44

#### Presentation and Opening Statement by Sponsor:

REP. RUSSELL: This is a joint resolution of the state urging the National Park Service to require concessionaires within the national parks in Montana to pay their employees wages in accordance with the state minimum wage and overtime compensation laws.

Rep. Cohen was the individual who was really interested in our moving on a committee bill with this. He was going to come and explain all the details, but apparently he was unable to get here.

## Proponent Testimony:

DON JUDGE, proponent. We do support the legislation. We think it is one way of guaranteeing at least some sort of minimum wage level for people in one of the fastest growing industries in the state of Montana, which is tourism. It will help promote economic development and keep the level of wages up where they minimally ought to be. We encourage you to give support to the legislation.

PAVLOVICH: Question for Mike Stump. You are from the Department of Labor, right? Do you have any problem with the concessionaires?

MIKE STUMP: Employment Relations Division. We have had over the years a number of complaints. I attempted to find some specific ones in our files. (somehow his microphone was turned off and this part could not be heard) ... require \$2.01 per hour for tipped employees and overtime over 56 hours in a work week. That part of the law is proper. We have no problem with this.

I was excused from the last labor committee meeting and I had left my proxy so I could vote yes on the asbestos bill which was in the committee. I didn't know there was going to be a motion made to reconsider SB 165 which was the governor's appointment bill. I had opposed that bill from the very beginning and then found out that I had cast a yes vote, and I would like to change my vote on that.

RUSSELL: All those in favor of allowing Rep. Rice to change his vote on 165 so indicate.

Vote: Unanimous vote to allow Rep. Rice to change this vote.

TESTIMONY OF DON JUDGE ON HOUSE JOINT RESOLUTION 44 BEFORE THE HOUSE LABOR AND EMPLOYMENT RELATIONS COMMITTEE, APRIL 11, 1989

Madam Chair and members of the Committee, for the record, I am Don Judge representing the Montana State AFL-CIO in support of HJR 44.

This resolution seeks to require employers to pay a decent minimum wage and provide overtime protections to employees of concessionaires in our National Parks. Many of these men and women are working in the National Park Service in order to earn the money necessary to receive a higher education. Even the ability to earn a minimum wage and overtime would help these future leaders of our state and their families afford the ever-increasing costs of higher education.

Further, the tourist dollars spent in Montana's national parks should not all go to better the profit margins of the concessionaires. A fair wage for these workers guarantees that more dollars are spent in Main Street businesses and to support the families of these workers. Tourism has been the fastest growing sector of our state's economy and many of these workers have entered the service industries because there are few alternatives. Not all of these workers are students; some have families and other responsibilities which they must support financially. Montana's minimum wage and overtime protections should be applied for these workers.

We believe that Montana state law should take precedence over federal law where possible. The needs and general well-being of our citizens are best determined by their representatives here in Montana. While these employees are working within the borders of our state, the concessionaires should abide by Montana laws.

We urge your support for HJR 44.
