HEARING ON SENATE JOINT RESOLUTION 2

Presentation and Opening Statement by Sponsor: Senator

Elmer Severson of Senate District 32, the chief sponsor of SJR 2, gave a brief summary of the bill. This is a joint resolution of the Senate and the House of Representatives of the State of Montana to send delegates to the Western States Legislative Forestry Task Force.

Senator Severson handed out written testimony regarding this resolution. (See Exhibit #1) The Western States Legislative Forestry Task Force was organized in 1974. It consists of two state senators and two state representatives from Alaska, California, Idaho, Montana, Oregon, and Washington. Most of the state delegates represent rural-forested areas. The Province of Alberta also joined as an associate member early in 1988. Both Canadian provinces are represented by their respective forest ministers.

Testimony:

- Senator Bob Brown of Senate District No. 2, a charter member of the Western States Legislative Forestry Task Force stood in support of the resolution. He stated that he felt that the Task force is very valuable to those living in the western states. One of the common bonds of the Task Force is the significant federal land ownership within each represented state.
- Representative Bernie Swift of House District No. 64, a member of the Task Force, stood in support of the resolution. He stated that the Task Force was involved in the trade agreement with Canada. He feels very strongly about Montana staying involved with the Task Force. Federal policy and land management decisions can substantially influence the economic and social structures of state, and particularly those with large federal ownerships.
- Kara Ricketts, representing the Montana Wood Products, stood in support of the resolution. She stated that it is a definite asset to the people of Montana to belong to the Task Force.

Questions From Committee Members:

Senator Blaylock asked about the cost of belonging to this organization. Senator Severson replied that the dues are determined through a formula adopted at Spokane, Washington in 1976. This formula is based on each state's volume of standing commercial timber, plus its ability to pay based on its financial aggregates.

Montana's dues are \$2,750. paid on a biennial basis.

Closing by Sponsor:

Senator Severson closed. He asked the committee to look favorably upon this resolution.

DISPOSITION OF SJR 2

Discussion:

Amendments and Votes:

- Recommendation and Vote: The committee was polled at a later date and voted unanimously to give Senate Joint Resolution 2 a DO PASS recommendation.
- SPEAKERS: A memo was read from Senator Williams asking for a speaker for the House and Senate proceedings to be located in Room 10-A. This room provides office space for five senators and is very accessible to other senators, is convenient to several press people and many lobbyists who are in the area from time to time. The installation would require less than 3 feet of wire and a speaker. The wire would come from EQC directly through the ceiling into 10-A.
- Senator Blaylock stated that is the committee would do this, then everyone would ask that it be added to their offices.
- A motion was made by Senator Blaylock to deny the request of Senator Williams. Motion carried unanimously.
- <u>DICTAPHONES:</u> Senator Blaylock stated that the hand held dictaphones are in short supply in the Steno Pool.
- A motion was made by Senator Blaylock to buy five more hand held dictaphones, not to exceed a total of \$350. Motion carried.
- **SOUND SYSTEM:** Telecommunications will report next week on the sound system design.
- PHONES: It was reported that the public is having a problem getting through on the phones lines. This would be a good issue for joint meeting.
- REQUEST FOR A JOINT RESOLUTION: John Kinna from the Lt.

 Governor's Office asked that the committee request a joint resolution for bronzes or appropriate plaques and also a time capsule to commemorate Montana's Centennial.
- A motion was made by Senator Mazurek that the committee request the Legislative Council to draft a joint resolution regarding the same. Motion carried unanimously.

The Western States Legislative Forestry Task Force was organized in 1974. It consists of two state senators and two state representatives (assemblymen) from Alaska, California, Idaho, Montana, Oregon and Washington Most of the state delegates represent legislatures. rural-forested areas. The current chairman is Representative Richard Adams of Idaho. In 1986, the Canadian province of British Columbia joined the Task Force as an associate member. The Province of Alberta also joined as an associate member early in 1988. Candadian provinces are represented by their respective forest ministers.

The Task Force objectives include monitoring federal executive administration natural resource decisions, those of the Congress, the state legislatures, and the attitudes of all segments of society affecting the maintenance and utilization of public and private forest lands, primarily in the West; while recognizing the need to preserve and utilize a reasonable amount of the timbered land base to meet other needs. The Task Force has sought to influence federal policy by initiating unified state action to national forest related issues. semiannually one of its four yearly meetings is held in Washington, D.C. There it has been received by the Secretaries of Agriculture and Interior, the Assistant Secretary of Commerce, the Chief of the U.S. Forest Service, the Director of the Bureau of Land Management and Presidential assistants. Its members have made numerous personal and written contacts with the Congressional delegations from each Task Force state, with appropriate Congressional committees and with key administration officials on current subject matters of concern. In April 1988, in Washington, D.C., the Task Force hosted a luncheon in the U.S. Senate for Senators and Congressmen to hear the Honorable Allen Gotlieb; Canadian Ambassador to the United States discuss the Canada/USA Free Trade Agreement. It also honored Senator John Stennis for his support for agricultural and forestry research at land grant colleges. It honored Senator Mark Hatfield in 1986, for his support of forest insect control.

Some of the issues upon which the Task Force has acted include: RARE II; Clean Air Act Amendments, Alaska Land Allocation; USFS budgets for reforestation, timber management, state and private forestry; long-range weather forecasting; uses of forest chemicals; cooperative forest fire funding; the National Forest Multiple Use Management Act; funding for the Forest and Range Renewable Resources Planning Act; economic criteria for determining federal timber harvest schedules; oversight hearings on the National Environmental Planning Act; Corps of Engineers authority to regulate dredge and fill; federal payments to states for lost revenues due to federal ownership of lands; forst insect research; USFS road funding policy; spotted owl; Tongass National Forest; salvage timber sales; Canadian lumber imports; national forest planning; Gramm-Rudman Act; forest land taxes; international border forest fire cooperation; and funding for emergency insect and disease outbreaks; support for vigorous U.S. forest service timber sales and road access programs; funding for applied fire management research; elimination of Japanese tariffs on U.S. softwood plywood imports; allow transport of forest products to east and gulf coast ports on other than U.S. flag vessels; appropriations for the Mcintire-Stennis forestry research program; modification of application of even-flow timber sale policy to better meet marketplace and forest community needs; federal reimbursement authority for utilizing fire fighting resources regardless of jurisdiction (Canada); support for retention of the present 25% formula for timber sale receipt payments to the states and local governments;] etc.... Over one hundred such issues have received major Task Force attention and action.

A RESOLUTION

Be It Resolved by the Western States Legislative Forestry Task Force:

WHEREAS, the Western States Legislative Forestry Task Force recognizes and appreciates the necessity of immediately addressing and reducing the federal deficit by the reduction of federal spending, including some cuts in transfer payments to the states for public education support and land grant universities; and

WHEREAS, Congress has adopted the Gramm-Rudman-Hollings Act which will in all probability permanently cut federal payments to western states; and

WHEREAS, the Western States Legislative Forestry Task Force is willing to accept cuts which equally impact on all of the states and which will require all states to increasingly shoulder the responsibilities for funding of necessary programs, including public education, with state-level revenue; and

WHEREAS, the economic and tax base of the western states is not as fully developed as necessary to provide maximum support for education as is the case in other states which do not experience large federal land ownership within their boundaries; and

WHEREAS, Federal Forest Reserve Funds and Impact Aid Funds (P.L. 874) payments to western public schools could be reduced or eliminated by Congress or the automatic cuts in the Gramm-Rudman-Hollings Act; and

WHEREAS, federal "in lieu of" tax payments funds, which previously supported public education and other state and local government functions based on this federal ownership acreage, are also proposed for reduction or elimination; and

WHEREAS, the western states, working with all potentially affected lessees and adjacent owners to avoid or minimize economic, recreational, or other impacts, are prepared to assist the Federal Government in selecting appropriate sections of land for transfer.

NOW, THEREFORE, BE IT RESOLVED by the members of the Western States Legislative Forestry Task Force, that Congress, with the advice of the Secretary of the Interior and the Secretary of Agriculture of the United States, authorize the transfer of two additional sections per township from federal lands to the member states of the Western States Legislative Forestry Task Force for state ownership and for the sole and exclusive purpose of supporting public schools and institutions of higher education in the western states.

BE IT FURTHER RESOLVED that a copy of this resolution shall be transmitted to the President of the Senate and the Speaker of the House of Representatives of Congress, the congressional delegations representing the states comprising the Western States Legislative Forestry Task Force in the Congress of the United States, the Secretary of the Interior of the United States, and the Secretary of Agriculture of the United States.
