Call to Order: By Chairman Gene Thayer, on March 2, 1989, at 10:00 a.m.

Announcements/Discussion: Chairman Thayer announced, "HB 258, that was scheduled for today, was cancelled at the request of Representative Spaeth. It has been rescheduled for March 10."

HEARING ON HOUSE BILL 417

Presentation and Opening Statement by Sponsor:

Representative Pavlovich, House District 70, said HB 417 was the result of a boat ride he had taken on Flathead Lake. The boat owner had informed him it was necessary to secure a catering license each time he wished to possess or sell liquor. He said there were times when bus loads of people arrived on a Friday or Saturday evening and wanted to go on his boat ride. By being required to send to Helena for the catering license, he wasn't able to obtain the license in time for that group of people.

This piece of legislation would allow him a special boat permit license. We asked the Department of Revenue and got their blessing to introduce this bill. "You will see on page 1 a \$200 fee, which is the price of a catering license. He will have his own catering license. He cannot take that license or that boat from Flathead Lake and move it down here on Canyon Ferry. If there is somebody here on Canyon Ferry that would like to build a tour boat and they want a license here,

they are more than welcome. Presently, this is the only boat on Flathead Lake, or in Montana that does this kind of business."

- Testimony: Representative Smith stated, "I am here in support of Representative Pavlovich's HB 417. What happens with that catering is really no big problem on something scheduled way ahead. In the summertime, we get a lot of tour buses and it's just a great big extra for the community. It is extra dollars in the area. It's a good bill, and I urge you to concur in this."
- Questions From Committee Members: Senator Thayer stated,
 "It looks like you had it amended for the original \$250 down to \$200. Did the House do that on the floor?"

Representative Pavlovich replied, "Those were Department amendments from Mr. Blewitt, and were made in the committee. Those were to name the registered owner of the boat as a resort or beverage licensee or as an individual named on a resort or beverage license, or is at least a stock holder who owns tempercent. This will take care of the purchase, so nobody else can use it but one person."

Closing by Sponsor: Representative Pavlovich said, "I will close, and ask for your concurrence in the bill. If it does pass, Senator Lynch will carry the bill for me."

DISPOSITION OF HOUSE BILL 417

<u>Discussion:</u> Senator Weeding asked, "Is an endorsement the same as what a bar owner has when he wants to put another bar on?" Senator Lynch replied, "A caterer, that is what this is for."

Recommendation and Vote: Senator Meyer moved HB 417 BE

CONCURRED IN. Senator McLane Seconded the motion. The

motion Carried Unanimously. Senator Lynch was assigned to carry HB 417 on the Senate floor.

HEARING ON HOUSE BILL 480

Presentation and Opening Statement by Sponsor:

Representative Knapp, House District 27, said "I am here for HB 480, which was asked for by banks over in the Missoula area. They would like to have some direction, from legislature, on what to do with abandoned escrow accounts. For whatever reason, an escrow account gets abandoned, and people leave the state. We don't have any direction in the codes on what to do with them."

"You will see that Section 5 is just an addition to the code. Section 1 says what to do with abandoned demand savings. Section 2 says shares or other interests. Section 3 is on certificates of deposit. Section 4 is on personal property. Section 5 just adds that escrow direction from the state, on what to do with abandoned escrow accounts....You will notice the five years is in there. That is consistent with the other sections. After five years, you can declare them to be abandoned."

Questions From Committee Members: Chairman Thayer inquired,
"Can you explain quickly, what happens to the money?"
Representative Knapp replied, "Just like any abandoned property, this would go to the state."

Senator Williams asked, "That goes to school funding, I think, doesn't it?" Representative Knapp answered, "That is one question I can't answer, but I assume that is where it goes."

Senator Williams stated, "Four years ago I carried a bill for some telephone co-ops. They wanted to prevent their capital credits from going into the abandoned property. They wanted to take it back and redistribute it among their consumers. It sounded good to start with. I visited with (Representative) Francis Bardanouve who put this together many years ago. It is a pretty good program. Abandoned bank properties, abandoned anything goes into this fund, and the interest is fed into the school foundation program in some way or another. I don't know what it is."

Closing by Sponsor: Representative Knapp said, "If you concur with this, Senator Van Valkenburg is signed on the bill. He would probably carry it on the Senate floor."

DISPOSITION OF HOUSE BILL 480

Discussion: None

Amendments and Votes: None

Recommendation and Vote: Senator Williams made a motion that HB 480 BE CONCURRED IN. Senator Noble seconded the motion. The motion carried Unanimously. Senator Van Valkenburg carried the bill on the Senate floor.

DISPOSITION OF HOUSE BILL 209

<u>Discussion:</u> Senator Lynch stated, "I was visiting with Representative Hannah today, and he would respectfully request we wait one more day to act on this."

Chairman Thayer replied, "I think we should always extend that courtesy. If there are no objections, we will take action on this bill tomorrow." Consent was unanimous.

Senator Williams said, "I would like to visit with Representative Hannah, Mr. Chairman. There is a program in place, right now nationally, that would take care of an awful lot of those problems. I am involved with it in five northwestern states here."

Chairman Thayer asked Senator Williams, "Would you like to explain that so everybody could identify with it?"

Senator Williams replied, "It's a plan, they call Billy Mac. It's for the servicing of mortgages. It makes no difference where your mortgage was originated. It makes no difference where the mortgage is being paid. Everything is done electronically through City Bank out of New York City. When there is a problem with a mortgage or payment or anything, they are the ones that take care of it. It is a program that just got started in September. We are working in the state with the credit unions. There are one hundred and four credit unions, and we are trying to get them moving on the program."

DISPOSITION OF HOUSE BILL 247

Amendments and Votes: Senator Lynch made a motion to adopt the amendments for HB 247 (See exhibit #1). Senator Lynch rescinded his motion on the amendments.

<u>Discussion:</u> Senator Williams asked, "Why not the amendments?" Senator Lynch answered, "Because, I think it takes away what they wanted to do with the definitions of volatile."

Mary McCue said, "I talked to Representative Whalen about my concern on the use of the word regional. I don't think he considers it the problem I do. To me it denotes some kind of geographical limitation, and maybe it does not." Senator Lynch stated, "The same term is being used in regard to water reserves. You are allowed to get into a regional water reserve, but it doesn't mean that the region has to be contiguous with the state. Mary McCue asked, "That is why they had to come back to you though, was it not? Because, they wanted to get into a lottery with people in Rhode Island, or wherever, they had to come back." Chairman Thayer and Senator Lynch both said she was correct.

Senator Weeding asked, "Could we put a modifier in there? Like a noncontiguous region, or define the region as not necessarily contiguous?"

Senator Lynch stated, "Before we start amending the bill, we had better see if there are enough votes to pass it."

Senator Noble reiterated, "If the bill isn't going to pass, there is no use in taking all kinds of time with amendments."

Recommendation and Vote: Senator Lynch made a motion HB247

Be Concurred In. Senator Hager Seconded the Motion.

Senator Meyer called for the question.

Chairman Thayer stated, "The question has been called for on the motion To Concur In HB 247."

A roll call vote was needed.

The motion failed, with three voting in favor, and six opposing. Those voting in opposition were Senator Meyer, Senator Boylan, Senator Noble, Senator Williams, Senator McLane, and Senator Thayer.
