#### HEARING ON HOUSE BILL 754

Presentation and Opening Statement by Sponsor: Hal Harper,
House District 44, stated "HB 754 will address the
overcrowding of rivers. This bill will deal with that
problem by shrinking fishable stretches of river. This
bill puts a fee on people who fish. There will be a
50-cent increase in the cost of a Class A resident
fishing license and a Class AAA sportsman's license and
a \$1 increase in the cost of a Class B nonresident
fishing license. We will directly use this money to
improve and to rehabilitate fishable stretches of water
across this state...This money will be available for
stretches of water all over the state. The money is
needed to help these streams. I urge you to support
this bill."

## Testimony: Proponents:

Representative Bob Marks - "If you look at the language there on page 3, in sub-section 4 and 5, this language will clear up any misconceptions of the bill. It says 'the department shall consult with local conservation districts regarding the appropriateness of the project and any applicable permit requirements. The department shall receive the consent of the landowner or lessee of any associated lands before initiating physical projects on these lands.' There is not a heck of a lot to fear with this. With that, I urge you to support HB 754."

- Representative Bruce Simon "I am a fisherman and I stand in strong support of this bill. There are a lot of streams throughout Montana that could use this kind of work. We have had erosion of banks in several streams around Montana and we could use a bill like this. Even if the fishing license is free, if there isn't a decent place to fish, then it isn't worth much."
- Representative Ed Grady "I am very aware to what has happened to our stream banks in high water. I think this is a real start into giving us some help to control these stream banks. I think this bill is very beneficial to agriculture and sportsman. It is using sportsman dollars to help the agriculture people out. Every time we have high water, more of our state goes on down to some other state. This is beyond our control and we are losing valuable land. I hope the Senate passes this bill; the State of Montana needs it."
- Robert Van DerVere "This is a good bill and I hope you will support it 100%."
- Paul Roos See exhibit 3 for testimony.
- Don Chance "We are strongly in support of this legislation. We are more than willing to help finance and to provide the funding necessary for a program like this in place."
- Chris Hunter "We are aware, as anybody is, the problems that this legislation would correct. We strongly support this legislation."
- Tony Schooner "By being in the business as an outfitter, I can testify to the millions of dollars that are brought into the state through the fishing industry. In a nation wide survey, over 50% of the people fish. I sure there are more than that in Montana because we have a place to fish. The sportsman are willing to pay for this. This is a good bill and I urge your support."
- Janet Ellis "We support this bill like a similar bill that has passed the Senate... I want to point out, you can't do anything on private land without the landowners consent. I urge you to support this bill."
- George Ochenski "The landowners will be protected under this bill. It certainly is a consideration we have taken into account. The landowners were not specifically what we had in mind, when we put this bill

together. We are talking about the rivers and the fisheries. I will pass out to you a clipping from a Trout Magazine. It lists the one hundred best trout streams in the nation." See exhibit 4. "Montana has the best trout streams. We are losing good miles of fisheries through natural and manmade problems. We should be gaining more miles. So we can handle the increase of people that are coming into this state. I hope this committee will pass this bill."

Stan Bradshaw - "This bill is not intended to damage agriculture in anyway. One of the things I have been reading in the paper about this bill--This bill is redundant because the Department of Fish, Wildlife, and Parks already have huge sums of money to do this kind of work. I was a little startled at that, so I went down to the department to see what kind of funding they have to do this work. There is not a designated source of fund to do this kind of work. They may have some additional dollars to apply to this kind of thing. The availability of this money is highly unreliable and it is only a small amount of money. There is not a reliable source of money in any department to do this work. It is work that can be to the benefit of both the fisheries and the landowners. I urge your support of HB 754."

Brant Quick - "Our organization supports HB 754. This bill will do nothing but benefit this state and we urge your support."

Ken Wilson - "I want to go on record in support of HB 754."

Bill Holdorf - "Our three hundred and fifty members support this bill. We hope you will pass 754."

Ray Tilleman - "All the comments, that I might make, have already been made. I support this bill fully."

Mike Bay - "I want to go on record as supporting HB 754."

## Testimony: Opponents:

Lorents Grosfield - "I believe the this bill has become more controversial than it ever needed to. I had a hard time deciding which one to appear as, an opponent or a proponent. The Montana Association of Conservation Districts supports the general intent of projects to clean-up and improve fisheries and streams.

Conservation Districts, as you know, have local jurisdictions over all the streams within their boundaries. We have some permitting authority over those streams. I would like to thank the sponsor of the bill for agreeing to put Conservation Districts in the bill. We are suggesting a little stronger rule with these amendments. It doesn't change the bill it explains it a little better." See exhibit 5 for amendments. Mr. Grosfield explains the amendments.

- Dave McClure "We rise in opposition only to the present wording. We will support the bill with the adoption of the Grosfield amendments. We will work to make it a successful program."
- Ole Ueland "I want to go on record in opposition to HB 754."
- Kim Enkerud "The membership of these organizations, that I represent, are all public land users. This bill does not specifically address private lands. Our streams and river are found across all ownerships of land. We rise in opposition to this bill."
- Jerry Jack "We rose against this bill over on the House side. We offered a series of amendments. Some of those amendments we had incorporated in the bill. We are in agreement with the Conservation District amendments. We feel, if these amendments can be incorporated in the language of the bill, you will have our support on this."
- Marvin Barber "We want to be a positive opponent and support the bill with Mr. Grosfield's amendments on it."
- Don Allen "I just had a chance to review the amendments since the hearing started. I find that most of the concerns that we had, have been resolved by the Grosfield amendments. I would like to support the bill with those amendments in there. I have one other concern which is on page 2, line 5. I would like to ask the committee to change the words `maintain and restore the integrity' to something like `protect for beneficial uses'. Unless you say `beneficial uses', it could lead in the future to some real disagreements to what activities can occur. I hope you will support these amendments."
- Kay Norenberg "We are opposing the bill as written. We would like to support the amendments that Mr. Grosfield offered."

- Dueane Calvin "We rise in opposition to the bill as written. We have reviewed the amendments that Mr. Grosfield submitted. In light of those amendments, we feel we could support those amendments as well as the bill."

- Representative Harper handed in an amendment to be discussed with the committee. See exhibit 9.
- Questions From Committee Members: Senator Aklestad "What expertise does the fish and game have within their own department to design--In some areas, they can physically repair the banks. It seems like the expertise is already available. The conservation offices or the ASC offices--I don't know if the fish and game has that much expertise in that area?"

  Representative Harper "In many projects other people are going to be involved. This is besides the fish and game. I want to maintain the fish and game as the lead agency under this bill."
- Senator Beck "You are not for amendment number 8 in the Grosfield amendments?" Representative Harper "The way I would like to see that is, if you left the existing language in, but at the very end you put in 'appropriateness of the project and contain any applicable permits'."
- Senator Beck "You don't think this would be appropriate to have this under the Conservation District?"

  Representative Harper "What I am asking fisherman to ante up 50-cent from instate and a \$1 from out of state. They're going to demand that their agency give the money to who is going to be the lead agency in charge. You can't ask fisherman to raise money and then give it to some other agency of the government. That isn't right. We are giving them legal power to what they think is appropriate."
- Senator Williams "It seems like getting eight out the nine amendments would be great. Are the others hinged on this?" Lorents Grosfield "The discussion is over the word `consult'. How much force does that word have? I

think Mr. Allen had an excellent point on beneficial uses. That will fit in fine at the end. I am not sure the word `consult' is quite strong enough. What does that mean?"

Closing by Sponsor: Representative Harper - "I think we had a good hearing and I urge you to support this bill."

#### DISPOSITION OF HOUSE BILL 754

#### Discussion: None

- Amendments and Votes: Senator Galt moved to strike subsection (b), line 9, on page 3; Senator Aklestad seconded the motion. The motion carried unanimously.
- Senator Bengtson moved the Harper amendment (exhibit #9).
  The motion carried unanimously.
- Senator Jergeson moved to amend `river' means a river, stream, creek, or other naturally occurring body of flowing water. Senator Jergeson stated this was an alternative amendment #4 on the Grosfield amendments. The motion carried unanimously. Senator Beck stated that motion took care of #1 and #4 of the Grosfield amendments.
- Senator Thayer moved the language, "The legislature further finds that some of our state's rivers and fishery are diminished in value by water pollution, water storages, and repairen erosion and that there is a need for a program to promote the beneficial use and productivity of our river systems". The motion carried unanimously.
- Senator Thayer moved #3 Grosfield amendment. The motion carried unanimously.
- Senator Bengtson moved amendment #5 of the Grosfield amendments. The motion carried unanimously.
- Senator Bengtson moved amendment #6 of the Grosfield amendments. The motion carried unanimously.
- Senator Bengtson moved amendment #8. The language stated,
  "The department shall consult with the local
  conservation districts regarding the appropriateness of
  the project and obtain any applicable permits." The
  motion carried unanimously.

Senator Devlin moved to clean-up the language on page 2, lines 9, 10, 11, and 12. The language reads, "Is a sound method to ensure that rivers and fisheries will continue to serve the state and its people". The motion failed with Senator Abrams, Senator Bengtson, Senator Jergeson, and Senator Williams voted no.

Recommendation and Vote: Senator Williams moved HB 754 TO BE CONCURRED IN AS AMENDED. The motion carried unanimously.

HB 754 Section 1: outlines the purposes of the river restoration program

Section 2: defines five terms used in the act

physical projects and the lease or purchase of water from storage
facilities if authorized by law; requires departmental

initiating physical projects

Section 4: establishes the river restoration account to receive funds for program purposes

Section 7: raises Class B nonresident fishing license by \$1

Section 8: adds 50 cents to the Class AAA sportsman's license rate in effect until March 1, 1994

Section 9: adds 50 cents to the Class AAA sportsman's license rate in effect March 1, 1994

Section 10: extends present agency rulemaking authority Section 11: applies license increases to fishing seasons beginning on or after March 1, 1990

Section 12: provides a July 1, 1989, effective date

Testimony in SUPPORT OF HB 754

submitted by Paul S. Roos, FFOAM Board Member 1630 Leslie Helena. MT 59601

FFOAM supports HB754 as an important vehicle to enhance the resources upon which our industry depends.

We believe that with the expertise provided by the Department of F, W, & P, fishery habitat could be enhanced in a cooperative-everyone wins manner. Consultation with the local conservation district and the consent of the landowner or lessee would have to be obtained.

As an outfitter and lifelong Montana fisherman, I know the need is there for this type of fund. Montana's streams are seeing an ever increasing use by both instate and out-of-state fishers. One of the most intelligent, long reaching solutions to increased pressure on our streams is to improve the quality of fishing in marginal waters. Increasing the number of miles of quality fisheries will dilute the pressure and increase the value of our state as a fishing paradise.

Landowners stand to gain most of all. Good trout streams have stable banks. Unstable banks are one of the most troublesome problems facing ranchers and farmers. Topsoil and acres are lost rapidly when erosion of banks is excessive. The sportsman and the agriculturalist can work together through this bill to do stream restoration projects approved by all parties.

Absolutely no one benifits when our water races down a degraded, eroded streambed to harass some poor soul on a flood plain somewhere downstream.

This is an important bill. Montanans deserve an affirmative vote from this committee on HB754.



Dear Senator:

This letter is my thoughts on HB 754, the river restoration bill, that is being considered by the Senate Agriculture Committee Wednesday at 1:00 O,clcck.

From the title you would think that at last we have a good water bill that is all motherhood, apple pie, chevrolet, and all the other things that every red blooded American should want to see happen.

Upon closer examination we find that it is really a lease purchase of water rights (pg.2, line 25), much as the instream flow bill which was killed in the senate. The difference is that in this bill the Fish, Wildlife and Parks seem to think that in order to restore the stream banks they need to "lease or purchase water rights, etc". The result is that once again the Fish, Wildlife and Parks is after valid, existing water rights.

Fish, Wildlife, and Parks rulemaking powers are expanded to accomplish the purposes of the act (Section 10) and I could foresee deer and elk, with their riparian water rights, free to leap over fences and water pretty near any place they want (as they do now), while domestic livestock might be singled our to not have a riparian water right and might have a tough time watering in the streams and reservoirs they do now. This would further change the water rights as we know them since most ranchers filed for water rights for their livestock based on a formula of so many gallons consumed per head per day. These water rights are waiting for the final adjudication of water in Montana.

There may be a few specific cases where something like this is needed but I would disagree that "there is a need for a program to maintain and restore the integrity and productivity of our river systems". The bill is much to broad in scope, is another water grab by Fish, Wildlife and Parks, and should be killed.

SUMMARY: I am requesting your support for the Senate Finance & Claims Committee to amend HB 775 -Water Development Grant and Loan Funding to include partial funding for the PARK BRANCH SEDIMENT CONTROL PROJECT. This project was excised from the priority list submitted to the LONG RANGE PLANNING COMMITTEE by the Water Development Advisory Committee.

This project is for the construction of a series of vanes to prevent the build-up of gravel and sand sediments in inlets to irrigation canals from rivers carrying heavy gravel sediments during the spring runoff periods. The Park Branch Canal has been cited by EPA for violating the Clean Water Act for removing these sediments by dredging or bulldozing (as currently practiced). As irrigation projects along the Musselshell, Bitterroot, Clark Fork, Jocko, Missouri, Milk, Gallatin and Yellowstone Rivers have this same problem, a solution acceptable to the EPA is needed.

LEGISLATIVE ACTION: The Park Conservation District applied for funding from the Water Development Program for this project. It was ranked No. 5 on the priority list submitted by the Water Development Advisory Committee to the Long Range Planning Committee (LRPC). Testimony for this project was given at the LRPC hearing on January 27; the LRPC recommended ZERO funding for this project. As documentation for requesting a reconsideration by the LRPC was not available before HB 775 was passed by the House, this request is directed to the Senate Finance & Claims Committee.



This is a request to the Senate Finance and Claims Committee to amend HB 775 - Water Development and Renewable Resources Grants to include funding in the amount of \$30,000 from the Water Development Program for the PARK BRANCH SEDIMENT CONTROL PROJECT on the Yellowstone River at Emigrant. This request is based on the following.

#### A. <u>LEGISLATIVE ACTION</u>:

- 1. The project, described on p.15 of Renewable Resource and Water Development Programs: Project Evaluations nd Recommendations for 1990-1991 Biennium, was ranked No. 5 by the technical review committee and the Water Development Advisory Committee when submitted to the Joint House and Senate Long Range Planning Committee.
- 2. The Long Range Planning Committee recommended ZERO funding for this project and it was not included in the list of projects appearing in HB 775. Information I received indicated it was stricken from the list for two possible reasons:
  - a. data indicating the Park Branch Canal has low operations and maintenance (O&M) costs presented in the testimony given at the committee hearing on January 27, and
  - b. a request for 100 per cent funding of \$51,000 with no cost sharing from the two water users' associations or other non-state funds.
- B. <u>RESPONSE</u>: The following information, obtained since projects were listed in HB 775, justifies considering amending the list to include the PARK BRANCH CANAL SEDIMENT DIVERSION PROJECT in HB 775:
- 1. The O&M and special assessments charged <u>per unit</u> to the Park Branch Canal and Paradise Valley Canal users <u>appear</u> to be higher than 19 of the 30 projects shown on the enclosed list (Attachment No. 1) of State Water Conservation Projects provided by the DNRC.

The relative O&M costs of the different projects cannot be accurately be compared for two reasons:

- a. The units against which the charges are based are different for different projects: (i) MI is a miner's inch, a flow rate which is a volume per unit of time, (ii) AF is an acre-ft, a volume of water one foot deep covering one acre (i.e., 43,560 cu ft), and (iii) AC is an acre, a surface area. To be consistent the MI needs to have the time the flow is turned into the irrigated acreage; the AC needs to have the number of inches of water applied to the irrigated acreage during the growing season. For this reason, it is difficult to make valid comparisons.
- b. Rick Bondy, Chief, Engineering Bureau, DNRC also indicates that O&M costs for the Park Branch and Paradise Valley users are low because the users do most of their own O&M work and other canal associations contract out the total O&M costs. To make a valid comparison requires an accounting of the "in-kind" services provided by the Park Branch and Paradise Valley users be included in the figures.
- 2. The request from the Water Development Program is reduced from \$49,715 with matching funds of \$1,285 from Park County Conservation District to \$30,000 with matching of \$30,000 from ASCS pooling agreements and user assessments. The original request for 100 per cent grant was based on interpretation of eligibility guidelines by the grantsperson. Discussions with users groups, SCS and ASCS program personnel following original hearing on January 27 indicates that 50 per cent match can be provided. Subsequent review of project requirements and permitting processes indicates that total cost of project is \$60,000.
- 3. As a result of dredging operations in the inlet canal of the Park Branch Canal in the summer of 1988, EPA cited the Park Branch Water Users Association (PBWUA) with Administrative Order No. 89-07, a FINDINGS OF VIOLATION and ORDER FOR COMPLIANCE in the matter of a violation of the Clean Water Act (Attachment No. 2).
  - a. Par. 15 of the FINDINGS OF VIOLATION states:

"The PBWUA has contacted the Montana Department of Natural Resources to seek funding for a permanent

solution to such annual or periodic dredging of the side channel and the discharge of this material into the river and its floodplain."

#### b. Par. 2 of the ORDER OF COMPLIANCE states:

"PBWUA shall develop a plan for a permanent solution to allow irrigation water to be obtained without recurrence of dredging and filling that is damaging to fish and wildlife resources and channel stability and said plan shall be submitted to EPA by August 1, 1989. Said restoration plan shall be subject to the approval of EPA in consultation with the Corps of Engineers, Soil Conservation Service, Montana Department of Natural Resources and Conservation, Montana Department of Health and Environmental Sciences, Montana Department of Fish, Wildlife and Parks, and Park County Conservation District."

NOTE: Although this citation is specifically for the Park Branch Canal, it has statewide implications. The sedimentation of inlets to irrigation canals is also occurring along the Musselshell, Bitterroot, Milk, Jocko, Missouri and Clark Fork Rivers according to discussions with Gordon Klofstad, SCS State Planning Engineer; and Steve Fry and Rick Bondy, Engineering Bureau, DNRC. As the sediment removal at other sites has been by dredging or bulldozing, the irrigation projects may be subject to similar EPA citations.

- 4. A copy of the application for the Water Development Program was sent to the EPA Regional Office in Denver on January 30 for review as a possible permanent solution to the problem. The review by the EPA (Attachment 3) indicates that "the use of submerged vanes in cobble-bed rivers has merit and their effectiveness should be tested in cobble-bed rivers."
- 5. An interagency coordination meeting was held March 22 at the SCS office in Livingston to discuss corrective actions for compliance with the directives of EPA Administrative Order 89-07. All the agencies listed in Par. B. 3. b. and the EPA Regional Office in Denver were represented. The consensus of the group was that the use of submerged vanes be pursued as a viable solution to the Park Branch Canal problem.

#### CONCLUSION:

THE STATE OF MONTANA WOULD BE WELL SERVED BY AMENDING HB 775 TO PROVIDE PARTIAL FUNDING FOR THE PARK BRANCH CANAL SEDIMENT CONTROL DIVERSION PROJECT.

#### STATUTORY AUTHORITY

The following FINDINGS are made and ORDER issued pursuant to the authority vested in the Administrator of the Environmental Protection Agency (EPA) by Sections 308 and 309 of the Clean Water Act (CWA), 33 U.S.C. Sections 1318 and 1319, and by the Administrator delegated to the Regional Administrator of EPA Region VIII, and redelegated by the Regional Administrator of Region VIII to the Director, Water Management Division, Region VIII.

#### FINDINGS OF VIOLATION

1. During the month of July 1988 the Park Branch Water Users
Association (PBWUA) or its representatives placed dredged or
fill material in a side channel of the Yellowstone River in
association with dredging and modification of a side channel
and floodplain in Section 8, Township 6 South, Range 8 East;
and Section 5, Township 6 South, Range 8 East, Park County,
Montana.

- These unauthorized dredging and filling activities were detected during state and federal investigations. Photographs of the affected river and adjacent floodplain were taken on November 7, 1988.
- 3. Said dredged or fill material constitutes a "pollutant" within the meaning of CWA Section 502(6), 33 U.S.C. Section 1362(6).
- 4. Such placement of dredged or fill material in the side channel of the Yellowstone River and its adjacent floodplain constituted a "discharge" within the meaning of the Clean Water Act (CWA) Section 502(12) and (16) U.S.C. Section 1362(12) and (16).
- 5. The tractor or other machinery used to carry out said dredged or fill activities constitutes "point sources" within the meaning of CWA Section 502(14) 33 U.S.C. Section 1362(14).
- 6. PBWUA is a "person" within the meaning of CWA Section 502(5), 33 U.S.C. Section 1362(5).
- 7. The Yellowstone River and the above referenced side channel and adjacent wetlands are "navigable waters", i.e. waters of the United States, within the meaning of CWA Section 502(7), 33 U.S.C. Section 1362(7).
- 8. CWA Section 301, 33 U.S.C. Section 1311, prohibits the discharge of dredged or fill material from a point source into the waters of the United States by a person except in compliance with a permit issued pursuant to CWA Section 404, 33 U.S.C. Section 1344.

- 9. PBWUA did not obtain a permit pursuant to CWA Section 404, 33 U.S.C. Section 1344, prior to the above described discharges to the Yellowstone River and its adjacent floodplain area.
  - 10. Said discharges of dredged or fill material in the
    Yellowstone River as described above without such a Section
    404 permit constitute violations of CWA Section 301, 33
    U.S.C. Section 1311.
  - 11. Restoration of the affected floodplain riparian area is appropriate because of the harm to fisheries and wildlife resources.
  - 12. Restoration will confer maximum environmental benefits since mere removal of the material will not abate the actual and potential harm from erosion and loss of fish and wildlife habitat.
  - 13. Restoration of the affected riverine riparian vegetation to a condition which approximates a condition prior to its loss is achievable as a practicable matter through commonly used construction, revegetation and best management practices.
  - 14. As determined by EPA, such reasonable and achievable restoration efforts would bear an equitable relationship to the violations and wrongs described herein.
  - 15. The PBWUA has contacted the Montana Department of Natural Resources to seek funding for a permanent solution to such annual or periodic dredging of the side channel and the discharge of this material into the river and its floodplain.

16. These FINDINGS and the ORDER which follows have been made after consultation and coordination with the United States Army Corps of Engineers, Omaha District.

#### ORDER FOR COMPLIANCE

Based upon the foregoing FINDINGS, and pursuant to the Authority vested in the Administrator of EPA under CWA Sections 308 and 309(a), 33 U.S.C. Sections 1318 and 1319(a), and by him delegated to the Regional Administrator, and redelegated to the undersigned, it is hereby ordered:

- 1. PBWUA shall develop a plan that provides for restoration and stabilization of the affected Yellowstone River side channel and channel banks referenced in referenced in FINDINGS

  Paragraph 1 above, in order to restore the impacted area to its prior state. The plan at a minimum shall allow for revegetation of the eroding channel banks and be submitted to EPA by April 1, 1989. Said restoration plan shall be subject to the approval of EPA in consultation with the Corps of Engineers, Soil conservation Service, Montana Department of Natural Resources and Conservation, Montana Department of Health and Environmental Sciences, Montana Department of State Lands, Montana Department of Fish, Wildlife and Parks, and Park County Conservation District.
- 2. PBWUA shall develop a plan for a permanent solution to allow irrigation water to be obtained without recurrence of dredging and filling that is damaging to fish and wildlife resources and channel stability and said plan shall be submitted to EPA by August 1, 1989. Said restoration plan shall be subject to the approval of EPA in consultation with

Box 5, Omaha, Nebraska 68102 to determine if the proposed removal and restoration will require a permit from the Corps of Engineers under Section 404 of the Clean Water Act. If necessary such permit shall be obtained prior to implementation of said restoration.
- 4. PBWUA shall consult with appropriate State and local agencies (e.g. Montana Department of Health & Environmental Sciences, Montana Department of State Lands, Park County Conservation District, etc.) to determine if the proposed restoration will require additional authorization under State or local law.
- 5. PBWUA shall implement said restoration for item 1 in the ORDER prior to June 1, 1989.
- 6. A representative of EPA will inspect the completed restoration after notice is provided in writing to EPA that said restoration has been accomplished.

this ORDER shall not be deemed to be an election by the United States to forego any civil or criminal action to seek penalties, fines, or other appropriate relief under the Clean Water Act for the violations giving rise to this ORDER. The Criminal Fine Enforcement Act of 1984, P.L. 98-596, provides for fines in excess of the amount specified in the statute under certain circumstances. Compliance with the terms and conditions of this ORDER shall not be construed to relieve the orderee of its obligations to comply with any applicable federal, state, or local law.

This is in reference to your letter of January 30, 1989 with enclosures regarding a proposed solution for the Park Branch Canal Inlet problem in the Yellowstone River near Emigrant, Montana. As you requested, we have reviewed the engineering design concept presented by your firm which uses submerged vanes to minimize or possibly eliminate deposition of gravel during periods of high flow. It appears from our review of the enclosures you provided on the use of submerged vanes in coblebed rivers has merit and their effectiveness should be tested in coble-bed rivers.

We were please to hear that you recently testified before the Montana legislature to secure funding for a demonstration project using the submerged vanes concept. You are awe that we have issued an Administrative Order (AO) to the Park Branch Canal Company for their failure to comply with the Clean Water Act and obtain a 404 permit before discharging material into waters of the United States. One of the requirements of the AO is that the Park Branch Canal Company submit a proposal for a permanent solution at the inlet to the canal. We commend your efforts to work with the Montana Department of Natural Resources and the Park Branch Canal Company in seeking a permanent solution to their maintenance problem.

Please keep us appraised of your efforts to obtain funding for a permanent solution to the inlet problem for the Park Branch Canal Company in cooperation with the Montana Department of Natural Resources.
