HEARING ON HOUSE BILL 782

Presentation and Opening Statement by Sponsor:

Representative Joe Quilici of Butte, representing District 71, opened the hearing saying he had gone through the Forensic Science Lab and became aware that there were many problems. This legislation is to establish new functions for the Forensic Science Division. The medical examiner, at present is in charge of the whole facility, which did not work well, he stated. This measure, he said, would place the functions of the director under the authority of the attorney general. It would also provide for a medical examiner and a director of laboratory of criminalistics, and clarified their positions. List of Testifying Proponents and What Group they Represent:

Testimony:

- Marc Racicot said the bill was a vitally important piece of legislation. He said the laboratory and its functions had been thoroughly reviewed and the bill would improve upon the present system. In the past the medical examiner was responsible for performing autopsies, holding seminars throughout the state of Montana and supervise the laboratory side of the laboratory. At the laboratory, there are 66,000 analyses that take place each year, so he felt there was not time for the medical examiner to adequately supervise the laboratory functions. A suggestion that the medical examiner maintain the pathology side and the division administrator supervise the laboratory was incorporated into the bill. He said that funding was in House Bill 100 and was being considered in the House at that time.
- Questions From Committee Members: Senator Halligan asked how the other bill requested by the attorney general dealt with the lab director. Marc Racicot said his office had asked that the bill be withdrawn as it reflected the ideas of only one person who was no longer employed at the lab.

Senator Halligan asked if that bill dealt with the provision that the current director could be removed. Mr. Racicot said it did not. He said current statute required specialized hearings to remove a director, far different from the means of dismissing other state employees. The bill dealt with that statute.

<u>Closing by Sponsor:</u> Rep. Quilici said that the Rules Committee had heard the bill to see whether or not it was an appropriations bill. He said the appropriation was added in the Senate Finance and Claims Committee. He urged concurrence of the bill.
