HEARING ON HOUSE JOINT RESOLUTION 37

Presentation and Opening Statement by Sponsor: William Menahan, Representative from House District #67, stated that the doctors at Montana State Hospital, Galen, requested that the new Forensics Building on the Galen campus be named after Dr. Harry Xanthopoulos. According to Rep. Menahan, Dr. Xanthopoulos is affectionately known as "Doctor X", having been there for over 20 years. He has been a physician in authority and served as Director at one time, and has turned down offers of higher paying positions to stay at the Montana facility. Rep. Menahan stated Dr. Xanthopoulos is still on the staff, and other staff members feel this would be a good tribute to his loyalty and service. Rep. Menahan stated he agreed with the amendments presented by Curt Chisholm, Department of Institutions.

Testimony: Curt Chisholm, Director, Department of Institutions, stated this Resolution was introduced and passed by the House before his Department knew it existed, although he knew the doctors were in favor of the name requested in the Resolution. He stated his Department does not object, but they prefer the name "Xanthopoulos Treatment Facility". It is currently called the "Forensic Treatment Facility". The name change is requested in the proposed amendment which would strike "Harry Xanthopoulos Building" and insert "Xanthopoulos Treatment Facility". In addition, there were some technical changes included in the amendments. He presented copies of the proposed amendments to the committee (Exhibit #1).

- Questions From Committee Members: Senator Hager expressed concern that since Dr. Xanthopoulos is referred to as Doctor X, would it be possible that it would be called the "X" Building. Rep. Menahan stated he believed that a plaque would probably be mounted rather than the name being put on the building.
- Senator Himsl stated he agrees with the designation as a Treatment Facility rather than naming the building.
- <u>Closing by Sponsor:</u> Representative Menahan closed without further comments.
