### EXECUTIVE ACTION

HB 200

Senator Regan noted that there were a lot of problems with HB 200 but it was her intent to save the definition and the designation of the lead agency. She pointed out that it was important for the state to have a lead agency in child care. She moved the bill and struck everything else from the bill.

Senator Van Valkenburg made a substitution motion to do pass the bill. He said he wanted a chance to vote for the bill in its present form.

The question was called. The motion failed 6-13 on a roll call vote.

Senator Regan said she would like to save the definition out of the bill on page 12-13. She moved that those definitions be adopted on page 12-13 and save section 8. Save section 3 on the department lead agency.

- Senator Bengtson pointed out the controversy on the definitions was on the pre-schools and that was deleted in the House.
- Senator Regan said that daycare was what they were trying to define.
- Senator Keating asked about the use of the term "daycare" for the developmentally disabled and would this cause confusion in the definition of daycare and child care.
- Charlie McCarthy, DFS, said the definition of daycare was defined in 1981 and was still in the legislation. He said there was a different definition being proposed this time in the section that was clarification of the definition of day care. This is on the bottom of page 12 and the top of page 13. He noted that day care for the developmentally disabled was different legislation involving the Health Department with a licensing unit for day treatment for developmentally disabled and the definition would not conflict.
- Senator Nathe asked where this would put babysitting.
- Charlie McCarthy replied that babysitting is on a irregular basis and the definition of daycare is regular care defined as three consecutive weeks or more.

  Babysitting is not licensed by anybody.
- Senator Stimatz asked for clarification of the motion. Senator Keating asked if this would be voting on section 8 as amended by the House.
- Senator Story clarified that if this motion prevails the bill would be reduced to section 3, 7, 8 and the title. He said that section 7 would give them their duties as lead agency.
- Senator Keating asked if DFS now did licensing for child care around the state and were already the lead agency for registering child care establishments.
- Mr. McCarthy replied that DFS was the lead agency for licensing. This would give authority to be lead agency over child care mandates a state plan for day care that includes the day care that goes on in the Department of Labor, SRS, and Health Department. It is more than licensing. He said the planning that goes on now goes on in each separate agency. The establishment of a lead agency would bring that all together so someone is responsible for putting it together in one plan so there are not four separate agencies doing their own

thing.

- Senator Keating asked if this would require more personnel.

  Mr. McCarthy replied that it would not (246).
- Senator Van Valkenburg noted that sections 15, 16, and 17 had the codification instruction, severability and effective date. He said in particular the codification instructions was needed because section 3 says the department is designated there is nothing there that says which department. The codification instruction makes it refer to the Department of Family Services.

Senator Regan amended her motion to amend the title and include sections 15, 16, 17.

- Senator Aklestad pointed out that section 8 appeared during testimony to have problems.
- Senator Van Valkenburg said the only problems in section 8 referred to the business between the pre-school and the daycare. It is being left in the form that does not define pre-school.
- Senator Himsl commented that this is not a good way to legislate.

The question was called. Senator Regan's motion failed 8-11 on a roll call vote.

Senator Devlin made a substitute motion to table HB 200. The motion failed 6-13 on a roll call vote.

Senator Aklestad moved to do not pass House Bill 200. The motion passed 14-5 on a roll call vote.

HB 759
Senator Manning moved do pass HB 759.

Senator Van Valkenburg offered an amendment (Exhibit #1).

He discussed the amendment.(505) He said this would provide the director in the Board of Science and Technology the ability to provide grants. He said the bill would provide criteria they should use in making that award. The amendment would add a forth criteria and that is the research program be coordinated with research programs in the state university system. He pointed out this would enhance the research effort. It was a major investment and this would insure that they were not duplicating something that had already been done.

- Senator Manning opposed the amendment. He said this would be duplication.
- Senator Van Valkenburg said this would leave it to the Board of Science and Technology at the time they award the grant to think about that before they hand them two million dollars (615). He said this would coordinate the effort and would avoid creating another unit of the system. He pointed out that there were already research programs going at MSU and at U of M.
- Senator Manning pointed out that the reason two million was being asked for was to get the ten million from the feds.
- Senator Keating commented that separate entities doing research may stimulate competition.
- Senator Stimatz said he opposed the amendment because it confused the issue. He pointed out that it would have the university system ride the coattails of an organization that is already in place.
- Senator Jacobson pointed out that medical research was normally connected to the university. All this amendment is doing is asking them to talk.
- Senator Jergeson noted that he would like to see this bill contain some requirements for private funds. He suggested page 2, line 8, following "basis" insert "and \$500,000 of private funds".
- Senator Manning asked if there was someone giving something of value to the research center.
- Senator Thayer replied the proposal for the McGlaughlin Center, when the federal grant for the new building is obtained, it will be built on land that is currently owned by the Columbus Hospital which is owned by the Sisters of Charity and it they are going to make this land available, which has quite a significant value, and it is either going to be donated or leased for one dollar for one hundred years.
- Morris Browning, Administrative Director of McGlaughlin Research Institute, explained that the sisters are going to make available a ten acre tract for this property including the necessary utility connections. He said that besides the value of the property of about \$100,000, there was additional monies coming to the research institute through the gift of life campaign of

approximately \$75,000. (932)

The question was called on the amendment to require a private match. Senator Van Valkenburg asked if this would reduce the two million so it would be \$1.5 million appropriation and \$500,000 from private funds. Senator Jergeson clarified that it says the two million is appropriated and the money is to be used to match federally appropriated funds and \$500,000 of private.

The motion failed with one no vote by Senator Jergeson.

- Senator Himsl asked if this was just the application that the federal funds had not yet been appropriated.
- Senator Manning clarified that this was asking for two million from the state and then the federal government would come up with ten million. If they don't come up with it, this would revert.
- Senator Jenkins pointed out that the state had to come up with the two million because during the interim, Great Falls would have no way of coming up with the two million. If the federal government did not come up with ten million, this money stays here.

The question was called on the motion to concur. The motion passed with three no votes.

Chairman Story announced an hour dinner break. The meeting continued at 7:15 p.m.

#### HB 780

- Senator Aklestad pointed out that HB 780 requires rule making and therefore requires a statement of intent.
- Chairman Story said the department feels they need to amend their rules in order to permit them to sell usable parts off these vehicles to junk yards rather than just crushing them. He read the statement of intent. (150)
- Senator Story clarified that this strips the bill with everything except the section required to give them authority for rule making. The title of the bill would have to be amended accordingly.
- Senator Aklestad moved the statement of intent first paragraph only.

The question was called. The motion passed unanimously.

(Tape 1-B)
Senator Aklestad asked why this was necessary.

- Senator Story replied that the department felt this was a grey area and they did not have statutory authority and they would like to have authority for rule making. He said they also want to amend it so they don't have to get it done by October because they don't think they can get it done by October under the rule making procedure. They need the immediate effective date so they can start working through the rules. Mr. Opitz said they want section 3 changed from October 1989 to July 1, 1990. (039)
- Senator Aklestad moved the bill to keep section 3, 6 and alter the title and to strike October 1, and insert July 1, 1990 and strike all other sections.

The question was called. The motion passed unanimously.

Senator Jenkins moved to do pass HB 780. The question was called. The motion passed unanimously.

### HB 614

- Senator Story said this provides a ten cent charge to all phone service.
- Senator Manning presented an amendment for HB 614 (Exhibit #3). He explained that this would take the statutory appropriation out. He moved the amendment. (140)

The question was called on the amendment. The motion passed unanimously.

- Senator Manning presented another amendment (Exhibit #4).

  Representative Wyatt explained the amendment. She said this was a means test determined by SRS that this group was going to use since they were attached to SRS. She said there was a means test for the pieces of equipment because they don't want people that can afford to buy it themselves to given or loaned these pieces of equipment so only someone who could not, she said. The amendment would take the means test out. She pointed out it was important that the means test stay in.
- Senator Jacobson asked if she would have any objection to leaving it in but putting the department instead of the committee in charge.

Representative Wyatt said she would have no objection.

- Senator Van Valkenburg pointed out the problem in getting the department involved was the concern about FTE's and costs. The did not want a new program in SRS.
- Senator Jacobson pointed out that there was already a means test and if it was just put in as a duty of the department it would not create another FTE.
- Senator Manning said he withdrew the amendment (259).
- Senator Van Valkenburg moved to do pass HB 614.
- Senator Manning said the bill was intended to assist these people to be like anyone else and be able to call and talk to anyone. He explained that there is a person that intercepts and relays the call.
- Senator Jenkins pointed out that their son or daughter or friend could do the same thing.
- Senator Aklestad asked if the FTE's in the relay system were under personal services.
- Representative Wyatt replied that there were no FTE in there at all. SRS is going to take the money and give it out to the committee and the committee will be privatizing the operation.

The question was called. The motion to do pass failed 8-11. The vote was reversed for a do not pass.

### HB 763

- (496)Senator Story explained that this deals with \$100,000 for in-home services for the aging plus additional funds put in by committee.
- Senator Keating commented that this did not even provide matching money this was just \$100,000 pure general fund. He moved HB 763 do not pass. Senator Jergeson requested a recorded vote.

The question was called on the do not pass motion. The motion passed 14-5 on a roll call vote.

#### HB 768

Senator Nathe moved do pass HB 768.

Senator Jergeson agreed that it was a wonderful program but pointed out the state could not afford help for senior

citizens, children, or the hearing impaired.

- Senator Nathe pointed out that this was like a quantum jump in intelligence in interpreting what is happening by Mr. Jack Horner and he believes there are further contributions to be made.
- Senator Keating asked if this bill were to fail would that be the end of the Museum of the Rockies.
- Senator Van Valkenburg said if this motion passes he would like something in the minutes about expectation of future commitment to Museum of the Rockies.
- Judy Weaver, Assistant Director and currently Acting Director of the Museum (671), clarified the one third concept. She said the impression was made that they were not asking for a fixed dollar amount but rather asking the state to assume a percentage of funding now and in the future. She clarified that was not their intent. The bill carries in it a dollar amount for base salaries, maintenance, and utilities. The one third concept was used in the past to describe funding for the museum historically. Today the state gives about 20% of the total operating budget and the private sector funds the rest. She said she presumed that in the future that percentage would decline. She expects that the private sector would pick up more of the museum support. She did not know how many years they would need state support but that they do need help
- Senator Van Valkenburg asked if she meant that total 20% funding including this and what is in MSU budget and that will not go higher than that in the future it will only go down.

Judy Weaver replied that was correct.

The question was called. The motion passed 10-9 on a roll call vote.

HB 193

Senator Bengtson moved that HB 193 do pass.

Senator Devlin asked for information of the coal trust.

Richard Miller replied that the coal severance tax went to the six library federations. (952)

Senator Devlin moved as a substitute motion to cut the funds in half so it would be \$750,000 for each year of the biennium.

Senator Bengtson said she did have an alternative amendment.

Senator Devlin withdrew his amendment until he heard hers.

Senator Bengtson presented an amendment to cut direct aid to public libraries to fifty cents per capita and per square mile instead of a dollar. She said the bottom line for this was \$1,702,662. She said this figures out what goes to reimbursement for interlibrary loans, reimbursement for states multi-library card, and the base grants for library federations. It cuts the direct aid request in half, the interlibrary loan reimbursement remains the same, reimbursement for the state multi-library card cut in half, base grants for federations cut in half, administration remains the same of 1.5% of the total. The other amendment cut everything out except the direct aid and the bottom line on that was \$1,892,126. She said if the committee would be willing to accept the lower amendment it is a commitment on the part of the Legislature to make a direct contribution to public libraries in the state.

Senator Bengtson moved to amend HB 193 which she said the bottom line of that is \$1,702,662 (Exhibit #5).

The question was called. The motion passed 10-8 on a roll call vote.

Senator Bengtson moved the bill as amended.

Senator Bengtson commented about Senator Jergeson's discussion about not giving to the elderly, infants or children. She pointed out that these subjects have all been addressed in the budgets. She said the museums and libraries are the multipliers in society and are the very things that build society.

(Tape 2-A)

Senator Bengtson said it was fair to deal with these enrichment programs.

Senator Aklestad pointed out that this needed a statement of intent.

Richard Miller distributed a statement of intent (Exhibit #6).

Senator Bengtson moved the statement of intent. The question was called. The motion passed with one no vote.

Senator Bengtson commented that books are for people that don't have access to public school system. The public library is there as a resource to provide education.

Senator Bengtson moved do pass as amended with the statement of intent.

The question was called. The motion passed 12-7 on a roll call vote.

HB 277

Senator Jenkins moved do not pass.

Senator Boylan made a substitute motion to do pass (184).

The question was called on the substitute motion to do pass. The motion passed 10-9 on a roll call vote.

**HB 333** 

Senator Keating ascertained that HB 333 would cover everything that the Department of Health is trying to do to be able to react to emergencies and then HB 609 would not be necessary. He offered an amendment regarding the statutory program. He explained that HB 333 deals with the environmental quality protection fund which is 4% of RIT. The fines and penalties that are collected will go to this fund. HB 333 is the authority to expend those funds if the need arises. (Exhibit #7) He moved the amendment. (349)

The question was called. The motion passed unanimously.

Senator Keating moved HB 333 do pass as amended.

The question was called. The motion passed with 3 no votes.

HB 609

Senator Keating moved HB 609 do not pass. The question was called. The motion to do not pass passed with one no vote by Senator Jergeson.

HB 769

Senator Jenkins moved HB 769 do not pass.

Senator Jergeson pointed out that this research and assistance in sustainable agriculture is needed and is

gaining in popularity. He pointed out that there was no reason for discriminating against this. He made a substitute motion to do pass HB 769.

Senator Jenkins pointed out that in 1985 they asked the Experiment Station to do this very job this bill says and it is on the books now (603).

Senator Jergeson said he had not seen that statute.

Senator Aklestad pointed out that if this program is important then within the existing budget of the Extension and Experiment Station they should be able to prioritize some of their existing budget and go ahead with this program. He noted that on page 3, line 8, that says the Extension Service "shall" provide the service. He said if they are going to then they would be back next time for money.

The question was called on the do pass motion. The motion passed 10-9 on a roll call vote.

HB 601 Senator Manning moved to do pass HB 601.

Senator Himsl explained that this would replace EPA funding grant program which is terminating and makes possible federal funds at the rate of 80% federal money 20% state match.

Senator Story clarified that it was not for infra-structure but for wastewater, water and sewage systems.

The question was called. The motion passed unanimously.

HB 718 Senator Jacobson moved do pass HB 718.

Senator Story discussed the bill as an entitlement to veterans. He said the states share of costs for veterans homes were larger than the states share of costs for nursing homes. There is a different screening on veterans so the average stay in a nursing home is over a year, the average stay in a veterans home is over three years. He pointed out that veterans homes do not require an economic need test. The real expense is that since 1895 there has not been a veterans home built so there has not been an entitlement. If this bill is passed, this would create an entitlement, he stated (915). Instead of spending

money for two or three hundred veterans, money may be spent on up to 100,000 veterans. There is not enough money in Montana to do that, but once an entitlement is created, a court would insure that it is carried out. This would create a high danger to Montana and expose the future taxpayers to more costs.

- Senator Devlin asked Mr. Chisolm about the proposed amendment for a year grace period. Mr. Chisolm replied that he gave it to Senator Story and it may need typing up.
- Senator Jergeson asked where in the bill did it create an entitlement program if it provides for 40 beds. He asked out it would create an entitlement beyond the 40.
- Senator Story explained that the forty first veteran could go to a judge and the judge decides that there is equal protection clause of the Constitution requires fair treatment. (055)
- Mr. Chisolm explained the updated amendments. (Exhibit #8) He said the first thing he suggested to do was to identify the number of beds in this bill. He said he arbitrarily put in 40 beds so he had a number to work He is proposing a new section be added to the bill and it is an implementation section. It says that he has a year to implement the provisions of this act. He said he could do it no sooner than July 1990, contingent on two critical issues. The first is that the renovation costs of upgrading whatever vacant areas are available for this 40 beds, does not exceed \$300,000. This is an arbitrary limit that he put on it. (219) He said that if it costs for that, the deal is off, because it is not worth spending more into that facility. Secondly, what he can verify from the Veterans Administration in Washington, that these beds will be eligible for that per diem. It neither one of these provisions can be met, then he does not have to implement the provisions of this act. He pointed out that he plugged in some spending authority, because if the provisions are met and they are ready to go, then it will take some operating money for the 40 beds.

## (Tape 2-B)

- Senator Harding asked about federal law in regards to wartime veterans as opposed to other veterans and what the price tag was.
- Mr. Rich Brown replied that only wartime veterans were eligible for payment at institutions for pension and aid to dependents. The majority of that money that

comes to that institution is from the individual. In order to qualify for that pension and aid to dependents, they must be extremely poor. These are all under federal law and they are the ones that set the rules as to what veterans are eligible.

- Senator Story pointed out that if this bill is passed, under Montana law, Montana defines veterans differently, there will be people that are eligible under Montana law to go into those homes.
- Mr. Brown pointed out that there was a definition of veterans under Montana law but in order to be eligible for federal VA pension and aid to dependents the federal law must be met.
- Senator Van Valkenburg suggested that an amendment be made to the bills that would define eligible veterans to limit them and follow federal regulations.
- Senator Story said that if it was confirmed that the purpose of going into the homes could be conformed to the federal standard then the peacetime veteran would not be eligible for these homes. He said amendments that would limit this would mean a great difference in the cost.
- Mr. Chisolm explained the statutory admission to the Veterans Home at Columbia Falls. He said that veterans were eligible for admission if they are an honorably discharged veteran or spouse or surviving spouse of a If this definition is met, the federal veterans. Veterans Administration will subsidize that bed as long as the veteran is honorably discharged. The pensions are entitlements that come to the veteran. These are an extra source of income that can be billed against to pay the difference in what the feds give and in per day per diem of what is actually charged. (128) The VA pays about \$20.35 and leaves a difference of about \$30.00 still owed. If individual veterans receive a pension allowance then the home bills against that so they can pay on an ability to pay. If they don't have that then they pay on ability to pay against social security or whatever other source of income they have.

Senator Devlin moved the amendments. (Exhibit #8)

- Senator Harding asked if their eligibility would be based on need.
- Mr. Brown replied that a veteran would have to be in need of nursing home care to get to Columbia Falls Veterans

Home facility. The veteran would have to be in need of income in order to receive pension and aid to dependents.

- Senator Hammond asked if they don't have pension then they have to come up with additional money some other way.
- Mr. Brown replied that was correct and that was why 75% or more of the money is provided free of federal government at the Columbia Falls facility and there is the smallest amount of Medicaid delivered there. (175)
- Senator Jergeson asked if the person is a peacetime veteran at the Columbia Falls Home and has no money who would pay that \$30.00.
- Mr. Chisolm replied that happens occasionally. The VA will still pay the per diem of \$20.35 a day to support the veteran. If that is all the veteran has then the veteran will be Medicaid eligible.

Senator Aklestad moved the amendments.

Senator Van Valkenburg moved that the amendments be segregated. He said the first amendments could be voted on but he had amendments to number eight.

The question was called on #1-#7 (Exhibit #8). The motion passed unanimously.

- Senator Van Valkenburg explained that the amendment put on HB 202 included an appropriation for the Galen home and the eastern Montana home that was \$1.9 million. If amendment #8 is left it would end up as a double appropriation of this amount. He proposed to change #8 so that Section 5 of the bill would read "this act is contingent on passage and approval of HB 202 if HB 202 is passed and approved, section 2 of this act HB 718 is void." He moved to amend #8 to make those changes.
- Clayton Schenck explained that the money that is in the bill as it currently stands is for operating funds not for the building of it. They are not the same as the funds for construction.

Senator Devlin moved #8 of the amendment.

The question was called. The motion passed with one no vote.

Senator Himsl voice objection that the program was not being reviewed by the usual process of government.

Senator Jacobson read Senator Regan's statement. She felt that the legislative process was being bypassed and was setting a bad precedent.

The question was called to pass HB 718 as amended. The motion passed 12-7 on a roll call vote.

#### HB 547

Senator Devlin moved do pass HB 547.

Senator Himsl presented an amendment that Senator Regan left. (Exhibit #9) He moved the amendment. He explained that the provides for funding and planning study and still allows for construction. (470) get

Senator Story asked if this was going after some federal dollars.

Senator Devlin replied it was a 65-35 match.

Senator Story asked if it was funded or something proposed.

- Senator Devlin replied that the state had to show that they could come up with \$1.4 million in order to apply.
- Senator Story asked if they did not come through with the money would this plan be void. Senator Devlin replied that it would be out the window.
- Senator Tveit pointed out that on the second amendment it was just getting the plans together to apply to the feds for the approval of the facility. The deadline is for the study to present to the federal administration for their approval. If they don't come up with the money on the federal side then this is null and void.
- Clayton Schenck explained (614) that the third amendment was put in with the intent to make it clear that construction can not commence before confirmation comes from the federal government. As the bill is currently written he was not sure there was that restriction.
- Mr. Rich Brown (633) explained if there were not 65% match there would be no construction.
- Senator Story noted that this bill would not stop construction as the bill is now written.
- Mr. Chisolm said the amendments that are being proposed by Senator Regan is an option to those presented by the

bill sponsor.

- Clayton Schenck explained the other amendment. In general, it exempts the veterans home from the certificate of need review and discusses the committee that is going to work on it. He was not aware of any conflict or option between the two amendments.
- Senator Devlin felt that this would change the formation of the bill on the site selection committee and picking the site.
- Senator Tveit said the second amendment when the date is stripped out, it is not setting a timeline to get the proposal. It would set it back a couple of years. Amendment four guts the bill by saying there will just be a study. Both amendment pretty much kill the bill. He said he would like to segregate the amendments 2 and 4 of the other packet.
- Clayton Schenck explained that amendment #4 is a contingency appropriation that says if HB 202 fails that there is general fund money to do the design and planning and site selection. Amendment #4 and 6 is contingency if HB 202 fails then #4 goes into effect. All it does it provide an for an alternative if HB 202 fails to let them go ahead with the design and planning and site selection but using general fund instead.
- Senator Jergeson pointed out that Senator Regan's amendment would not allow a veterans home in eastern Montana.
- The question was called on Senator Regan's amendment (#9). The motion passed 9-8 on a roll call vote.
- Senator Devlin discussed the amendments that were requested by the sponsor, Representative Johnson. (Exhibit #10) He noted that there may be some conflicts between this and the other amendments. He explained that this exempted the veterans home from the certificate of need.
- Chairman Story pointed out that the amendments should be coordinated.
- Senator Devlin (986) said there were specific reasons for taking out the certificate of need. He moved the amendment.
- Senator Aklestad asked if the current veterans home required a certificate of need.

- Mr. Chisolm replied that state projects did not have to go through the certificate of need. He said the veterans group wanted assurance that this would not get hung up in certificate of need process.
- Senator Himsl asked Mr. Opitz if they were exempt from certificate of need.
- Mr. Opitz (035) replied that the question was posed to the Department of Health's legal counsel and this was an insurance policy to make sure that they would not be subject to certificate of need. He said they do the licensing and certification but they are not to be mixed up.
- Senator Van Valkenburg pointed out that the problem with this amendment and the previous one is that they both created a new section 17. This would need to be renumbered to section 18 on this amendment.
- Senator Jenkins noted that amendment 9 would have to be changed to section 19. The way it is written, changes would have to be made.
- Senator Devlin said the researcher could coordinate the two amendments. (corrected version of #9-Exhibit #11)
- Senator Devlin moved the amendment (Exhibit #10). The question was called. The motion passed unanimously.
- Senator Devlin explained that the Governor would appoint a committee to make a site selection. There will be application made to the feds for 65% matching funds. He pointed out that the various groups agreed to all support this bill and accept the site selection committees recommendation.

### (Tape 3-A)

- Senator Himsl asked about the status of the veterans hospital and why would that not be an ideal facility.
- Senator Devlin explained that it was a hospital now and not a nursing home.
- Jim Ahrens, Montana Hospital Association, responded to a question by Senator Van Valkenburg concerning vacant beds. He said that the association did not take a stand on the issue and he had no knowledge of the situation.
- Senator Jenkins asked if the \$20 a day would still be

received in a nursing home versus a veterans home.

- Senator Van Valkenburg asked if this was an option that should be considered before a new state institution is built. He pointed out there were vacant nursing homes and hospital beds in eastern Montana that would serve these needs.
- Mr. Chisolm said that the veterans groups were afraid the VA would not make those vets eligible for the subsidy if they can't identify a distinct and separate entity for veterans only as a state operated veterans home. He pointed out it was difficult to do if the facility is a wing of an existing private organization. This is why he suggested conditioning the annex at Galen. If the Veterans Administration does not sanction those beds for reimbursement then it would be a mistake.
- Mr. Brown said the reason they were asking the state to build a state share facility with the Veterans Administration was that they could apply the \$20.35 a day towards the care so the state did not have to come up with even Medicaid payments. He pointed out there was some doubt whether private hospitals would want them to manage one wing of their hospital.
- Senator Story pointed out that (137) presently there was a considerable vacancy rate in nursing homes in eastern Montana. The occupancy is going down. It is true that they are not eligible for federal money, however the higher reimbursement for Medicaid means that five dollars a day less general fund is spent for putting someone in a nursing home than in a veterans home.

Senator Devlin moved HB 547 do pass as amended. The motion passed 10-9 on a roll call vote.

#### HB 472

Senator Jenkins moved do not pass. The motion to do not pass passed 15-2 on a roll call vote.

### **HB** 773

Senator Harding moved to amend HB 773. She presented an amendment (Exhibit #12). She explained that funds could be rearranged in HB 100 that would cover HB 773. In HB 100 through the Department of Family Services there is the sum of \$58,069 in 1990 and \$50,667 in 1991 that could go for this. The Department of Health said that they would allow \$46,541 in 1990 and \$46,675 in 1991.

Mr. Opitz explained that they want to reduce the appropriation on HB 773 by that amount and the director will rearrange priorities between the handicapped children program and the preventive health bureau. He noted that Dr. Esplin had some preventive health money for this purpose. He pointed out that normally there was some carryover money from preventive health block grant monies. That in HB 100 is at the discretion of the director to reallocate. Potentially there could be some money from the Health Planning Bureau because certificate of need has been removed as far as hospitals are concerned. (403) There are also some general fund modifications to family planning that potentially could contribute something toward this

The question was called on the amendment. The motion passed unanimously.

Senator Harding moved the bill as amended. The question was called. The motion passed unanimously.

As requested we have calculated the revenue and expenses involved in the operation of a 100 bed Veteran's nursing facility in eastern Montana. In making this calculation, the following assumptions are made:

- 1. The number of licensed skilled nursing beds is 100.
- 2. The percentage of occupancy of those beds is 93.3%.
- 3. The total cost per patient day is \$54.71.
- 4. The billable per diem per patient day is \$53.07.
- 5. The physical plant is in place. No construction costs are included in the calculations.
- 6. There is full participation in all federal VA and Medicaid entitlements. Note: Typically, VA participation does not begin until the facility has been in operation for one to one and one half years. General Fund participation will increase by \$692,999 per year until VA participation is achieved. Total General Fund participation would be \$1,061,100 per year until VA participation is achieved.
- 7. The facility is budgeted for an ADP of 93.3 members.
- 8. Fixed equipment would be included in the construction costs, however, operational equipment would have to be purchased. That cost has not been reflected in the calculation.
- 9. Should the facility's construction costs be funded through a bonding program, and if the Department of Institutions is required to make payments on the debt service of those bonds from the revenue generated through operation of the facility, additional General Fund authority in the amount of the debt service payments will be required.
- 10. An additional Financial Investigator position will be required in the Management Services Division, of the Department of Institutions, to maintain the private billing function for the new facility. These costs are
