HEARING ON HB 36

Presentation and Opening Statement by Sponsor:

Representative Ray Peck stated that HB36 comes to the committee as a correction to HB100, regarding the language. He explained that \$25,000 was appropriated for the state traffic education account, and that this bill is to correct an error regarding reference to the federal special revenue fund. He added that, on page 1, line 16, he was requested to insert "advanced drivers education account", following "appropriated from the", authorizing appropriation of the traffic education fund.

Kathy Fabiano, Office of Public Instruction

Testimony:

Ms. Fabiano indicated that the language in Section 1, regarding appropriation authority, was inadvertently left out, and that they had no authority to distribute those funds. She added that the appropriation was never moved from the federal special revenue fund to the state special revenue fund, and that this bill does not increase their authority, it just moves the funds from one column to another.

She then indicated that they were not aware of the requested amendment, mentioned by Representative Peck, and that, although they do not see the need, they have no problem with it.

- Q. Senator Himsl asked Ms. Fabiano if he understood her to say she does not think the amendment is necessary.
- A. Ms. Fabiano responded no, that she indicated they were not aware of the amendment, but see no problem with it.
- Q. Senator Keating asked Ms. Fabiano what is the source of those funds.
- A. Ms. Fabiano responded that they are accumulated revenues.
- Q. Senator Keating asked where the accumulated revenues come from.
- A. Ms. Fabiano responded from the fees charged to individuals who receive training, noting they are charged approximately \$100, and also from a grant through the Department of Justice.
- Q. Senator Jenkins asked Ms. Fabiano if this is intended to be a one-time shot.
- A. Ms. Fabiano responded yes, that it is for equipment replacement, and repair of lighting facilities.

- A. Representative Peck responded that they are taking the language out.
