HEARING ON SB 24

Presentation and Opening Statement by Sponsor:

SEN. ROBERT WILLIAMS, Senate District 15, Hobson, stated there was a case in Fergus County where the children refused to pay for the burial of a parent. SB 24 makes it mandatory for children to pay for the burial of a parent.

Proponents' Testimony:

Gordon Morris, Director, Montana Association of Counties, provided a resolution for the committee. EXHIBIT 1

Opponents' Testimony: None

Questions From Committee Members:

REP. KASTEN asked who would enforce this bill and with what action. Mr. Morris stated that in section 40-6-303 on page 2 the department states that a civil action may be brought by the county.

REP. KASTEN asked the cost to bring suit against an adult child who refuses to pay for a parent's burial. Mr. Morris stated it would take two to three hours to process an order and he didn't know the exact cost.

REP. HANSEN asked if there were more than one child in the family and the parent dies, who would be responsible for the costs. Mr. Morris stated that it is the duty of the children, so the county would approach all of them.

REP. CROMLEY said the bill states that the child must have the ability to pay; how is it determined who can or can't afford it. Mr. Morris stated that the county welfare office would make that determination.

REP. SQUIRES stated concern that some children may not be able to pay for the burial of a parent. Mr. Morris stated then the county would pay.


REP. BROWN stated concern about people whose children can't pay for the burial and so the county would cremate them. There are people opposed to cremation; is there some way they could state their preference. Mr. Morris said the county would take the cheaper way which would be cremation.


Closing by Sponsor: SEN. WILLIAMS closed on SB 24.

obligation to indigent parents.

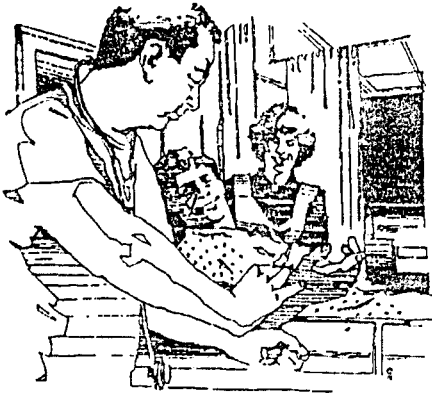
NOW THEREFORE BE IT RESOLVED that MACo seek added language
to §40-6-301 MCA to read: Duty of child to support indigent
parents. It is hereby declared and made the duty of every adult
child, having the ability so to do, to furnish and provide
necessary food, clothing, shelter, medical attendance, and burial
and interment costs for his indigent parent or parents, unless,
in the judgement of the court or jury, he is excused therefrom by
reason of intemperance, indolence, immorality, or profligacy of
such parent.

INTRODUCTION

In the fall of 1990, Governor Stephens appointed a number of working committees to address the problem of access to health care for the uninsured. The committee recommendations were submitted to the Governor in December of 1990.

Upon review of the Final Report, Governor Stephens personally committed to working on successful implementation of the five steps outlined in this summary. Because changing health care is an ongoing process, the final action step is a commitment of executive branch staff and financial resources to continuing the search for solutions to problems in the health care arena.

Governor Stephens believes these steps provide positive, appropriate direction for Montana in addressing the complex issue of health care access. They are not a total solution; just a beginning. Also, we must acknowledge that some changes are not possible in state because of the federal design of the Medicaid and Medicare programs. Potential changes in these programs await Congressional action.

(All committee recommendations are contained in the working committees' Final Report on Health Care for Montanans.)

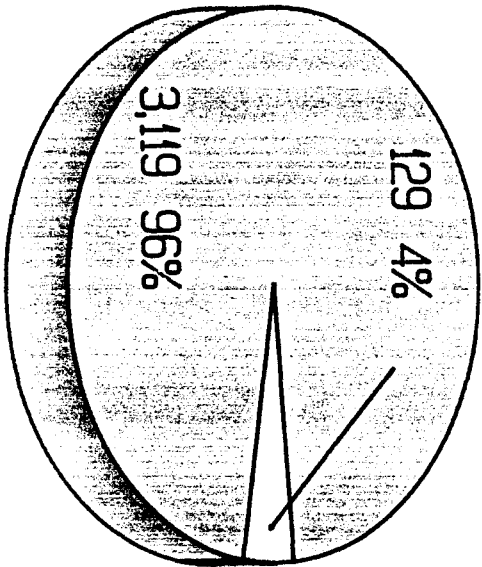

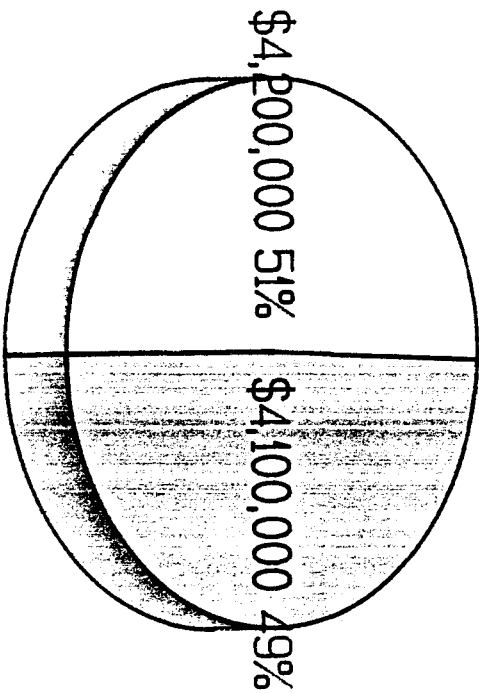
Total Infants On Medicaid FY 1988
