Announcements/Discussion: HB 411 was heard today. Economic development in Montana was discussed by several people.

#### HEARING ON HOUSE BILL 411

### Presentation and Opening Statement by Sponsor:

REP. MIKE KADAS, HD 55, Missoula, sponsored this bill at the request of the Legislative Audit Committee. It is an Act to make permissive the reports common carriers of beer and cigarettes file with the Department of Revenue; and amends Sections 16-3-235 and 16-11-104, MCA. Reports on the products carried by railroads and motor carriers transporting beer and cigarettes manufactured out of state and brought into Montana are mandated for each

month. This bill will make those reports permissive rather than mandatory. The information on the reports can now be obtained from other sources.

Proponents' Testimony: John Northey, Legal Counsel for the Office of the Legislative Auditor, explained under present law the report is mandatory. The Department wants to be able to receive these reports if they desire to do so, but since the information is already available from other sources, it does not have to be mandatory. HB 411 will change the requirement for the reports from mandatory to permissive.

REP. BOB PAVLOVICH, HD 70, Butte, supports HB 411. He serves on the Audit Committee and they all agreed this is an acceptable change. REP. KADAS agreed to carry the bill for the Committee.

Closing by Sponsor: REP. KADAS closed.

## EXECUTIVE ACTION ON HOUSE BILL 411

Motion/Vote: REP. PAVLOVICH moved HB 411 DO PASS. Motion carried unanimously. Wine had not been included in HB 411 so REP. PAVLOVICH moved to reconsider HB 411. This motion was unanimously adopted. Reconsideration will be taken February 5, 1991.

VICE CHAIR REP. SHEILA RICE took over as Chairman. She introduced Chuck Brooks, Director, Bob Heffner, Chief Administrator for Economic Development, and Rick Jones, Relocation Officer, all from the Montana Department of Commerce, who presented information on the economic small business development strategy of this administration which is focussed on nurturing and helping the growth and expansion of existing Montana Businesses.

Butch Ott, President of the Billings Chamber of Commerce; and Janet Seagrave, High Plains Development Authority, Inc., Great Falls, presented information on economic development in Montana and answered questions from the Committee. EXHIBIT 1
