### **HEARING ON HJR 47**

### Presentation and Opening Statement by Sponsor:

REPRESENTATIVE VICKI COCCHIARELLA, House District 59, Missoula, presented HJR 47 in place of sponsor, R. BUDD GOULD, House District 61, Missoula, saying the resolution honors the University of Montana Grizzly basketball teams. The Lady Grizzlies have been the Big Sky Conference Champions for three consecutive seasons and the men won the Big Sky Conference this year. The teams will be visiting the Legislature on April 9, 1991 and passage of this resolution is urged.
