Please Note: These are summary minutes. Testimony and discussion are paraphrased and condensed.

Announcements/Discussion:

Rep. Driscoll discusses Chairs ruling on House Bill 795. What constitutes final action on a House bill? Is it upon passage of third reading or is it when it comes back from the Senate with Senate amendments? Following rules are discussed: H40-120, H40-220(2), H50-150(7), H50-150(9).

Rep. Mercer: Based on H50-150(7) A motion to approve a bill to appropriate the principal of the coal trust fund needs three-fourths of each house. This bill did not receive a 3/4 vote of this house. The argument made on the floor is that this is not the final passage, but these are specific rules that we have in the House and a bill can not proceed unless it satisfy those things. We could do this for every bill that does not make it through the House.

Rep. Harper: Look at H40-120 to see that it needs only a majority vote to proceed with action.

Rep. Mercer: This bill needs a 3/4 vote to leave the House. Why would you need this rule if any coal bill could simply go over to the Senate on a simple majority? The bill has failed as

a matter of law if it does not get the 3/4 vote. This is a House rule.

Rep. Harper: Reads H40-220(2).

Rep. D. Brown: H40-120 was put in the 1985 session to clear up final vote and last action of that body.

Rep. Swysgood: Concerning H40-220(2) we still have to go back to H50-150(7) because we are dealing with a question that requires more than a majority vote. Regardless of it going to Senate or not. The final approval out of the House requires a 3/4 vote.

MOTION by Rep. Kadas: I move Rules Committee up hold the ruling of the Chairman that House Bill 795 pass with a majority of the House.

Motion <u>CARRIED</u> Reps. Driscoll, Harper, D. Brown, Darko, Kadas, Russell and Strizich voting yea. Reps. Grinde, Mercer, J. Rice and Swysgood voting nay.
