Opening Statement:

REP. STANG presented the bill, which requests that Revenue Oversight study all aspects of tribal taxation in Montana.

Proponents:

Jim Halverson, Roosevelt County Commissioner, spoke in favor of the bill. Revenue Oversight should be able to provide information to legislative bodies and Montana citizens concerning reservation taxes. This session saw three bills raised regarding tribal and reservation tax policies: SB 415, SB 428 and SB 464.

REP. ELLISON and REP. HARRINGTON spoke in favor of the bill.
