Please Note: These are summary minutes. Testimony and discussion are paraphrased and condensed.

Announcements/Discussion:

Chairman Bengtson clarified to visitors and witness the need to identity themselves each time they address the committee to aid the secretary in taking accurate minutes.

The committee was going to take Executive Action on SB-25 if Cort Harrington of the County Treasurers Association supplied the figures of the dollars involved in this bill. These figures were not available yet, so Executive Action will be taken at a later date.

Discussion:

Senator Bengtson reported that Connie Erickson had drafted amendments to SB-10 to correct the problems in language discussed earlier. Also, the two Representatives, Bob Gould and John Scott, along with their co-signers, have agreed to add their names to SB-10 after the bill is amended to include Emergency Response Equipment and drop any and all mention to Fire Service Areas. The amendments will be heard, but no Executive action will be taken until the questions about the bonding issue can be addressed. Alec Hanson will get the opinion of the Bond Council and then will confer with Senator Bengtson about this issue. HEARING ON SB-35

Presentation and Opening Statement by Sponsor:

Senator Weeding, from District 14, sponsored SB-35 that is a request from cities and counties to allow County Attorneys to act as the legal advisor to a Hospital District. A district is formed by referendum, and voted on by the people. The hospital board is elected officials, and so they should be allowed representation by the County Attorney, but it is not clear.

Proponents Testimony: Gordon Morris, Executive Director, (Montana Association of Counties (MACo), representing 55 of the 56 counties spoke on behalf of SB-35. Across the state, the action of County Attorneys representing Hospital Districts is fairly common, but this would make it law that they must act as legal advisors. This bill is supported by MACo east, west, north and south, and so he recommends this bill do pass, and be placed on the Consent Calendar.

Opponents Testimony: none

Questions From Committee Members:

Senator Eck asked Mr. Morris if there could conflict of interest cases between County Commissioners or city or town? Mr. Morris stated that County Hospitals are a county entity falling under the general powers of the County Commissioners. They do not due business with municipalities, so there would never be the case where the County Attorney is representing a city or town against a hospital district. Senator Eck asked about the Conservation District (page 1, line 24). Mr. Morris stated that Conservation Districts are independent entities outside the county. There would be no conflict of interest. No overlapping authorities.

John Connors, The Attorney General's Office, County Prosecutors' Services Bureau (CPSB), which provides training and trial assistance to the county attorneys in Montana. Senator Eck's question always faces county attorneys where they are faced with representing conflicting parties in the county. What happens in those incidents if the county commissioners have a conflict with another board the county attorney recommends that the other board retain other legal counsel? The first priority of the county attorney is to represent the board of County Commissioners. This is not stated in the law, but has been generally the case. County attorneys do not want the added work, but feel it is the Legislature job to decide if these duties should be imposed upon county attorneys, and if so, then they will try to meet them the best that they can. They do not oppose the bill.

Senator Eck asked if the wording "unless legal action involves County Commissioners" was the best. Mr Connor thought "conflicts with the interests of the county" would be more precise.

Senator Beck wanted to know if this meant more work for the

county attorneys considering the liability exposure that hospitals do have? Would county attorney have the prerogative to give legal advise to hire other legal counsel with expertise in the matter? Mr. Connor said there are provisions in the law that allow county commissioners the option of obtaining outside counsel, beyond the county attorney.

Senator Harding asked Mr. Morris to give his opinion as to how the county commissioners in the state feel about the extra workload for the county attorneys. Mr. Morris stated that there are only 24 Hospital Districts are in Montana. They occur in small rural counties, and some like Choteau, have 2 districts. They provide hospital service were there is no private service available. It is relatively isolated, and the problems that hospital districts are facing are primarily related to issues of budgetary and civil matters that are of concern to the hospital board. Would this increase the county attorneys budget as part of the county general fund? County Attorneys could make the case for more funds if they felt there would be significant increase in the workload. The commission in those locations would be wise to increase funds, but Mr. Morris did not feel this would be the case. Hospital Districts right now are pleading for legal assistance, and as public bodies, they should be able to turn to the county attorney for the purpose of the first request. Then, as Mr. Connor stated, possibly be directed to seek other counsel with legal expertise concerning the issue. County Attorneys will not be involved in malpractice suits because those matters involve insurance companies, and the insurance company will provide the legal counsel in those cases. The local political climate, the local financial considerations, and the local administration of the hospital are the matters that would be covered in this legislation.

<u>Closing by Sponsor:</u> Senator Weeding closed by stating that this bill was requested by County Commissioners in his district, and they are not concerned with overloading their county attorneys or overruns in the budget. His personal experience is that county attorneys are providing this service in most areas, but the service should be available to all hospital districts. Senator Weeding asked for a do pass on this bill, and would agree to having it placed on the Consent Calendar if unanimous.

EXECUTIVE ACTION ON SB-35

Motion: Senator Thayer moved that the motion do pass.

Discussion: Senator Harding thought if she had a hospital district she would certainly need to call the county attorney. Senator Beck, whose district does have a hospital district, did not have any problem. Mr Connor said most county attorneys are already providing this service to hospital districts.

FIRE DISTRICT AND FIRE SERVICE AREA BOND ISSUANCE	

Legislative Request #91L-07 January 10, 1991

INTRODUCTION

Senate Bill # 10 currently before the 1991 Legislature proposes allowing fire districts and fire service areas to sell bonds to provide funds for the purchase and maintenance of fire equipment and facilities. The bill would allow bond issuance up to a maximum amount not to exceed 18% of the taxable value of the property in the fire district or the fire service area.

EXAMPLES OF BOND ISSUANCE LIMITS

The following are examples of bond issuance limits that would result from application of the 18 percent maximum for a sample of fire districts.
