#### **HEARING ON HOUSE BILL 52**

#### Presentation and Opening Statement by Sponsor:

Representative Jerry Nisbet, House District 35, Great Falls, Black Eagle, stated that House Bill 52 is introduced at the request of the Teachers' Retirement Board. The purpose of the bill is to clarify certain administrative provisions of the Teachers' Retirement System relating to the payment of administrative claims purchasing additional service based on PERS membership credit and eligibility for disability benefits. Section 1 of the bill allows individuals transferring PERS membership credit to the Teachers' Retirement System to purchase 1 year additional service for each 5 years of membership service. Section 2 will delete the statutory requirements for 2 signatures on all Teachers' Retirement System administrative claims, which is no longer necessary or practical under the SBAS on line edited

entry system. Section 3 would allow an inactive member, who has been continuously disabled, to apply for disability benefits from the time they cease to be an active member.

## Proponents' Testimony:

David Senn, Executive Secretary, Teachers' Retirement Board, stated this is a general clarification of the Teachers' Retirement System. It does not enhance or enact any new benefits. Section 1 outlines purchase of additional services needed administrative clarification. Last session legislation was passed to allow teachers to purchase 1 year additional service for each 5 years of service. This purchase is only used in the calculation, the member pays the entire cost of the purchase so there is no fiscal impact on the System. They do have some members who start out in the Public Employees Retirement System and transfer to the Teachers' Retirement System. Section 2 strikes an obsolete requirement for 2 signatures on warrants. With the SBAS in the State Auditor's office preparing the warrants electronically, the signature isn't necessary. are checks and balances within the SBAS system on line edit entry to authorize and approve administrative claims. Section 3 clarifies the eligibility for disability retirement requirements.

#### Questions From Committee Members:

Senator Blaylock asked if this legislation impacted actuarial soundness in any way? Mr. Senn said it does not impact that in any way.

Senator Anderson asked how long does a teacher have to teach before drawing retirement? Mr. Senn answered that you have to have a minimum of 5 years and be at least age 50, then you can qualify for disability. Full benefits are paid at age 60 with 5 years or any age with 25 years service. Disability is being clarified to say that with 5 years service you can have disability at any age.

#### Closing by Sponsor:

Representative Nisbet closed the hearing and asked Senator Blaylock to carry House Bill 52 to the Senate floor.

#### **HEARING ON HOUSE BILL 80**

# Presentation and Opening Statement by Sponsor:

Representative Jerry Nisbet, House District 35, Great Falls, Black Eagle, said House Bill 80 would allow a person to make up salary that was lost due to a temporary absence. The lost salary now has an impact on a persons retirement and currently there is no provision to buy lost salary. The law does provide for buying back lost time, leave, service in other states, military time, etc. If a person wishes to buy the lost salary 2 provisions apply, 1. it is limited to the salary that one would have received except for the temporary absence (Page 5, lines 1 and 2) and 2. The required contribution be made to the Teachers' Retirement System (Page 1, lines 11 through 18). This change is actuarialy sound because the cost is carried by the teacher buying the salary.

# Proponents' Testimony:

Phil Campbell, Montana Education Association, supports House Bill 80 because it allows people who have a temporary absence from work and happen to be in their last few years of teaching and they lose salary due to a temporary absence. This would allow them to purchase that salary back so that the calculation of their average salary on which their retirement benefits are computed, would be greater. The cost is 5.7% of the salary that they have lost times the number of years in the system. Currently you can buy the time back so that you don't lose out on years of service and this will allow buying back lost salary. There is no fiscal impact to the general fund budget. This is an incredibly expensive opportunity for a member of the System.

Teresa Reardon, Montana Federation of Teachers, supports House Bill 80.

David Senn, Teachers' Retirement Board, explained that the member paying the full cost is actually buying a life time annuity. There is no risk to the retirement system and there is no risk to the individual buying the salary.

# Questions From Committee Members:

Senator Hockett confirmed that the retiree would pay all costs? Mr. Senn answered that is correct.

Senator Blaylock asked if you are already retired can you go back and buy that salary? No, that's not possible.

Senator Rea asked if there is restrictions about the person who is dismissed and then reinstated, is there discrimination there? Usually when they are reinstated they are made whole. Several examples were given.

Senator Vaughn asked if this increases the amount of money they have in their account to figure their retirement? The computations is on time and salary in the last 3 years of employment. This gives them the opportunity to put in the salary they may have missed due to absence.

#### Closing by Sponsor:

Representative Nisbet closed and asked Senator Blaylock to carry House Bill 80 to the Senate floor.

appointment is redundant because of the proposed legislation to change the Highway Department to the Transportation Department. Senator Vaughn said all of this will come out in the hearing we'll schedule. Senator Pipinich said they contemplate Mr. Rothwell's appointment would be about 6 to 8 months long.

#### **RECOMMENDATIONS AND VOTES:**

The VOTE was UNANIMOUS to add John Rothwell's name to the resolution. Attorney Niss will do this. Senator Pipinich will review his resume.

Chairperson Vaughn said the resolution has been drawn. We'll add this name to it. It will go through the bill drafting process, get a number, have a public hearing and we'll act on it.

#### **BOARD APPROVALS**

Chairperson Vaughn explained that we have been given 55 different Boards' appointments, which amounts to about 175 names, to approve. When one of you have finished examining a boards' candidates, please bring it to committee and we'll act on that particular board. Thus the work will be spread out. Then a Committee Resolution will be written, public hearing set, and action taken.

Senator Blaylock suggested that a bill be proposed to eliminate Senate approval of board appointments. The process a board member goes through and the legal requirements they must meet are carefully adhered by the Governor's office, and the group of people they represent. So there is no real need to have Senate approval. He believes Department heads should remain in the Senate approval process. He will talk to Senate leadership about this and report back to committee.
