Announcements/Discussion:

#### **EXECUTIVE ACTION ON SENATE BILL 205**

#### Motion:

Senator Towe moved adoption of the amendments in Exhibit #1.

#### Discussion:

Senator Eck referred to the proposed amendments in Exhibit #1. She said there are times when we will want to recognize the activities of developmental disabilities and she said this amendment takes care of that.

Senator Towe asked about inserting the language in a different area of the bill.

Senator Eck said what they are worried about is the cooperative agreement.

#### Amendments, Discussion, and Votes:

There being no objection the motion carried.

#### Recommendation and Vote:

Senator Pipinich moved to pass SB 205 as amended. There being 7 ayes and 0 nays the motion carried.

### EXECUTIVE ACTION ON SENATE BILL 326

#### Motion:

Senator Towe moved adoption of the amendments in Exhibit #2.

#### Discussion:

Senator Towe reviewed the amendments in Exhibit #2.

Senator Jacobson suggested leaving in the language pertaining to the parents of emotionally disturbed children.

Senator Eck said that is probably included in 'b' of the bill.

Senator Towe said they are covered as family members of severe and disabling illnesses. He said he thought emotional disturbances may be one thing, but it is different than a disabling mental illness.

Senator Pipinich said we should leave in the language regarding parents of children with disabling illnesses. He said he has been involved with a couple of families with these problems. He suggested leaving 'c' in the bill.

The chairman recognized the sponsor of the bill, Senator Mignon Waterman for her comments.

Senator Waterman said she understood Senator Towe's reasoning but she agreed with Senator Pipinich in that the parents should be left in. They have unique concerns as parents with children suffering from emotional disturbances. She said there is also a place for a health care professional or an advocate, especially for the elderly as noted in section 'd'. She said she would not like to leave these two categories out of the bill.

#### Motion:

Senator Towe withdrew his motion to adopt the amendments in Exhibit #2 and moved adoption of the language in Exhibit #3.

## Amendments, Discussion, and Votes:

There being no objection the motion carried to adopt the amendments denoted in Exhibit #3.

#### Recommendation and Vote:

Senator Towe moved to pass SB 326 as amended. There being 1 nay by Senator Rye and 6 ayes the motion carried.

#### EXECUTIVE ACTION ON SENATE BILL 348

#### Motion:

Senator Towe moved adoption of the following language: on page 4, lines 24 and 25 following the word 'person' on line 24 strike "required to report" and insert "or agency receiving a report of".

#### Discussion:

Senator Towe said this language would mean that the recipient must file the report.

#### Amendments, Discussion, and Votes:

There being no objection the amendment was adopted.

Senator Towe suggested the committee not take final action on the bill pending another amendment to be submitted by the Department of Family Services.

#### EXECUTIVE ACTION ON SENATE BILL 200

#### Motion:

Senator Towe moved adoption of language on page 1, line 11 following line 10, inserting language that would allow the board of hearing aid dispensers authority to include rules defining the term 'related devices', add a statement of intent and rulemaking authority and add the necessary language to the title of the bill. Included in his motion was adoption of the amendments in Exhibit #4 and language in the statement of intent that specified what should be included under the term "related devices".

#### Discussion:

The chairman called upon Tom Gomez to explain the amendments denoted in Exhibit #4.

Senator Jacobson asked what the term 'related devices' referred to.

Senator Pipinich said the hearing aids are inserted in the ears. He said the one he wears on the Senate Floor is a device. Mr. Havdahl using a hearing detector. The term 'devices' needs to be included because their are other objects used besides the hearing aids inserted into the ear.

The chairman recognized Tom Gomez who suggested the committee may want to consider adding to the statement of intent language that specified what should be included under the term "related devices".

#### Amendments, Discussion, and Votes:

There being no objection the motion carried.

#### Motion:

Senator Hager moved adoption of an amendment on page 2, line 17 strike the words, 'at all times'.

#### Amendments, Discussion, and Votes:

Senator Towe suggested deleting the language on page 2, lines 12 through 17.

Senator Franklin said she agreed that putting an employee in the place of business at all times seemed to be hysterical. She said she was sure it came out of concern about problems from fly-by-night dispensers. She asked if the committee would feel comfortable just inserting a period (.) on line 17 after the words 'place of business'.

Senator Eck said the reason was because the consumers want a permanent place where they can go and find a place of business.

Senator Towe suggested adopting language that would require licensed hearing aid dispensers and trainees to have a permanent place of business.

Senator Hager said this group of business people need direction. He said there were 147 complaints.

Senator Pipinich suggested striking the language on page 2, line 17, 'at all times'.

There being no objection Senator Hager's amendment was adopted.

Senator Rye said he wears a hearing aid in noisy rooms. He said he does not wear it very often. It was sold to him by a dispenser and he said he has had very good service with it and was happy with it's performance. He said he lost 25 percent of his hearing in Viet Nam. He said his aid was sold by the kind of people this bill is aimed at and that he has been satisfied with the device. He said he thinks this bill is a restriction of business competition to some degree. He said he would vote 'no' on the bill.

Recommendation and Vote:

Senator Franklin moved SB 200 do pass as amended. There being 1 nay and 6 ayes the motion carried.
