EXECUTIVE ACTION ON HOUSE BILL 46

Motion:

Senator Thayer moved to amend HB 46 by deleting section
four, and deleting section five, sub three.

Senator Kennedy moved HB 46 be concurred in.

Discussion:

Senator Lynch stated that he had asked Representative Scott McCulloch and Doug Mitchell from the secretary of state's office to come, because these were some of the parties that were involved with the bill. He stated that he would like to hear from all parties involved why we need the bill. This is not a hearing, it is executive session.

Representative Scott McCulloch, house district 96, stated that he was the chair of the subcommittee that met with the secretary of state's office to try to come up with some kind of

compromise. Representative Galvin brought it to his attention that this would cost forty thousand dollars, that was not the intent of the subcommittee. They could turn it over to the secretary of state and spend about seventy six thousand dollars. They chose as a subcommittee to go with Mr. Heffner's recommendations. The sustenant changes are on page nine, line three at the top of the page. If we would have anticipated any costs, then it would have been the subcommittee's recommendation to direct it to the secretary of state's office. We wanted this done without any additional costs, and without any additional FTE's.

Senator Lynch asked if Bob Heffner was the person who mentioned the forty thousand dollar figure.

Bob Heffner replied yes. Initially a fiscal note was attached to the bill, before it was so drastically revised, in the order of seventy to ninety thousand dollars. The fiscal note is no longer relevant. We pointed out that many of the responsibilities, or much of what was called for in the bill, was already discussed in existing law. A full scale study is called for here. If all you want is a ten page report from Becky telling you what she did on this, that's free. If you want a thorough study of licensing throughout state government, a study of how to optimize the whole process licensing without calling an industrial process analysis, they can come back to you with an answer to the question, do we need, or should we consider something like a centralized computerized licensing system, and if so, what would it look like, that would cost. We would definitely have to hire a consultant to do that, Becky is not qualified to do that.

Senator Lynch stated that as he reads section thirteen, it is up to the department what extent you are able to go. What he would like to see is when Becky goes through her normal process, if she can see ways to report back to us on how you might one stop shop. He asked that Mr. Mitchell, from the secretary of state's office comment on one stop shop.

Doug Mitchell, chief deputy of the secretary of state's office, stated that our involvement in this bill stems from our interest in streamlining bureaucratic red tape. The basis of this bill now, is the small business licensing coordination center that is in statute, and has been there for a couple of years now, that law provides the first four sections on page seven, section three, beginning on line fourteen. That section states that the department document, and make certain recommendations regarding business licensing and the elimination of duplicated forms. This bill seeks to add section thirteen, that simply provides a perimeter within which the department will report on. They already have the requirements to document and recommend, but this provides a date in which they will document and recommend.

Senator Lynch asked where are there not one stop shops.

Doug Mitchell replied currently when you want to start a business, you start getting bumped from one agency to another. The legislative intent of this bill is in places where the information you provide is the same, can we shorten licenses.

Becky Baumann, the business licensing specialist in the state representing the department of commerce, stated usually when a business calls their city official, the city official will give them the local requirements, and then send them to her office. If by chance, they are starting out on a different route, checking with revenue, or the secretary of state, they are eventually tied back to her. She has started business kits that she sends to the libraries, and the chamber of commerce, schools, and universities, so they are getting the word out more and more that she is available to them. Out of state people do not know that she exists.

Senator Lynch stated that he understands that Becky is neither an proponent nor an opponent. Would she be able to report back to the committee in two years that would help in any way to improve this.

Becky Baumann replied absolutely.

Senator Noble asked how many complaints does the department of commerce get regarding this problem.

Becky Baumann replied that she receives very few complaints.

Senator Thayer stated that Becky mentioned that she has made recommendations to various departments, some of them have agreed to them and implemented them, and others haven't. Which departments aren't responding to her recommendations.

Becky Baumann replied that the secretary of state's office were not responding to her recommendations.

Doug Mitchell, representing the secretary of state's office, stated that he was not aware of the specific changes that Becky has recommended. One of the things that all agencies have a problem with, is that we have certain statutory requirements regarding what information needs to be provided, and a lot of that is duplicated. We need to find administrative time, as does commerce, to try and make recommendations to try their best to do that.

Senator Thayer stated that this other bill that set up the one stop business just went into effect in 1987. There are very few complaints because of it, the other agencies are starting to reroute the people to the one stop service to Becky. The thing is working, the department's already said that they are willing to give a report back to the committee. He probably could have supported the bill if they had deleted section four, but now he will oppose the bill.

Senator Noble stated that over the years he has applied for many licenses, and he has never had trouble. It seems silly to legislate something that there is no problem with.

Senator Lynch asked what could get hurt. If it even does a little bit of good, at no cost, he would like a report back.

Senator Kennedy stated that we have a legislative responsibility to see that we can do things better.

Amendments, Discussion, and Votes:

Senator Thayer asked if the committee needed to put in the bill that this would be at no additional expense.

Senator Lynch stated if the committee doesn't put in any money, there won't be any additional expenses.

The motion by Senator Thayer to amend HB 46 by deleting section four, and deleting section five, sub three failed 4 to 3 votes.

Recommendation and Vote:

The motion by Senator Kennedy that HB 46 be concurred in passed 5 to 4 vote. Senator Kennedy will carry the bill to the floor.

EXECUTIVE ACTION ON HOUSE BILL 196

Motion:

Senator Kennedy moved to amend HB 196 by including small businesses with one member.

Senator Kennedy moved HB 196 be concurred in as amended.

Discussion:

Bart Campbell explained the gray bill to the committee (See Exhibit 1). A recommended change by Senator Gage on page two of the gray bill, paragraph D was made to read three members representing the indian tribe of this state, nominated by either the intertribal policy board, which is a private group representing the tribes, or nominated by the coordinator of indian affairs.

Senator Gage stated that he felt the coordinator of indian affairs should nominate a member, because he wasn't sure how stable of an organization the intertribal policy board is.

Bart Campbell asked if that is a state agency.

Senator Gage stated it is a state agency, and a person appointed by the governor.

Senator Lynch asked if the tribes would resent the fact that indirectly the governor gets all of their appointments.

Senator Gage stated that maybe they should put "after consultation with the tribes", or "as recommended by the tribes".

Representative Kilpatrick stated if the tribes are going to put in money, they may want a say on who is going in.

Senator Lynch stated that maybe the tribal counsel should nominate instead of the coordinator of indian affairs.

Senator Gage stated that it would be fine if we said "by the seven tribal counsels".

Senator Lynch stated that they would put that in under page two of the amendments.

Senator Bruski stated that there is one big segment that is not in this, and that is small business.

Senator Noble stated that he is not sure that the small businesses want to come in and pay forty five thousand dollars

just to be represented on the board.

Senator Lynch stated that he is not sure that they would have to. The only ones paying are going to be the labor organizations, the conservation groups, the tribes, and the state of Montana.

Bart Campbell stated 2A would be included in those who pay the twenty five thousand dollars. 2A is the three members representing business interests. The way that the amendment indicates is that twenty five thousand be paid by the business, by the labor, by the conservation, and by the indians.

Senator Bruski stated the big business would pay, not the small businesses.

Bart Campbell stated that was correct, the three members representing business entries nominated by statewide organizations in 2A. They would be required to put in twenty five thousand.

Senator Lynch stated they could put in the definition of small business under 2A.

Bart Campbell stated that he could insert a new section i. for small businesses.

Amendments, Discussion, and Votes:

The motion by Senator Kennedy to amend HB 196 by including the small businesses passed unanimously.

Senator Thayer stated that this bill in is here like value added is a new word. As long as he has been involved in economic development, everybody has been supportive of, and anybody that's looking at things to get involved in, look at trying to see what we can do to value add our resources in Montana. You can appoint committees and studies forever, and what is really going to help economic development in this state is what we do with our tax policy.

Recommendation and Vote:

The motion by Senator Kennedy that HB 196 be concurred in as amended passed 5 to 4 vote. Senator Lynch stated that he would carry the bill to the floor.



A BILL FOR AN ACT ENTITLED: "AN ACT TO ESTABLISH THE MONTANA
LEGISLATIVE ECONOMIC DEVELOPMENT AND VALUE-ADDED PLANNING
COMMISSION; TO EMPOWER THE COMMISSION TO CREATE AN ECONOMIC
DEVELOPMENT AND VALUE ADDING PLAN FOR SUBMISSION TO THE 53RD
LEGISLATURE; TO PROVIDE AN APPROPRIATION AND AUTHORIZATION FOR
EXPENDITURE CONTINGENT ON PRIVATE CONTRIBUTIONS; AND PROVIDING AN
IMMEDIATE EFFECTIVE DATE DATES AND A TERMINATION DATE."

WHEREAS, Montana is in economic difficulty and needs to
create economic growth; and

WHEREAS, the existence of a formal state economic
development plan is essential to creating economic growth; and

WHEREAS, a plan in order to be valid, must reflect a
consensus of the main economic groupings of the private sector,
legislative branch, executive branch, and economic development
professionals; and

WHEREAS, experts in economic development have emphasized
that the State of Montana adds little value to the state's basic
commodities before exportation; and

WHEREAS, adding value to products in Montana can create new
jobs and increase profits.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. SECTION 1. DEFINITION. AS USED IN [SECTIONS 1
THROUGH 3], UNLESS THE CONTEXT CLEARLY REQUIRES OTHERWISE,
"COMMISSION" MEANS THE MONTANA LEGISLATIVE ECONOMIC DEVELOPMENT
AND VALUE-ADDED PLANNING COMMISSION ESTABLISHED IN [SECTION 2].

NEW SECTION. Section 2. Montana LEGISLATIVE economic
development and value-added planning commission -- composition --
duties -- terms -- meetings -- reports. (1) There is a Montana
LEGISLATIVE value-added commission within the department of
commerce.

(2) The commission consists of 18 members, including:

(a) Three members representing business interests and
nominated by statewide organizations of value-adding industries
including:

wood products,
oil and gas,
coal mining,
metal and nonfuel mineral mining,

livestock, including cattle and sheep, AND
grain producers;

(b) Three members nominated by statewide labor organizations representing workers in the construction, retail, industrial, public, and service sectors;

(c) Three members of organized conservation groups nominated by statewide organizations representing water, air, land, and agricultural conservation and other environmental concerns;

(d) Three resident members representing the Indian tribes of this state appointed by the committee on indian affairs established in 5-19-102;

(e) one member FROM THE GOVERNOR'S NOMINEES from the university research and development programs within the university system;

(f) One member from the governor's nominees from the tourism industry;

(g) ONE MEMBER SPECIALIZING IN ECONOMIC DEVELOPMENT FROM the department of commerce NOMINATED BY THE GOVERNOR;

(h) Two members who are full-time economic development professionals nominated by local economic development corporations;

(i) FOUR MEMBERS OF THE LEGISLATURE, INCLUDING:

(I) TWO MEMBERS OF THE HOUSE OF REPRESENTATIVES, INCLUDING ONE MEMBER OF EACH PARTY, APPOINTED BY THE SPEAKER OF THE HOUSE; AND

(II) TWO MEMBERS OF THE SENATE, INCLUDING ONE MEMBER OF EACH PARTY, APPOINTED BY THE PRESIDENT OF THE SENATE.

(3) THE SPEAKER OF THE HOUSE AND THE PRESIDENT OF THE SENATE SHALL JOINTLY APPOINT THE MEMBERS OF THE COMMISSION PROVIDED FOR IN SUBSECTIONS (2)(A) THROUGH (2)(i) AFTER CONSULTATION WITH THE MINORITY LEADERS OF THE HOUSE AND THE SENATE.

(4) THE COMMISSION SHALL DEVELOP A CONSENSUS OF THE VARIOUS GROUPS REPRESENTED ON THE COMMISSION IN REGARDS TO DEVELOPMENT AND PREPARATION OF A STATE ECONOMIC DEVELOPMENT PLAN FOR MONTANA. THE PLAN SHOULD:

(a) BE CONSISTENT WITH THE STRATEGIC PLANS AND ECONOMIC DEVELOPMENT PLANS OF THE CITIES, TOWNS, COUNTIES, AND REGIONS OF THE STATE;

(b) ADDRESS ALL SEGMENTS OF MONTANA'S BASIC SECTOR ECONOMY INCLUDING BUT NOT LIMITED TO, NATURAL RESOURCE VALUE-ADDING; MANUFACTURING, TOURISM, RESEARCH AND DEVELOPMENT, TECHNOLOGICAL BASED BUSINESS, COMMUNICATIONS, TRANSPORTATION, DISTRIBUTION, AND WAREHOUSING;

(c) ADDRESS ALL SOURCES OF ECONOMIC DEVELOPMENT CAPITAL;

(d) CONSIDER THE NEEDS OF BUSINESS AND WORKERS IN REGARDS TO EDUCATION, JOB TRAINING, VOCATIONAL EDUCATION AND APPRENTICESHIPS;

(e) ADDRESS THE STATE'S ECONOMIC INFRASTRUCTURE STRENGTHS AND DEFICIENCIES; AND

(f) RECOMMEND REVISION OF LAWS OR CHANGES IN POLICY TO OVERCOME OBSTACLES TO ECONOMIC DEVELOPMENT AS IDENTIFIED BY THE COMMISSION.

(5) MEMBERS OF THE COMMISSION SHALL SELECT A CHAIRMAN AND A VICE CHAIRMAN FROM THEIR MEMBERSHIP. THE COMMISSION SHALL MEET AT THE CALL OF THE CHAIRMAN OR AS A MAJORITY OF THE MEMBERS DETERMINE.

(6) A VACANCY ON THE COMMISSION MUST BE FILLED IN THE SAME MANNER AS THE ORIGINAL APPOINTMENT.

(7) THE COMMISSION SHALL SUBMIT IN WRITING TO THE 53RD LEGISLATURE A FINAL REPORT WITH RECOMMENDATIONS AND ANY PROPOSED LEGISLATION NECESSARY TO IMPLEMENT THE RECOMMENDATIONS.

(8) THE MEMBERS OF THE COMMISSION ARE ENTITLED TO COMPENSATION AND REIMBURSEMENT IN THE MANNER AND AMOUNT PROVIDED IN 5-2-302.

NEW SECTION. SECTION 3. STAFF ASSISTANCE -- COMMISSION SUPPORT. (1) THE LEGISLATIVE COUNCIL SHALL PROVIDE STAFF ASSISTANCE TO THE COMMISSION.

(2) THE OFFICE OF THE GOVERNOR, THE DEPARTMENT OF ADMINISTRATION, THE DEPARTMENT OF COMMERCE, THE DEPARTMENT OF HIGHWAYS, THE DEPARTMENT OF REVENUE, THE PUBLIC SERVICE COMMISSION, THE MONTANA UNIVERSITY SYSTEM, AND ANY OTHER AGENCY CONCERNED WITH ECONOMIC RESEARCH AND ECONOMIC DEVELOPMENT SHALL ASSIST AND COOPERATE WITH THE COMMISSION AS MAY BE REQUIRED FOR THE COMMISSION TO CARRY OUT ITS DUTIES.

(3) THE COMMISSION MAY CONTRACT FOR SERVICES NECESSARY TO COMPLETE ITS DUTIES UNDER [SECTION 2] WITHIN THE LIMITS OF THE APPROPRIATION AND THE EXPENDITURE AUTHORITY PROVIDED IN [SECTION 4].

NEW SECTION. SECTION 4. APPROPRIATION -- EXPENDITURE AUTHORITY CONTINGENT ON PRIVATE CONTRIBUTIONS -- REFUND OF UNEXPENDED CONTRIBUTIONS. (1) THERE IS APPROPRIATED TO THE LEGISLATIVE COUNCIL FROM THE GENERAL FUND \$25,000 TO BE EXPENDED AS PROVIDED IN SUBSECTIONS (2) AND (3) TO SUPPORT THE ACTIVITIES OF THE MONTANA LEGISLATIVE VALUE-ADDED COMMISSION DURING THE BIENNIUM ENDING JUNE 30, 1993.

(2) THE LEGISLATIVE COUNCIL MAY DISBURSE THE MONEY APPROPRIATED IN SUBSECTION (1) ONLY IF THERE IS DEPOSITED IN AN ACCOUNT IN THE STATE SPECIAL REVENUE FUND TO THE CREDIT OF THE COMMISSION BEFORE JULY 1, 1991 MATCHING CONTRIBUTIONS OF \$25,000 PROVIDED BY EACH OF THE PRIVATE SOURCES IDENTIFIED IN [SUBSECTIONS (2)(b), (2)(c), AND (2)(d) OF SECTION 2]; AND

(3) MONEY FROM THE GENERAL FUND APPROPRIATION IN SUBSECTION (1) MAY BE EXPENDED ONLY IF ACCOMPANIED BY AN EXPENDITURE FOR THE SAME PURPOSE THREE TIMES AS LARGE FROM THE ACCOUNT ESTABLISHED IN SUBSECTION (2).

(4) The department of commerce is directed to apply for economic development planning funds from the federal government, including the U. S. economic development administration, and shall deposit any funds received under this subsection after April 1, 1991, into the special revenue account established in [subsection 2].

(5) AN UNEXPENDED AND UNOBLIGATED BALANCE ON JULY 1, 1993, IN THE ACCOUNT ESTABLISHED IN SUBSECTION (2) MUST BE REFUNDED TO THE CONTRIBUTORS OF RECORD IN AMOUNTS IN DIRECT PROPORTION TO THE AMOUNTS CONTRIBUTED BY EACH.

NEW SECTION. SECTION 5. COORDINATION INSTRUCTION. IF

SENATE BILL NO. 164 IS PASSED AND APPROVED AND IF IT CONTAINS PROVISIONS INCLUDING THE DEPARTMENT OF HIGHWAYS WITHIN A DEPARTMENT OF TRANSPORTATION, THE CODE COMMISSIONER IS INSTRUCTED TO CHANGE "DEPARTMENT OF HIGHWAYS" IN [SECTION 3] TO "DEPARTMENT OF TRANSPORTATION".

NEW SECTION. Section 6. Effective date DATES --
TERMINATION. ~~{This act}~~ is (1) [SECTIONS 1 THROUGH 3, 5, AND THIS SECTION] ARE effective on passage and approval.




