## EXECUTIVE ACTION ON HOUSE BILL 781

#### Motion:

Senator Thayer moved to reconsider action on HB 781. The motion CARRIED.

# Amendments, Discussion, and Votes:

Jeff Martin presented amendments requested by Senator Halligan for consideration by the committee (Exhibit #1).

Senator Halligan moved adoption of the amendments. The purpose of the amendments is to add the language in which the legislature authorizes the activities and appropriates the funds for the activities (studies) and then the DHES can do the special assessment studies. Senator Halligan introduced the amendments in the hope that extensive floor fights could be avoided over the bill as it currently stands.

John Alke, MDU, said the cost of the study could possibly be as high as \$2 million for the biennium.

Senator Doherty asked why the language was stricken in the bill.

Mr. Alke said the difficulty with the area studies is the main problem. The pollution point may not be in the affected area.

Senator Thayer said this language ensures that DHES is not being given an open checkbook to circumvent the appropriation process.

The motion to adopt the amendments CARRIED.

# Recommendation and Vote:

Senator Thayer moved HB 781 Be Concurred In As Amended.

The motion CARRIED unanimously.

## EXECUTIVE ACTION ON HOUSE BILL 93

## Amendments, Discussion, and Votes:

Senator Harp moved HB 93 be amended as per Exhibit #2.

The motion CARRIED.

Senator Eck moved to adopt amendments as per Exhibit #3 which would include all medicaid providers in a 5% tax by July 1, 1993.

The motion FAILED with only Senator Eck voting aye.

Julia Robinson, Director, SRS, reminded the committee the bill needed to be amended to remove the sunset provision.

Senator Thayer moved to amend the bill by striking Section 23.

The motion CARRIED.

# Recommendation and Vote:

Senator Harp moved HB 93 Be Concurred In As Amended.

The motion CARRIED.

## EXECUTIVE ACTION ON HOUSE BILL 809

## Discussion:

Beth Baker, Department of Justice, said the bill would generate approximately \$160,000 per year to be used for a special revenue account to fund the Fire Marshall activities of the Department of Justice. The impact on the general fund would be \$100,000 per year after the tax appropriation is subtracted for a total of \$250,000 per year which would go to the Fire Marshall Bureau.

Senator Thayer expressed concern that the person buying insurance is going to end up paying for this.

Senator Doherty noted there has been no increase in this fund since 1911. The Fire Marshall needs the money to do the job.

# Amendments, Discussion, and Votes:

Senator Doherty moved HB 93 Be Concurred In.

Senator Gage made a substitute motion to amend HB 93 so that the tax revenue would to the general fund rather than the special revenue account.

The motion CARRIED.

#### Recommendation and Vote:

Senator Doherty moved HB 93 Be Concurred In As Amended.

The motion CARRIED with Senator Gage voting no.
