Committee Business Summary:

Hearing: HB 1

HEARING ON HOUSE BILL 1

Opening Statement by Sponsor:

Representative Zook, sponsor, said HB 1, commonly referred

to as the "feed bill" has increases in amounts, as well as health insurance. Governor Stephens recommended a \$20 increase in health insurance effective June 1994 and another \$20 in the first six months of fiscal year 1995. The calculation of retirement contributions has a potential for the state match in the amount of \$150,000. The mileage rate has been increased which is set at the rate allowed by the Internal Revenue Service the preceding year. Attache salaries were increased as a result of the pay plan and HB 509, as well as general operating expenses. An additional amount was required by the Legislative Auditor because of select committees appointed by the Speaker of the House.

Rep. Zook concluded that HB 1 was compiled by the leadership and by the Legislative Council and any questions could be directed to Bob Person of the Legislative Council.

Questions From Committee Members and Responses:

Senator Keating questioned if estimates of revenue projections were made two years ago.

Terry Cohea, LFA, said when a fund balance statement is prepared for the Legislature, \$5 million is traditionally included for the feed bill. She noted the fund balance statements that are driving the \$215.6 million deficit include the amount of HB 1 as well as the feed bill for the July special session.

Senator Keating questioned if HB 1 has a supplemental in that we are overspending what is anticipated.

Ms. Cohea said HB 1 is not appropriated until the appropriation is made, but in calculating the cost of state expenditures, historically a \$5 million estimate is made of what

the feed bill would cost, so this fulfills the estimate and is not a supplemental, but a traditional way of handling the feed bill.

Senator Jacobson said it was her understanding that the only new expenses in HB 1 are the \$20,000 being allotted to the legislative auditor which has to do with some computer runs that will be required by House select committees appointed by Representative Mercer.

Senator Swysgood questioned how much HB 1 is over the feed bill of the last session.

Bob Person, Legislative Council, said the percentage amount for HB 1 is 11.79 percent. He said the total last session was \$4,495,997 and this time it is \$5,026,230.

When questioned by Senator Jacobson if most of that increase has to do with benefits, Mr. Person said a large portion is the health insurance as alluded to by Rep. Zook.

Mr. Person distributed to the committee a copy of "HB 1 - Feed bill budgets summarized by responsibility center". (See Exhibit 1)

Senator Devlin questioned the figures in caucus and start-up in the House and Senate. He asked why the start-up costs for the House and Senate are similar when the House membership is much larger than that of the Senate.

Senator Jacobson said the House updated the voting board last session and the Senate is looking into purchasing that equipment this session. That is the main reason for the difference in the House and Senate figures, in that the voting board is \$125,000.

Senator Jacobson said with regard to start-up costs, much of that has to do with staff that began work before the legislative session started to prepare for the session. She noted her feeling that the staff size in the House and Senate is not considerably different. The actual travel costs of legislators is probably minimal in comparison to the start-up costs for bringing staff on board.
