EXECUTIVE ACTION ON SB 6

Motion/Vote:

Sen. Christiaens moved the amendments to SB 6. Motion carried unanimously.

Motion/Vote:

Sen. Franklin moved that SB 6 as amended DO PASS. Motion carried unanimously.

EXECUTIVE ACTION ON SB 7

Discussion:

Chairman Eck said there was discussion that SB 7 DO NOT pass, there was a petition put forth by several groups. (Exhibit #1)

Sen. Franklin said even if the amendments were accepted to SB 7, the number of people on the board is increased.

Sen. Towe asked how the board increased. Susan Fox, Legislative Council, said the amendment as submitted would add parents of children with emotional disturbances under Sub A, which would keep the increase to the board.

Sen. Towe asked if there was a suggestion that the category of family members of persons with severe and disabling mental illness does not include parents of children with emotional disturbances. Sen. Eck said that there was no testimony concerning this, but it was suggested that parents of children with emotional disturbances fit better with the other group. If we did that, it would mandate one other person to the board, and there would be objection.

Sen. Franklin said adding parents of children with emotional disturbances would limit serving family members of persons with severe and disabling mental illnesses.

Sen. Towe asked if family of persons with severe and disabling mental illness were covered by the category of emotional disturbance. Sen. Franklin said that it would not be.

Sen. Franklin asked about the legal definition of emotional disturbance. Kathy McGowan said "emotionally disturbed" is a reference to children whereas "seriously mentally ill" is in reference to adult. Ms. McGowan said putting these two categories together would really upset the Montana Alliance for the Mentally Ill.

Motion:

Sen. Franklin moved that SB 7 DO NOT PASS.

Discussion:

Sen. Towe said he wanted to hear more discussion. He was opposed to adding members to the board, but if the Committee took amendment 5, to add a fourth category and one person must be chosen among those four groups instead three groups. This does not add anyone to the board. That would satisfy Dave Cunningham's concerns. He would like to hear comments of the others. Sen. Klampe said it sounded good.

Chairman Eck said that even a fourth category were added, groups like the Rimrock Foundation would never be named to the board.

Sen. Towe said that the Rimrock Foundation wouldn't be named, but individuals like Marion Dozier who spearheaded this legislation and who had been a city council member would be appointed to the board. They would not feel locked out if they were one of the options.

Substitute Motion:

Sen. Towe moved that Amendment 5 be adopted, and change the word "three" to "four" on line 12.

Discussion:

Susan Fox said there would be adjustments to reflect that change. It would be "three members at large" and then "two members must be chosen" from Sub A.

Sen. Towe went through the amendments.

<u>Vote:</u>

Motion carried unanimously.

<u>Motion/Vote:</u>

Sen. Towe moved that SB 7 DO PASS as amended. Motion carried unanimously.

Sen. Towe said if Sen. Nathe changed SB 7 to the original form on the Floor of the Senate, Sen. Towe would oppose SB 7.

EXECUTIVE ACTION ON SB 34

Chairman Eck turned the Chairmanship over to Sen. Eve Franklin for executive action on SB 34.

Discussion:

Susan Fox, Legislative Council, explained the amendments offered by Fred Fisher of the Board of Crime Control which would an additional member to the coordinating council, so both the Attorney General and the Administrator of the Board of Crime Control would have a spot on the council.

Sen. Towe and Susan Fox discussed the amendments. (Exhibit $\# \hat{g}$)

Chairman Franklin asked Sen. Eck how she felt about striking the preparation of a biannual budget document in section F. Sen. Eck said that it is a new concept and the coordinating council would choose to do or not to do that.

Sen. Towe had concerns about staffing of the coordinating council from the governor's office. Sen. Eck said she didn't think they could get money from the governor's office. She said she would rather accept the amendments offered by the Board of Crime Control and be on hand when SB 34 appears before the Finance Subcommittees.

Motion:

Sen. Towe moved the amendments as presented by the Board of Crime Control.

Vote:

Motion carried unanimously.

Motion:

Sen. Eck moved that the Committee DO PASS SB 34 as amended.

Discussion:

Sen. Klampe asked for comments about possibility of Sunsetting a bill like SB 34. Sen. Rye said he would be against a Sunset date on SB 34 because he could not see a time during the next decade that a coordinating council would not be needed.

Sen. Rye concerns were concerning travel reimbursement. Susan Fox said that unless they were a full-time employee of the state, each member would be entitled to \$25.00 for each day plus travel expenses. Sen. Christiaens pointed out that this would apply to only two individuals.

<u>Vote</u>:

SB 34 concurred as amended unanimously.

Discussion:

Sen. Christiaens said 4 million dollars of the 6 million of preventative federal money goes to the Office of Public Instruction for school programs, and 2 million dollars go towards drug testing and education for the Department of Corrections, and the rest for investigation and prosecution of drug cases in Montana. Sen. Eck asked about grants to local groups. Sen. Christiaens said generally funds go to the sheriff's department or the police department.

Sen. Eck said that Fred Fisher said that one of the directives of the expenditure of the federal funds was to plan for collaboration. Sen. Eck said there are two other bills which address prevention to come to the Public Health Committee soon, so Committee members should keep that in mind.

EXECUTIVE ACTION ON SB 45

Discussion:

Sen. Towe said that he had received amendments from the Board of Morticians, and they showed a good faith effort of addressing the concerns Sen. Towe had during the first hearing of SB 45. He asked that SB 45 be kept open for review.

Motion:

Sen. Towe moved that on page 3, Line 21, strike "an adult child" and insert "a majority of adult children", and that grammatical corrections be made to reflect this change.

<u>Vote</u>:

Motion to Amend SB 45 carried unanimously.

Discussion:

Bonnie Tippy, Board of Morticians, said that the problem with the Sen. Towe's additions to the Board of Mortician's amendment is that the new amendment says that anyone has a cause of action and what the Board of Morticians is trying to do is to limit who can sue a funeral home or crematory. They don't want "people coming out of the woodwork to launch a lawsuit."

Sen. Towe said that his additions to the amendment meant that if funeral homes and crematories follow procedure outlined in SB 45, it is presumed they are acting without negligence.

Chairman Eck asked if that section should be replaced. Sen. Towe said that he had asked to delay further action until this had been worked out with the Board of Morticians.

Sen. Christiaens asked about the disposal of ashes. Susan Fox asked the Department of Commerce about the definition of "disposition", and they said that it is an industry standard term, and if the Committee defined "disposition", it may compromise something for the Department of Health. Chairman Eck asked about remains being kept for a certain period of time. Susan Fox said that the Montana Trial Lawyers Association had liability concerns about this as well.

Sen. Towe said he takes the position of the Board of Morticians in the instance of disposing of remains. SB 45 requires that a very accurate record be kept of the authorizing agent's wishes regarding the disposal of remains. If the crematorium is lax about keeping a record, then they are negligent. Sen. Towe said he would review all these points with the Board of Morticians and the Montana Trial Lawyers Association.

Sen. Rye asked Sen. Towe if he were a member of the Montana Trial Lawyers Association. Sen. Towe said he was not a member, but that he agreed with them on this issue.

Sen. Towe asked about the dangers of pace makers. Bonnie Tippy said they are very dangerous and can explode. The morticians or a doctor must remove them, and it is very important that authorizing agents let the crematory personnel know about pace makers.

Sen. Christiaens asked about a scar left by the implantation of a pace maker. Mary Lou Garrett, Board of Morticians, said that it is similar to other operational scars.

Sen. Towe said that if the authorizing agent failed to disclose the implantation of a pace maker in a body, then the funeral director would have a lawsuit against that individual.

Chairman Eck said executive action on SB 45 would be finished after Sen. Towe had a chance to speak with the Board of Morticians.



The 53rd Montana State Legislature:

This report is in response to the Sunrise law which requires the Legislative Audit Committee to evaluate qualifying proposals to establish new professional or occupational licensing programs. The Committee must also review proposals to transfer licensing programs between existing licensing boards. During the 1993 Biennium, the Committee evaluated proposals to establish licensing programs for crematoriums and crematory technicians, clinical laboratory science practitioners, and property managers. The Committee also evaluated a proposal to transfer the regulation of denturists from the Board of Dentistry to the Alternative Health Care Board.

Section 2-8-203, MCA, requires the Committee to report to the legislature on its recommendations as to whether each of the professions or occupations should be licensed by the state. The Committee is to include in the report its estimates of the costs of each licensing program and a schedule of fees to recover these costs. The Committee's recommendations are shown on page 2. The Committee's estimates for costs and fees are shown on page 3.

Legislative Audit Committee SUNRISE -- 1993 BIENNIUM

Introduction

The intent of the Sunrise Law (Chapter 266, Laws of Montana 1987) was to improve the legislature's ability to evaluate the need for new professional and occupational licensing programs. Under this law, the Legislative Audit Committee is required to evaluate any qualifying proposal to: 1) establish a new licensing board; 2) add canother occupation or profession to an existing board; 3) consolidate any existing licensing boards; or 4) transfer a licensing program between existing licensing boards.

In order for a proposal to qualify for review, the applicant must submit the proposal in the form of a report to the Legislative Audit Committee at least 180 days before the start of the legislative session. The report must provide information to the Committee related to the need for licensure and how the proposed board will operate. For consolidation or transfer proposals the report must describe the benefits of the proposal. Each proposal must include an application fee.

After the Legislative Audit Committee receives the completed report and application fee, the Committee will hold a public meeting to consider the report. The Committee hears testimony from the applicant and any other interested parties. The Committee considers information presented in the applicant's report and testimony given at the public hearing to make its recommendation as to whether the profession or occupation should be licensed. For consolidation or transfer proposals the Committee can recommend the legislature adopt the proposal or adopt some modification of the proposal. Section 2-8-203, MCA, requires the Committee to make its recommendation in a report to the legislature for its next regular session. The report must also include an estimate of the cost to the state for each of the licensing programs along with a proposed schedule of fees that will recover the costs of each program.

Public Hearings

On October 19, 1992, the Legislative Audit Committee heard testimony concerning proposals to license crematoriums and crematory technicians and clinical laboratory science practitioners. On November 20, 1992, the Committee heard testimony concerning a proposal to license property managers and a proposal to transfer regulation of denturists to the Alternative Health Care Board. The Committee voted on its recommendations for the first two proposals at its November meeting. Final Committee action related to Sunrise was taken at the Committee's meeting on December 21, 1992.

The following is a summary of Committee action and recommendations for the four professions which went through the Sunrise process during the 1993 biennium. Also presented are the Committee's estimates on projected costs for each of the licensing proposals and the estimated fees to cover those costs.

Clinical Laboratory Science Practitioners

A motion was made by Senator Svrcek to recommend licensure for clinical laboratory science practitioners. The motion carried with a unanimous vote.

Crematoriums and Crematory Technicians

A motion was make by Representative Pavlovich to recommend licensure for crematoriums and crematory technicians. The motion carried with a 7 - 0 vote and one abstention.

Denturists

A motion was made by Representative Pavlovich to <u>not</u> recommend the transfer of regulation of denturists from the Board of Dentistry to the Alternative Health Care Board. The motion carried with a unanimous vote.

Committee discussion after this motion indicated the applicant may bring other alternatives before the 1993 Legislature.

Property Managers

A motion was made by Representative Kadas to recommend licensure for property managers. The motion carried with a unanimous vote.

Licensing Program Costs and Fees

The Committee and the Department of Commerce reviewed the cost information provided by the applicants. The Committee believes the final figures are reasonable estimates of the yearly costs for the new licensing programs. To cover the costs of these new programs, the applicants and department staff estimated the necessary licensing fees. The Committee believes the fees presented in the following chart are reasonable and will comply with section 37-1-134, MCA, which requires fees to be commensurate with costs.
