Committee Business Summary:

Executive Action: SB 180, SB 205, SB 326

Senator Jergeson said he would describe the three bills that are in the Rules Committee that need action. SB 180 by Senator Christiaens would appropriate money to the Department of Family Services and clearly is an appropriation bill. He believes Sen. Christiaens had someone else redraft the bill and have it introduced in the House. We will need a motion to table SB 180.

<u>SB 205</u> by Senator Fritz has a statutory appropriation, and Senator Fritz has informed Sen. Jergeson that Legislative Council has suggested we need to put this bill on the table before it could be redrafted in the council to get it introduced in the House.

Senator Fritz said he just assumed it would be a necessary step before he had it redrafted. He would ask that the committee officially table SB 205 and he will proceed further.

The third bill is <u>SB 326</u> by Senator Nathe, which appropriates money for administrative expenses and grants.

Motion: Senator Crippen moved SB 205 Be Tabled.

Motion: Senator Lynch moved all 3 bills Be Tabled.
