### EXECUTIVE ACTION ON HB 459

Motion: REP. SIMPKINS MOVED TO REMOVE HB 459 FROM THE TABLE AND RECONSIDER ACTION.

### Discussion:

REP. GERVAIS stated his opposition to the motion for the same reasons as were discussed the first time the committee voted on

the bill. He said the passage of the bill could jeopardize forty four million dollars in its attempt to save approximately three hundred thousand.

- REP. DAILY asked if this was the reason the committee was called to order. REP. HANSON responded by replying it was not. He explained the committee was to hear SB 138 and SB 211. REP. HANSON indicated SB 138 was cancelled in the morning and SB 211 was cancelled by SENATOR YELLOWTAIL just before the hearing was to start.
- REP. DAVIS noted he believed it would be completely out of order to take action on bills that were not scheduled to be heard. REP. HANSON replied it was his understanding once the committee is called to order a motion on any bill may be considered.
- REP. DAILY expressed his opposition to the committee meeting being called to order for this purpose. He insisted REP. SIMPKINS could have requested the full House pull the bill off the table instead of having the committee called for this sole purpose.
- REP. SPRING stated he has seen the same thing done when committee chair positions were held by the other party. He noted his support of the chairman's action.

<u>Vote</u>: HB 459 BE REMOVED FROM THE TABLE. Motion carried 9 to 8 with REPS. DAILY, DAVIS, DOLEZAL, HARRINGTON, GERVAIS, McCARTHY, McCULLOCH, and WYATT voting no. EXHIBIT 1

### Discussion:

- REP. DAILY commented the action taking place is certainly not an example of bipartisan, cooperative support talked about at the beginning of the session. He said many members would have been present if they had known such a motion would have been made.

  REP. DAILY emphasized what is being done is wrong.
- REP. MCCARTHY agreed with REP. DAILY and said she would emphasize on the floor the meeting was called for completely inappropriate action.
- REP. SIMPKINS maintained if the majority of the committee wanted to call the meeting they could have done so for any reason.
- REP. MCCARTHY declared she would not have raised an objection if the meeting was called for the purpose it was conducted. She said she would have stayed for the discussion if that had been the case. (REP. MCCARTHY and REP. DAILY left the meeting at this point).
- **REP. GERVAIS** asserted this motion should have been made on the floor of the House.

Motion: REP. SIMPKINS MOVED HB 459 DO PASS.
