Committee Business Summary:

Hearing: SJR 26; SB 169
Executive Action: SJR 26; SB 169; SB 174

HEARING ON SJR 26

Opening Statement by Sponsor:

SEN. BOB PIPINICH, Senate District 33, Missoula, introduced SJR 26 encouraging the United State government to take a more active role in a multinational effort to end the tragic pattern of violence in the former country of Yugoslavia.

Proponents' Testimony:

REP. CARLEY TUSS, House District 35, Black Eagle, stated many of the residents of Black Eagle were Croatian and were horrified by the events in Yugoslavia. She said they were seeking a peaceful resolution because the community had Serb and Bosnian friends and relatives. She said the isolation of Sarajevo reminded her of the starvation of Stalingrad, and reports of other events mimic the atrocities of World War II. She noted the contributions of the Croats, Serbs, and Bosnians in Montana. She asked for favorable consideration of SJR 26.

REP. BOB PAVLOVICH, House District 70, Butte, stated he was of Croatian descent and the Butte community included Serbs, Croats, and Slovenes. He described visiting Yugoslavia and meeting President Tito with his mother. He lamented the events in Yugoslavia. He referred to lines 21-23, page 2, which recommend sending a delegation to Yugoslavia, and reported he knew an individual who was well-acquainted with people in Yugoslavia and could be part of the delegation.

Opponents' Testimony: None.

Informational Testimony: None.

Questions From Committee Members and Responses:

REP. SPRING said he sympathized but asked REP. PAVLOVICH whether he thought a delegation could truly have an impact. REP. PAVLOVICH responded that a delegation could have an impact because there were people in the United States who had contacts with the leadership of Yugoslavia and were respected there.

Closing by Sponsor:

REP. PAVLOVICH closed.

HEARING ON SB 169Opening Statement by Sponsor:

SEN. TOM BECK, Senate District 24, Deer Lodge, introduced SB 169 which directs the Department of Corrections and Human Services to transfer the buildings and land of the Old Montana State Prison complex to the Powell County Museum and Arts Foundation for continued operation as a museum. He said the Old Montana State Prison was currently leased to the City of Deer Lodge and subleased to Powell County. He said the bill would provide a 99-year lease of the complex directly to Powell County. The lease would give the Powell County Museum and Arts Foundation the opportunity to do long-term planning and apply for grants.

Proponents' Testimony:

Dick Bauman, President, Powell County Museum and Arts Foundation, provided written testimony in which he described the improvements the Foundation has already made to the prison complex and their plans for the future. EXHIBIT 1

Mr. Bauman recommended an amendment to SB 169 guaranteeing the rights of the Montana Law Enforcement Museum. EXHIBIT 2

Jim Thompson, Powell County Museum and Arts Foundation, reviewed the history and development of the museum. He explained the old prison complex needed further improvements, and the long-term lease would facilitate the Foundation's efforts in raising funds. He urged passage of the bill.

Clint Blackwood, Travel Promotion Division, Department of Commerce, urged support of SB 169 to encourage tourism and other commerce in Montana. He stated the film industry looked for settings like the old prison complex for movies. He reported neighboring communities were trying to develop tourist attractions and the old prison would tie in well with those efforts. He suggested the bill would be good for the state and community and stated support for the legislation.

REP. SAM ROSE, Russell Country, stated his support of the bill.

Opponents' Testimony: None.

Informational Testimony: None.

Questions From Committee Members and Responses:

REP. GALVIN asked SEN. BECK whether there would be an objection to a \$1 nominal fee for the lease of state property. SEN. BECK stated a nominal fee would be no problem.

REP. DAVIS asked SEN. BECK to review legislation in prior legislative sessions pertaining to the old prison complex. SEN. BECK explained the bill had been introduced in the last session, and the Montana Law Enforcement Academy had opposed the language in the bill. He said SB 169 and the amendment recommended by Mr. Bauman had been drafted in cooperation with the academy.

REP. SCHWINDEN asked SEN. BECK whether the Department of Corrections and Human Services had been involved in drafting the bill. SEN. BECK confirmed they had been involved. He said he had expected department staff to be present and testify for the bill.

REP. SIMPKINS asked SEN. BECK whether the bill gives complete authority to the Powell County Museum. SEN. BECK stated the Powell County Museum and Arts Foundation would have control.

REP. WALLIN asked SEN. BECK which buildings were included in the complex. SEN. BECK responded all the buildings except for the warden's residence, which was currently housing the Board of Pardons, were included.

REP. LIZ SMITH, House District 48, Deer Lodge, spoke in support of SB 169. She commended the hard work performed by the museum and arts foundation and noted the benefit to the community. She encouraged passage of the bill.

Closing by Sponsor:

SEN. BECK asked for concurrence on the bill. He said one of his primary concerns was helping the City of Deer Lodge eliminate any exposure to possible liability. He contended the bill would help in creating long-term plans for the complex.

EXECUTIVE ACTION ON SB 169

Motion: REP. SPRING MOVED SB 169 BE CONCURRED IN.

Motion: REP. MASON moved to amend SB 169. EXHIBIT 2

Discussion:

REP. REHBEIN asked whether the bill needed to be amended to specify a fee for the lease. Ms. Heffelfinger responded an amount will need to be included in the lease, but the amount would be negotiated with the county and therefore does not need to be specified in statute. REP. GERVAIS stated specifying a monetary sum would require the bill to be heard in appropriations.

Vote: SB 169 BE AMENDED. Motion carried unanimously with REPS. BARNHART and SQUIRES voting by proxy. EXHIBITS 3, 4

Motion/Vote: REP. SPRING MOVED SB 169 BE CONCURRED IN AS AMENDED. Motion carried unanimously with REPS. BARNHART and SQUIRES voting by proxy. EXHIBITS 3, 4

EXECUTIVE ACTION ON SJR 26

Motion: REP. DAVIS MOVED SJR 26 BE CONCURRED IN.

Discussion:

REP. SIMPKINS said his initial reaction to SJR 26 was that the State of Montana should not be directing the federal government's foreign policy. He said, however, after hearing testimony from people with family and friends in Yugoslavia, he had reconsidered.

REP. MOLNAR said he had family from Yugoslavia, but he did not think the federal government would pay any attention to a resolution from Montana.

REP. REHBEIN asked what happened to resolutions. REP. SIMPKINS referred him to lines 9-14, page 3, which specifies the distribution of the resolution. He explained the resolution also becomes part of session law.

REP. GERVAIS stated resolutions were effective; he had received responses from people as the result of resolutions he had introduced.

REP. WALLIN stated his support of the resolution. He said the resolution may just be a gesture, but the resolution demonstrated that the people of Montana do sympathize with the people of Yugoslavia.

REP. SIMPKINS noted Yugoslavia had been arbitrarily created at the end of World War II and was held together until recently by a dictatorship.

REP. SPRING stated he had great sympathy for the people, but he had difficulty supporting the resolution because he doubted its effectiveness.

Vote: SJR 26 BE CONCURRED IN. Motion carried 12 to 4 with REPS. REHBEIN, SPRING, MASON, and MOLNAR voting no and REPS. SQUIRES and BARNHART voting by proxy.

EXECUTIVE ACTION ON SB 174

Motion: REP. RICE MOVED SB 174 BE CONCURRED IN.

Motion: REP. RICE moved to amend SB 174. EXHIBIT 5

Discussion:

REP. RICE explained the amendment assures that any fees used to reimburse a citizen would come from fines collected under the title and thereby avoid any liability to the state.

Vote: SB 174 BE AMENDED. Motion carried unanimously with REPS. SQUIRES and BARNHART voting by proxy.

Motion: REP. RICE MOVED SB 174 BE CONCURRED IN AS AMENDED.

Discussion:

REP. ROSE expressed his dismay with the number of similar bills.

REP. REHBEIN asked what legal avenues were available to citizens under current law. Ms. Heffelfinger explained citizens can

inform the county attorney or the commissioner of political practices of a violation, and either the county attorney or the commissioner can file legal charges. She said if they do not pursue the complaint, then citizens have no recourse because they have no legal standing. She explained the issue in the bill was giving legal standing to citizens. She said the court generally would not recognize citizens unless they are personally damaged or financially harmed. **REP. SIMPKINS** offered, as an example, a candidate who must spend money to respond to an opponent's illegal campaign practice and would therefore be able to sue because of personal damage.

REP. WALLIN asked whether a lawsuit could be brought only by people directly involved. **Ms. Heffelfinger** responded under current law only people directly involved could bring suit; under SB 174 other citizens would have legal standing to bring suit.

REP. STOVALL asked whether anyone would be able to sue any candidate whenever they wished under SB 174. **REP. SIMPKINS** responded if the commissioner of political practices does not take action on a complaint, then an individual could sue. **REP. STOVALL** suggested the bill would allow a citizen to bring suit as a vendetta against a candidate. **REP. SIMPKINS** agreed, if the commissioner or county attorney did not prosecute the complaint.

REP. MOLNAR asked whether the bill applied to all candidates for public office including U.S. senate or president. **Ms. Heffelfinger** responded the bill applied to violations of statutes which govern standards for candidates.

REP. SQUIRES stated she supported the bill. She said candidates who experience campaign violations usually have problems resolved the commissioner of political practices. She suggested the more common situation in which the lack of legal recourse is a difficulty occurs on issues such as initiatives. She said the bill gives the commissioner and the county attorney the first option to file suit; and if they both choose to ignore the complaint, then the citizen has the prerogative to act. She said the bill provided a good safeguard for violations during initiative campaigns.

REP. SCHWINDEN declared the bill was a step in the right direction because it gives average citizens legal standing and involves them in the process. He suggested citizens feel disenfranchised and giving them legal standing would help alleviate their apathy toward the political process. He recommended supporting the bill.

REP. MASON asked **Ms. Heffelfinger** whether the amendment conflicted with provisions of the bill. **Ms. Heffelfinger** explained the amendment only addressed who would pay costs and attorney fees awarded by the court.

REP. STOVALL asked what happened if no fines were collected.

REP. RICE explained the amendment specified that payment by the state would come from fines which are collected; if no fines are collected, then no payment would be possible.

REP. MOLNAR asked whether suit would be brought against political organizations or individuals. Ms. Heffelfinger responded complaints would be filed for violations of reporting requirements. Thus, anybody who makes an expenditure or contribution and violates reporting requirements may be sued.

REP. MOLNAR asked whether the U.S. president could be personally sued for a violation of Montana campaign reporting requirements. Ms. Heffelfinger said her cursory view as a non-attorney was that the statute refers to a person who intentionally or negligently violates any reporting provisions of the chapter. She said if the president's campaign organization is required to report under the chapter, then the bill would apply.

REP. RICE reminded the committee the bill was an extension of current law. She addressed REP. MOLNAR and noted statute already allows complaints to be filed against people violating the reporting requirements. She pointed out the bill simply extended the statute to give citizens the ability to file suit if the county attorney or commissioner of political practices fails to act. She noted the bill had protection against frivolous suits. She said the real issue was the inaction on the part of the commissioner and/or county attorneys. She suggested county attorneys have other priorities, but she said she did not understand delays by the commissioner. She said the bill would put pressure on the commissioner's office to act on complaints. REP. RICE referred to REP. ROSE'S complaint about the number of bills concerned with political practices. She noted no other bill has dealt with citizen enforcement of campaign violations. She reminded the committee that citizen enforcement existed for other areas, and contended the bill would not result in frivolous suits.

REP. SPRING disagreed with REP. RICE'S assessment of the bill. He said we live in a litigious environment and contended the bill would result in more lawsuits.



REP. GERVAIS contended SB 174 was a simple bill, that testimony had explained the bill well, and that the amendment provided clarification. He called for the question.



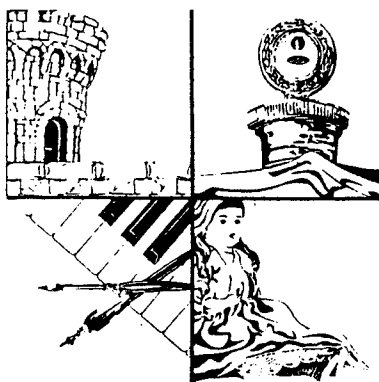

MR CHAIRMAN & COMMITTEE MEMBERS

I AM DICK BAUMAN, PRESIDENT OF POWELL COUNTY MUSEUM AND ARTS FOUNDATION. THIS IS MY EIGHTH YEAR AS PRESIDENT OF THIS NON-PROFIT ORGANIZATION. I AM IN FAVOR OF THE PASSAGE OF SENATE BILL 169.

THE "MUSEUM POST" (ENCLOSED WITH TESTIMONY) TELLS OF OUR MANY DIFFERENT ACTIVITIES IN THE POWELL COUNTY AREA, IT ALSO HAS OUR 1993 BUDGET IN THE AMOUNT OF \$334,800. THIS INCLUDES A CONSIDERABLE AMOUNT OF CAPITAL IMPROVEMENTS. WE ARE ALSO IN THE PROCESS OF DEVELOPING A "WESTERN HERITAGE AND EARLY DAY LIQUOR INDUSTRY" MUSEUM. THE BUILDING WAS ONCE A STABLE AT THE PRISON AND WILL ADD APPROXIMATELY 4000 SQ FEET OF DISPLAY AREA. THE ESTIMATED COST FOR THE WALLS, CEILING AND FLOOR IS \$60,000. WE HOPE TO BE OPEN IN LATE 1993 OR EARLY 1994.

RAILROADING PLAYED A BIG ROLE IN THE HISTORY OF MONTANA AND THE DEER LODGE VALLEY. ONE OF THE LAST ELECTRIC LOCOMOTIVES IN THE NATION IS IN DEER LODGE AND WE ARE GOING TO RESTORE THIS ENGINE AND POSSIBLY MOVE IT ONTO THE MUSEUM COMPLEX. DURING THIS TIME WE WILL ALSO ESTABLISH A RAILROAD MUSEUM.

WE HAVE REROOFED NEARLY EVERY BUILDING IN THE PRISON COMPLEX, INSTALLED HEATING SYSTEMS, PUT IN WATER LINES, SEWER LINES, REPAINTED AND REGLASSED TO MAKE THE PRISON COMPLEX THE ATTRACTION THAT IT IS TODAY. THE PAST INVESTMENT NOW EXCEEDS \$400,000. THESE PROJECTS AND INVESTMENTS THAT HAVE BEEN MADE BY THE POWELL COUNTY MUSEUM & ARTS ARE THE REASON THAT PASSAGE OF SENATE BILL 169 IS SO IMPORTANT TO US NOW AND ON INTO THE FUTURE.

ALSO INCLUDED IN THIS BILL IS THE WARDENS HOUSE. IT IS PRESENTLY OCCUPIED BY THE BOARD OF PARDONS & THE FISH AND GAME DEPT. WE WOULD NOT CHANGE THE AGREEMENTS THAT THEY NOW HAVE WITH THE DEPT OF INSTITUTIONS.

THE POWELL COUNTY COMMISSIONERS AND MAYOR OF DEER LODGE ARE IN FAVOR OF PASSAGE.

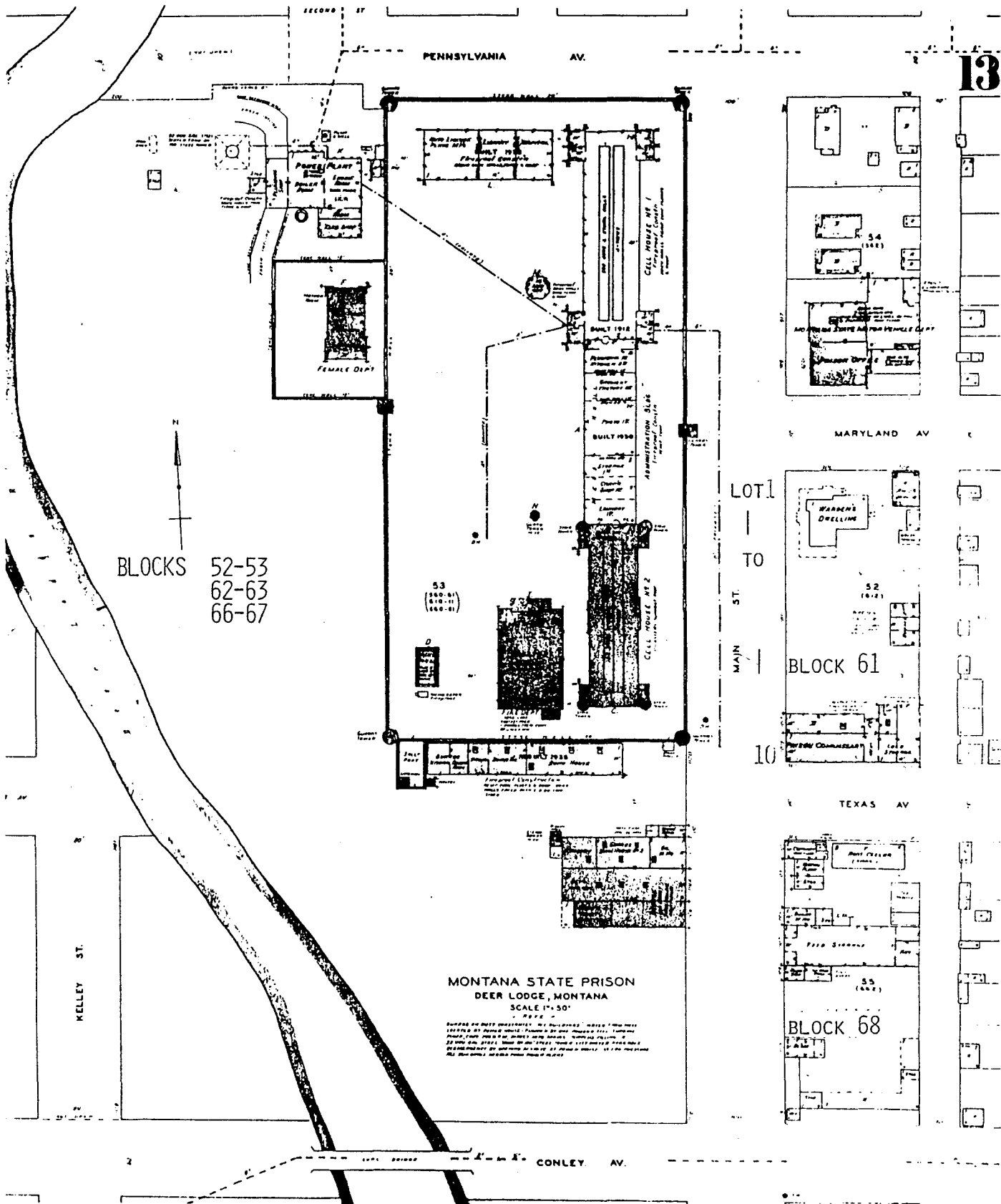

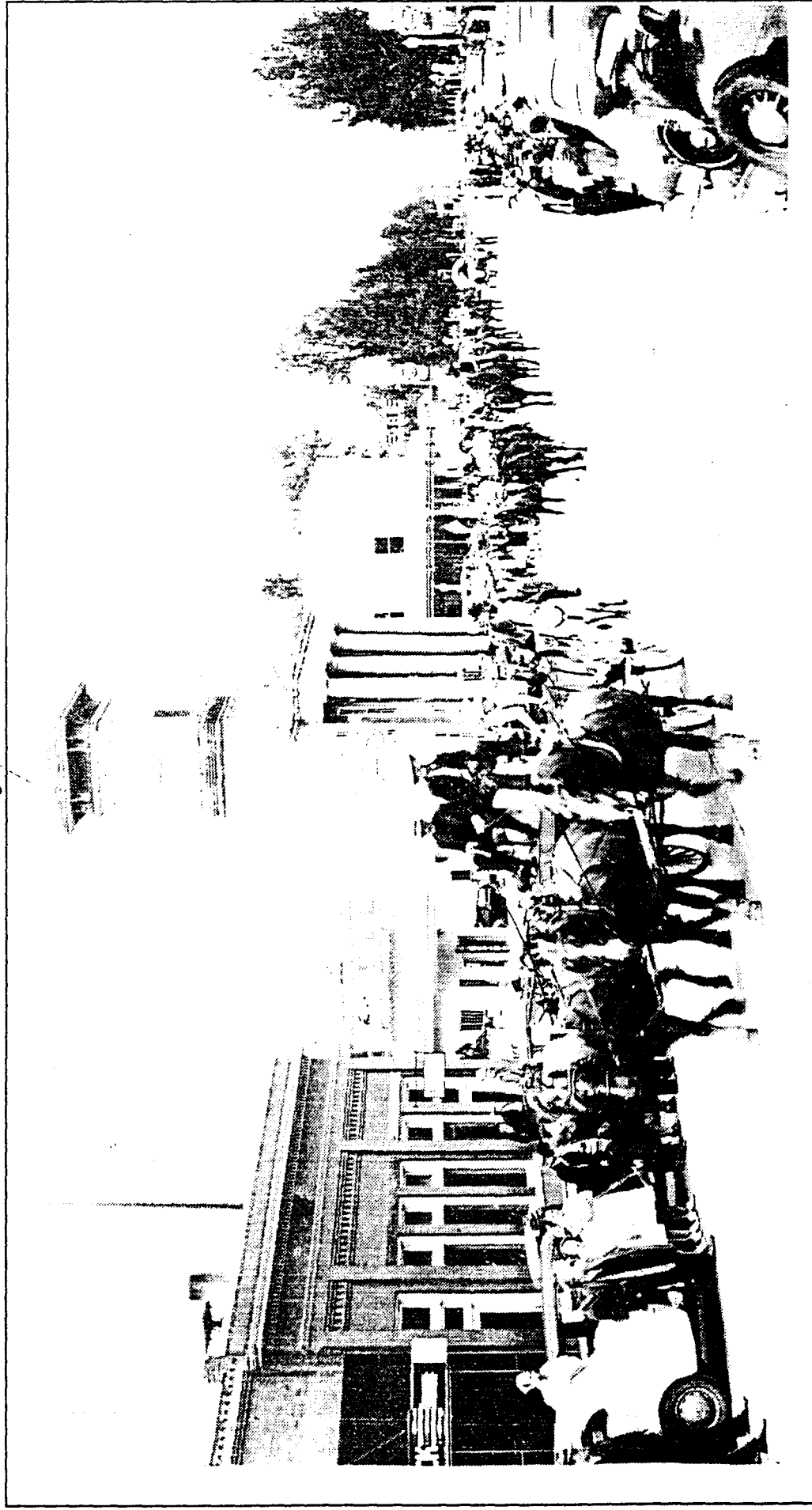

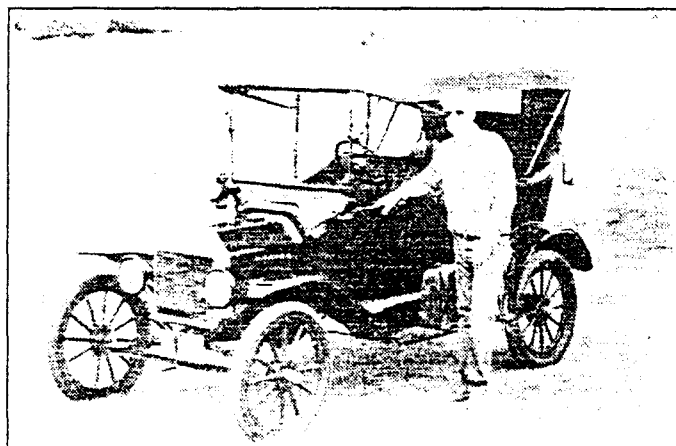
