**Executive Action:** HB 4, HB 654, HB 657, HB 677, HB 678, HB 608, HB 6, HB 7, HB 9, HB 642

**EXECUTIVE ACTION ON HOUSE BILL 4**

**Motion/Vote:** Senator Swysgood moved technical amendments to HB 4. (Exhibit 1) Motion CARRIED.

**Motion/Vote:** Senator Beck moved Representative Zook's amendments to HB 4. (Exhibit 2) Motion CARRIED.

**Motion/Vote:** Senator Christiaens moved that HB 4 AS AMENDED BE CONCURRED IN. Motion CARRIED.

**EXECUTIVE ACTION ON HOUSE BILL 654**

**Motion/Vote:** Senator Christiaens moved that HB 654 BE CONCURRED IN. Motion CARRIED with Senator Lynch opposed.

**EXECUTIVE ACTION ON HOUSE BILL 657**

**Discussion:** Senator Jacobson asked Terry Cohea to comment on the attorney general charging fees.

Terry Cohea, LFA, said it is \$48,000 general fund money. The bill would allow the attorney general to charge fees for opinions, with those fees going into the general fund.

**Motion:** Senator Lynch moved that HB 657 BE CONCURRED IN.

**Discussion:** Senator Aklestad said although he realizes if the counties don't ask for the services, there is no cost, he would not like to see the costs passed onto the counties.

Senator Jacobson said while she agrees with that, she felt we had no choice as the House has put us in that position.

**Vote:** Motion that HOUSE BILL 657 BE CONCURRED IN CARRIED with Senators Aklestad, Devlin, Keating, Swysgood opposed.

**EXECUTIVE ACTION ON HOUSE BILL 677**

**Motion/Vote:** Senator Lynch moved that HB 677 BE TABLED. Motion CARRIED with Senators Tveit, Harding, Aklestad, Beck, Toews, Hockett opposed.

**EXECUTIVE ACTION ON HOUSE BILL 678**

**Motion:** Senator Lynch moved that HOUSE BILL 678 BE NOT CONCURRED IN.

**Discussion:** Senator Swysgood stated if 42 driver's license stations are closed, people would not want to drive long distances to get their licenses renewed, which he said would be the effect of this.

Senator Jacobson stated if it is our intent to have those license stations opened, we should fund them, but money should not be taken out of gaming taxes that should be used to take care of people with addictions.

Senator Waterman questioned if the balance in this account would revert to the general fund.

Ms. Cohea said legislation was passed in the January special session saying the balance reverts at the end of 1993. HB 678 limits how much money will revert which would be \$190,000. \$510,000 would remain in the gambling state special revenue account.

Senator Keating felt it is wrong to earmark money this way when driver's licenses should be funded out of the general fund.

Regarding a question from Senator Harding regarding the funding of driver's licenses in HB 2, Ms. Cohea said the appropriation is in HB 2 from state special account. The account has had a large growth in the amount of money. There may be sufficient revenue in that account even without this bill to fund out of state special.

Senator Swysgood questioned how this figured into the 99/99.

Ms. Cohea said one of the reasons for doing it was to keep the money in state special and spend from state special.

**Motion/Vote** Senator Lynch made a substitute motion that HOUSE BILL 678 BE TABLED. Motion CARRIED with Senators Beck, Devlin, Hockett, Aklestad, Swysgood, Tveit, Weeding opposed.

#### **EXECUTIVE ACTION ON HOUSE BILL 608**

**Motion:** Senator Keating moved that HOUSE BILL 608 BE NOT CONCURRED IN.

**Discussion:** Senator Keating said the resource indemnity trust tax is about \$5 million a year which comes from various sources. There is \$17.5 million in interest income that goes for renewable resource water projects, reclamation and development grants. Those programs currently get about 80 percent of the \$17 million. It is not justified or reasonable to tax one small group of people in the state that have royalty income to pay for water projects in other parts of the state.

**Vote:** Senator Keating's motion that HB 608 BE NOT CONCURRED IN

FAILED.

**Motion:** Senator Hockett moved amendments to HB 608. (Exhibit 3)

**Discussion:** Senator Jacobson asked Senator Hockett if is justification is that Northern Montana College is not a land grant college.

Senator Hockett said that was correct.

Senator Jergeson said the issue is what units deal with land grants. The purpose of Senator Hockett's amendment (Exhibit 3) is to bring equity from one campus to another.

Senator Jacobson asked when the RIT funds reach their maximum and get capped, will this come from trust fund interest.

John Tubbs, Department of Natural Resources and Conservation, stated the way the amendment is proposed is that an appropriation will be established out of RIT account, water development, renewable resource account. It will receive a combination of interest and the proceeds if that is the committee's desire.

Senator Jacobson questioned what happens when the account reaches the amount at which the trust is capped; does the money continue.

Mr. Tubbs said the money will continue. The trust will have its maximum interest accruing from that.

Senator Weeding questioned the dollar amount of this.

Senator Jacobson said it would be \$240,000 a year.

Senator Swysgood asked how this compares to what monies Western Montana College gets from its land grant.

Senator Hockett said on a yearly figure, Western Montana College at the low end has \$207,000 and \$235,000 at the high end. It is projected for fiscal year '94-'95 to be \$219,000 for Western.

Senator Swysgood questioned how the figure of \$240,000 for Northern Montana College was arrived at.

Senator Hockett said it was the number of students at the school percentage-wise compared to Western Montana College.

Senator Devlin said he would resist the motion as this should be in a bill form.

Senator Jergeson stated this was included in the Governor's recommendations. The Governor wanted to create equity among the units of the university system.

Senator Beck questioned if we have a water quality instruction

program in all counties in Montana.

Senator Hockett said not to his knowledge. He added that Northern Montana College works with the federal government on doing training for waste water treatment around the state; this is strictly a water quality program.

Senator Aklestad asked Senator Hockett if he tried to get money in the same way other universities obtain their money.

Senator Hockett said yes, that he had talked to the Commissioner of Higher Education regarding this, although he doesn't know the results of the conversation. He was told they have committed that money for various bonding programs for repayment of building bonds, etc.

**Vote:** Senator Hockett's amendment motion (Exhibit 3) CARRIED on a roll call vote.

**Motion/Vote:** Senator Weeding moved that HOUSE BILL 608 AS AMENDED BE CONCURRED IN. Motion CARRIED with Senators Devlin, Keating, Tveit opposed.

#### **EXECUTIVE ACTION ON HOUSE BILL 6**

**Motion:** Senator Hockett moved to amend HOUSE BILL 6 (Exhibit 4)

**Discussion:** Senator Hockett stated this amendment has to do with Hot Springs, Montana; if they are moved back to the bottom of the list, they will not be funded based on action by the House.

Senator Keating questioned what the Camas Therapy Center does and why they are funded for \$150,000.

Senator Hockett said there was a request by the people of Hot Springs to rebuild a building for hot mineral baths. When questioned by Senator Keating if it is privately owned or is a municipal project, Senator Harding said it is the Indian tribe and the town of Hot Springs.

Senator Franklin noted it was explained by Rep. Elliott that this was the Hot Springs economic development plan and if they did not develop it, Hot Springs was destined for a grim future.

Senator Lynch asked who would get deleted from the list if this amendment passed.

Senator Jacobson said it would be Glasgow.

When questioned by Senator Lynch regarding funding levels, John Tubbs said currently the funding level is part way through the Glasgow Irrigation project. If that is removed, it will free up \$150,000. It could fully fund Glasgow irrigation district,

Hilger water and sewer district and part of Flathead Valley Cooperative water study.

Senator Harding asked Mr. Tubbs to explain what originally happened to Camas Hot Springs.

Mr. Tubbs said they applied in both reclamation development and water development. It was the decision of long range building to only fund \$150,000 of \$400,000 in requests, and they originally funded it in HB 7. After legislative action, it has gone full circle and is now where it originally was.

**Vote:** Senator Hockett's amendment motion (Exhibit 4) CARRIED on a roll call vote.

**Motion/Vote:** Senator Swysgood moved to amend HB 6 (Exhibit 5). Motion CARRIED.

Senator Vaughn moved to amend HB 6 (Exhibits 6, 7).

Mr. Tubbs said these exhibits allow for issuance of bonds to fund loans.

Senator Vaughn's amendment motion (Exhibit 6,7) CARRIED.

**Motion:** Senator Lynch moved to amend HB 6 (Exhibit 8).

Senator Van Valkenburg said this amendment would provide a \$100,000 grant to the Linda Vista sewer inceptor project in Missoula County. He said this project was approved by the '91 legislature. The proposal was presented to the long range planning subcommittee but was not put in the bill at the time. The project was not in the recommended list from the budget office and the Department of Natural Resources and Conservation (DNRC). The reason it was not submitted is difficulty with expenses involved to the individual homeowners, problems they are facing to form an RSID to create a funding mechanism for this project. He said it would be a \$2.2 million overall project involving over 200 homes that have now been subjected to an order by the Department of Health. He noted this is a unique situation because the Health Department had approved this subdivision when it was originally created. He added it is a very appropriate project for this kind of funding. The problem had been that the application was not made until after the deadline because the order did not come down until September. He concluded that he has found a good source of funding for this particular project and hoped we would respect that ability to find some unspent money.

Mr. Tubbs said the Linda Vista project was approved in the last biennium but it ranked very low. They did not see any compelling reason to spend \$10,000 a household to hook up to the facility. The Health Department issued an administrative order requiring all homeowners to hook up to a sewer system. They required an

RSID to finance the project. He said the basic problem is whether effluent is draining downhill and into individual wells. Regarding the funding availability, the money is unspent appropriations in the state water project account. They had an \$800,000 allocation in the current biennium and have about \$500,000 to \$700,000 that has not been expended. If it does not get spent, it provides a little cushion for an ending fund balance in the RIT account so some money has to be left there.

Senator Bianchi said there were a few other projects that were funded the same way.

Mr. Tubbs said there were but they have received their funding. They were allocated a grant. In the case of Linda Vista, even though they applied for a grant, the committee did approve a loan. This would change it from loan funding to grant funding.

When questioned by Senator Lynch regarding the average price of homes in the district, Senator Van Valkenburg said it is basic middle class, about \$65,000 to \$80,000 in today's real estate values. He said the homes in the area are in the neighborhood of 25 to 30 years old.

Senator Keating questioned the \$890,000 balance from the water development project.

Mr. Tubbs said the \$890,000 calculated beginning balance is based on the assumption that the agency will spend all of their appropriations to the maximum. The state water project account because of their workload in the Tongue River has not been able to pursue other projects that are appropriated. Instead of \$890,000, it would be \$1.2 million to \$1.3 million.

Senator Keating said it does not revert to anything and it is added to the new funds coming into the account and that is what he used to finance what is in HB 6. He noted if this motion passes, it will reduce the beginning fund balance which means that Glasgow will not be funded. He questioned if this is a grant.

Mr. Tubbs said it does not take away from \$1 million allocated for grants. It takes away from beginning balance to fund necessary appropriations. HB 608 puts grants at the top, and what is left over flows to the agency.

Senator Keating questioned who would not get \$100,000 if this motion passed.

Mr. Tubbs said at the end of the biennium there is a possibility they could go further down the list if the agency had not spent their money on the grants below Glasgow.

Senator Keating asked if this would not take away from the administration of the agencies.

Mr. Tubbs said it would if the income estimates were short.

**Motion:** Senator Harding made a substitute motion to add Flathead Joint Board of Control on page 7 of HB 6 into the same position as that of Senator Van Valkenburg.

Senator Harding asked John Metropolis to address this.

Mr. Metropolis said it fits well within the statutory criteria for these projects, and it has water, conservation and environmental benefits. It would eliminate waste ways that carry silt into Crow Creek which has caused fishery problems; it directs it into a reservoir.

Senator Waterman asked Senator Van Valkenburg the difference in the subdivision he is asking for from houses in other subdivisions.

Senator Van Valkenburg said in his case the Board of Health has issued an administrative order requiring people in the subdivision to hook up to a sewer system. The Health Department had previously approved this subdivision when it was created.

When questioned about water policy committees, Mr. Ray Beck of the DNRC said that committee has been eliminated at their own recommendation because they felt it was another unnecessary review process. The ranking comes from the DNRC process and criteria set up by the legislature.

Senator Jacobson asked Mr. Beck if this is the DNRC list of priorities.

Mr. Beck said yes, they work in coordination and support with other experts. Some of it is contracted out. It goes to the Governor who has the right to change them or re-prioritize them, and it then goes to long range planning. Long range planning really makes the final recommendations.

**Vote:** Senator Harding's substitute motion FAILED.

**Discussion on Van Valkenburg amendment**

Senator Aklestad asked Senator Van Valkenburg if this is as important as he felt it was, why they didn't reapply so the committee could have reviewed it this year.

Senator Van Valkenburg said the committee did review it; the order that the Board of Health issued was not issued until September 12 of last year. The deadline for application for grants was in August. He noted they went in front of the long range committee, and it was not acted on at that time. The committee chairman felt that it could be put in the Senate.

Senator Devlin stated there could be \$8,000 or \$9,000 per home on



RSID and he wondered if that is normal or high for an SID.

Mr. Beck said it depends on the community and type of structures. For a situation like this, it would be normal to the high range. He added his feeling that it will be a fairly heavy burden.

Senator Waterman asked Senator Van Valkenburg why he did not reapply irregardless of the order.

Senator Van Valkenburg said because the order had been issued, the Missoula County commissioners then had the authority to order the creation of an RSID even though there could be 100 percent protest between property owners. Costs will be imposed on these people, and that did not happen until after the application process had been done.

**Vote:** Senator Lynch's motion to amend HB 6 (Exhibit 8) CARRIED.

**Motion/Vote:** Senator Lynch moved that HOUSE BILL 6 AS AMENDED BE CONCURRED IN. Motion CARRIED.

#### **EXECUTIVE ACTION ON HOUSE BILL 7**

**Discussion:** Senator Jacobson noted there is an amendment prepared by Jim Haubein, LFA, to delete the Camas Therapy Center project for the town of Hot Springs that was moved down in the priority list in HB 6. (Exhibit 9)

**Motion:** Senator Swysgood moved that language be inserted in HB 7 that would be the same language that was inserted in HB 6 as related to Ennis and the Yellowstone project. If this project receives funding in HB 6, this appropriation is void in HB 7.

Senator Swysgood's motion CARRIED.

**Motion/Vote:** Senator Swysgood moved that HOUSE BILL 7 AS AMENDED BE CONCURRED IN. Motion CARRIED.

#### **EXECUTIVE ACTION ON HOUSE BILL 9**

**Motion/Vote:** Senator Waterman moved that HOUSE BILL 9 BE CONCURRED IN. Motion CARRIED.

#### **EXECUTIVE ACTION ON HOUSE BILL 642**

**Motion/Vote:** Senator Weeding moved to amend HB 642 (Exhibit 10). Motion CARRIED on amendment.

**Motion:** Senator Weeding moved that HOUSE BILL 642 AS AMENDED BE CONCURRED IN.


**Discussion:** Senator Swysgood questioned whether the technical note on the bottom of the fiscal note had been taken care of with the amendment.


Senator Jacobson said the effective date on the bill had been changed a couple times, and currently it is July 1, 1993 which is not a retroactive date.

**Vote:** Motion that HOUSE BILL 642 AS AMENDED BE CONCURRED IN CARRIED with Senators Aklestad, Devlin and Keating opposed.

(4) Earnings on bond proceeds prior to the completion of any loan must be allocated to the debt service account to pay the debt service on the bonds during this period. Earnings in excess of debt service, if any, must be allocated to the water development state special revenue account and may be used for the purposes allowed under 85-1-604(3)(c).

(5) Loan repayments from loans financed with coal severance tax bonds are pledged, dedicated, and appropriated to the debt service account in the state treasury for the benefit of bonds approved for loans under this section.

**"NEW SECTION. Section 13. Requirements for approval of state debt.** Because [section 12] authorizes the creation of a state debt and appropriation of coal severance tax bond fund deposits and appropriates money that would otherwise be deposited in the coal severance tax permanent fund, a vote of three-fourths of the members of each house of the legislature is required for passage of [section 12]."

(2) The legislature, through the enactment of this section, in accordance with Article VIII, section 8, of the Montana constitution, authorizes the creation of a state debt in an amount not to exceed \$3,855,242 for loans to political subdivisions and local government entities for water development projects approved in [sections 1 through 3] and for funding a reserve for the coal severance tax bonds authorized to fund those projects.

(3) In connection with the issuance of coal severance tax bonds, the board of examiners may pay the principal and interest on the bonds from the debt service account and in all other respects manage and use the funds within each special bond account for the benefit of the bonds. The board of examiners shall exercise its discretion to enhance the marketability of the bonds and to secure the most advantageous financial arrangements for the state.

(4) Earnings on bond proceeds prior to the completion of any loan must be allocated to the debt service account to pay the debt service on the bonds during this period. Earnings in excess of debt service, if any, must be allocated to the water development state special revenue account and may be used for the purposes allowed under 85-1-604(3)(c).

(5) Loan repayments from loans financed with coal severance tax bonds are pledged, dedicated, and appropriated to the debt service account in the state treasury for the benefit of bonds approved for loans under this section.

"NEW SECTION. Section 13. Requirements for approval of state debt. Because [section 12] authorizes the creation of a state debt and appropriation of coal severance tax bond fund deposits and appropriates money that would otherwise be deposited in the coal severance tax permanent fund, a vote of three-fourths of the members of each house of the legislature is required for passage of [section 12]."
