#### Committee Business Summary:

Hearing: HJR 27, HJR 29

Executive Action: HJR 27, HJR 29

#### **HEARING ON HOUSE JOINT RESOLUTION 27**

#### Opening Statement by Sponsor:

Representative McCarthy, District 66, sponsor, stated HJR 27 would request an interim study of the needs of Montana veterans, and a report of that to the 54th legislature.

Rep. McCarthy stated that veterans comprise one-eighth of the total population of Montana or 101,544 throughout the state. Over one-third of the veterans are in southwestern Montana, which is one of the reasons they thought it would be a good use for Galen. She concluded that at the present time there are 95 nursing beds for veterans in Montana.

# Proponents' Testimony:

Keith Colbo, Warm Springs-Galen Task Force, in stating his support of HJR 27, said this resolution is not intended to conflict with the wishes of eastern Montana and that facility, but it will take a look at veterans' care now and in the future. He concluded the population figures indicate a growing concern and need in Montana for these services in the state.

Tony Cumming, American Legion of Montana, in stating his support of HJR 27, said the study is very necessary so that people will understand what veterans are up against in Montana.

Dick Baumberger, Disabled American Veterans, stated his support of HJR 27.

John DenHerder, a war veteran, stated his support of the resolution. He said there are many problems out there. The few nursing beds in Miles City have no activity rooms, and it is not truly a nursing home. He concluded that he would like to see the veterans have a campus such as Galen where they can have their own facilities.

Willie Day, Eastern Montana Coalition, stated his support of the resolution as a study for the veterans' needs after the Eastern Montana Veterans Nursing Home is built. He noted that currently there are only 90 nursing home beds in the state. He would support looking into the possibility of something at Galen to serve the needs of veterans.

Senator Betty Bruski-Maus, Senate District 12, stated her support of HJR 27.

### Closing by Sponsor:

Representative McCarthy closed. She said the funding is in the neighborhood of \$40,000 using Senator Lynch's study last time. In talking with Representative Grady, they would anticipate it would come from the cigarette tax.

#### HEARING ON HOUSE JOINT RESOLUTION 29

### Opening Statement by Sponsor:

Representative Dolezal, District 34, Great Falls, sponsor, said HJR 29 is directing a study of the governance of the Montana School for the Deaf and Blind. The reason for the study is that the school is set out by itself and is not sure where the governance for the school should belong. It is currently under the Board of Public Education. There are other schools of a sort that are under the Department of Institutions, and the question is where the School for the Deaf and Blind best fits. The School provides services to communities throughout the state in the form of an outreach program.

#### Proponents' Testimony:

Robert Runkel, Director of Special Education, Office of Public Instruction, stated they are a willing partner in the study of the Montana School for the Deaf and Blind. He added that he is confident that a quality impartial and thorough report can be prepared for review by the Legislative Finance Committee, the Board of Public Education and the Office of Public Instruction (OPI). He said the federal Regional Resource Center (RRC) provides services for about 20 different areas of technical assistance. The study would be under the scope of one type of technical assistance agreements. He envisions no problem with the federal RRC participating in this study.

# Opponents' Testimony:

None.

#### Questions From Committee Members and Responses:

Senator Aklestad questioned if the monies available from the federal government for the study are also available for the school to be using for educational purposes.

Mr. Runkel said no, the State of Montana currently receives no dollars for any technical assistance agreements. They are services offered by RRC so there are no dollars coming into the state for providing technical assistance.

Senator Weeding asked if the function of the RRC is to make these evaluations.

Mr. Runkel said the federal RRC is to provide technical assistance to education departments in the state. At the state's discretion, it is to improve the quality of special education services to children in the state.

#### Closing by Sponsor:

Representative Dolezal closed, stating the ultimate decision will be made by the state. This study will make recommendations as to what type of governance model this school would best fit under; it may later find out it is properly placed under the Board of Public Education. He concluded there is a committee to report its recommendations no later than November '94, which will give the Legislative Finance Committee time to act on it. The report will also be presented to the Board of Public Education and the Office of Public Instruction.

#### EXECUTIVE ACTION ON HOUSE JOINT RESOLUTION

Motion/Vote: Senator Lynch moved that HOUSE JOINT RESOLUTION 27
BE ADOPTED. Motion CARRIED unanimously.

#### EXECUTIVE ACTION ON HOUSE JOINT RESOLUTION 29

Motion: Senator Waterman moved that HOUSE JOINT RESOLUTION 29 BE ADOPTED.

<u>Discussion</u>: Senator Devlin questioned if OPI would get these monies anyway that come out of RRC.

Mr. Runkel said OPI annually receives the services from RRC. It technically would not require formal action by the legislature for them to access those services.

**<u>Vote</u>**: Motion that HJR 29 BE ADOPTED CARRIED unanimously.


