HEARING ON HJR 31

Opening Statement by Sponsor:

Representative Wiseman, House District 33, sponsor, said HJR 31 would request an interim study on executive reorganization and options for consolidating state government agencies to achieve operational and budgetary efficiencies. problems in Montana and not much hope for increased revenue, downsizing state government is a good idea, as evidenced by actions of corporate America. State government has 18 agencies and 10,000 employees, and they should be able to reduce that figure and still operate efficiently. He concluded there is enough money in HB 2 to finance approximately three interim studies, and he would like to have HJR 31 included as one of the studies or part of a study to be done.

Questions From Committee Members and Responses:

Senator Weeding questioned what publication referring to executive reorganization was being referred to in the Resolution.

Representative Wiseman said one idea is "Reinventing Government".

Senator Waterman stated this should happen with the Governor coming through with a plan and presenting a budget to back it up rather than an interim study of the legislature.

Representative Wiseman said he is trying to encourage it to happen.

Senator Aklestad said he would like to amend HJR 31 to include in the study executive and legislative reorganization. He noted the legislature should act by example and if they are asking departments of state government to consider this, the legislature should do it as well.

Representative Wiseman said he would have no problem with that. Anything that can be done to reduce the size of state government should be looked at.

Senator Forrester questioned that an interim study would have anymore effect than legislative subcommittees reviewing this. The study would be a waste of money, and he added that direction has to come from the governor.

Senator Keating said he would like to see the bill read on page 2, line 19 after "consolidation" the insertion of "or elimination", which he felt would save money by eliminating programs and agencies.

Closing by Sponsor:

Representative Wiseman closed. He said his constituents are

unhappy that state government has not reduced itself.

Motion/Vote: Senator Waterman made a substitute motion that HJR 31 BE TABLED. Motion CARRIED with Senators Aklestad, Beck, Fritz, Hockett opposed.
