Opening Statement by Sponsor:

Representative Stovall, District 98, said HB 693 would enlarge the Interim Committee on Indian Affairs from four members to eight members. Rep. Stovall told the Committee that a new section was added to extend the appointment date of the members, to 30 days after the session. Rep. Stovall asked for a favorable consideration for HB 693.

Proponents' Testimony:

Senator Gage, District 5, supported SB 693. Senator Gage told the Committee that Montana needs better communication and education among the people of the state in regards to Indian affairs. Senator Gage told the Committee that Rep. Stovall was planning to present amendments to deal with funding for the Indian Affairs Committee. The amendment would have added a section to make funds statutory appropriated. Senator Gage said the same could be accomplished by going to the Finance Committee with a budget amendment.
