SB 16, SB 15, SB 14, SB 13, SB 9, SB 3 Executive Action:

EXECUTIVE ACTION ON SENATE BILL 16

Senator Aklestad moved Senate Bill 16 DO NOT PASS. Senator Aklestad made a substitute motion to TABLE Senate Bill 16.

<u>Discussion</u>: Senator Waterman said although this is a valuable program, the special session needs to make cuts and issues like this need to be addressed.

Senator Jacobson said this is not a debatable motion.

<u>Vote</u>: The motion CARRIED to TABLE Senate Bill 16 with Senators Lynch, Bianchi, Fritz and Waterman opposed.

EXECUTIVE ACTION ON SENATE BILL 15

<u>Motion/Vote</u>: Senator Jergeson moved that Senate Bill 15 BE TABLED. The motion CARRIED with Senator Fritz opposed.

EXECUTIVE ACTION ON SENATE BILL 14

Motion: Senator Christiaens moved that Senate Bill 14 DO PASS.

<u>Discussion</u>: Senator Jacobson said the fiscal note reflects that the general fund savings in revenue would total \$74,200.

Senator Aklestad felt the costs are passed onto the consumer. He said although it was indicated that would not happen, it would appear to him the commissioner's office could send out a memo to the insurance people that this could be done so they could work from paper shuffling to the electronic method without having a statute. He said in statutorily mandating something, there is a greater effort to get it done in a short period of time, and someone ends up paying for that.

Senator Christiaens said this is not going to cost any more for those insurance companies who go to the electronic filing. The increased fee of \$5 is only for those that do not do the electronic filing. In fact, the budget is being reduced. \$25,000 will be taken out of the budget for every year in the future. He indicated there are some start up costs, but they will be working with the industry to come up with compatible software so there will be permanent savings passed onto the consumer.

Senator Aklestad said it was going to cost the insurance companies more to set up for electronic filing than it would be to shuffle the papers. He felt the cost will go to the consumer.

Senator Jacobson said although there is no program at this time, it is evident a lot of them are interested in doing this or they wouldn't have asked the State Auditor for the program. We have to assume most of them want to gear up to the program.

Senator Devlin said in looking at the fiscal note, if there is a general fund revenue, there is an increase in revenue of \$49,000 from the fees.

Senator Christiaens said part of the reason there is more of an income is that a one time single check is being written now. Insurance companies aren't terminating agents, even though they are required to by law, because of taking the time to write a \$10 check for every agent that is terminated. There are a lot of people who are no longer agents. Once the program is up and running, it should save everyone money.

<u>Vote</u>: The motion CARRIED with Senators Swysgood, Devlin, Beck, Aklestad and Tveit opposed.

EXECUTIVE ACTION ON SENATE BILL 13

Motion/Vote: Senator Bianchi moved Senate Bill 13 DO PASS. The
motion CARRIED UNANIMOUSLY.

EXECUTIVE ACTION ON SENATE BILL 9

<u>Motion</u>: Senator Toews moved that the amendments to SB 9 be adopted (Exhibit 1).

<u>Discussion</u>: Senator Waterman asked if this would allow renegotiations only in the unified districts and not in consolidated districts.

Senator Toews said it allows renegotiation of consolidated districts since it is a new entity.

Senator Weeding asked if it was limited to salaries and benefits.

Senator Toews said yes.

<u>Vote</u>: The motion on the amendments (Exhibit 1) PASSED with Senator Lynch voting no.

Motion: Senator Aklestad moved Senate Bill 9 AS AMENDED DO PASS.

<u>Vote</u>: The motion that Senate Bill 9 AS AMENDED DO PASS CARRIED on a roll call vote.

EXECUTIVE ACTION ON SENATE BILL 3

<u>Discussion</u>: Senator Keating said he has amendments that would cap the program, adjust the benefits and change the income eligibilities as well as add some reporting requirements with

regard to income into the bill. It would eventually phase out the program through the demise of the recipients. It would cap it so there would be no new recipients. It will save money in the long run but with not much of an immediate savings. He said Senator Lynch has indicated he is going to make a move to kill the bill, and he didn't want to take the time to explain the amendments until he knew if there is interest to change the program.

Senator Lynch said before going through the amendments, he would suggest this bill should not pass. He noted that as soon as one of these widows or victims die, the savings would be there anyway. The assumption made by the budget office is that none of them are going to die immediately. He said this program is going to be eliminated within a 10 year period and concluded this is not a welfare program; it is an entitlement program.

Motion/Vote: Senator Lynch moved Senate Bill 3 BE TABLED. The
motion CARRIED on a roll call vote.
