# Discussion:

Chair Halligan asked Terry Johnson, Legislative Fiscal Analyst (LFA), if the Committee needed to know anything before voting on HJR 2. Terry Johnson responded that the Committee needed to consider one technical amendment. He explained that the House had not amended the revenue totals when they revised the price of oil.

# Motion/Vote:

Senator Towe moved HJR 2 BE AMENDED TO CHANGE THE STATE GENERAL FUND REVENUE AND THE SCHOOL FOUNDATION REVENUE TOTALS TO REFLECT THE HOUSE'S REVISIONS ON PROJECTED OIL REVENUE.

## Discussion:

**Senator Harp** asked whether those revisions had lowered the totals in HJR 2. **Terry Johnson** replied yes.

Senator Van Valkenburg asked if those totals would change the budget numbers the Legislature had been using. Terry Johnson replied no. He explained the LFA had used the new totals in all of its calculations.

Chair Halligan noted that the totals in the amendment reflected the changes in the oil price made by the House.
