discussion are paraphrased and condensed.

The first meeting of the House Taxation Committee was called for the purpose of orientation. **CHAIRMAN HIBBARD** welcomed Committee Members and asked each individual to identify themselves. An official roll call was not taken. Lee Heiman, who will serve as the Legislative Council resource person, explained the functions he will perform in support of the Committee (Exhibit 1).

CHAIRMAN HIBBARD introduced Judy Paynter, Principal Tax Administrator, Department of Revenue, who will serve as the Committee resource person from that agency. Beginning on Tuesday, January 3, 8:00 a.m., and continuing throughout the week, the staff of the Department of Revenue will provide an informational program, "A Guide to Taxes Administered by the Montana Department of Revenue." Members of the Senate Taxation Committee have been invited to attend these meetings.

CHAIRMAN HIBBARD announced that the Committee would begin hearing bills at 10:00 a.m. on Wednesday, January 4, beginning with HB 67 on that date and HB 32 and HB 38 on January 6.

CHAIRMAN HIBBARD requested that all exchanges between members be directed through him. He also asked both the minority and majority vice chairpersons to review all committee minutes. No cellular telephones will be allowed in the meeting room.

A discussion followed on the methods and purposes of tabling bills. The decision was made that the Chairman would not accept a motion to table until all Committee Members had the opportunity to speak to the bill. REPRESENTATIVE ELLIOTT clarified, for the benefit of new members, that the purpose of tabling a bill was either to postpone action on, or to kill a bill, and explained the differences between voting to table a bill and voting to kill a bill.

The **CHAIRMAN** informed members of the Committee that he would allow proxy votes which are to be left with respective minority or majority vice chairpersons. Members will also be allowed to vote in pairs with another Committee Member.

REPRESENTATIVE RANEY requested that the Chairman confer with the Sergeant at Arms to confirm that a decent amplifier be provided in the hearing room.

The Committee discussed, again for the benefit of new Committee Members, the future of a bill which has been passed out of Committee with an Adverse Committee Report.

My office is located on the first floor of the Capitol in Room 117-A, Legislative Council Legal Division. My regular office hours are Monday - Friday, 7:00 a.m. - 5 p.m.; Saturday, 8 a.m. - noon.

I will perform the following functions in support of the committee:

- 1. draft all amendments adopted by the committee, using the same bill drafting guidelines as were applied to the original bill and, with the Chairman's authorization make necessary changes in grammar, punctuation, word choice, and sentence structure, not affecting meaning;
- 2. draft proposed amendments upon request of individual committee members before committee action on a given bill;
- 3. draft proposed amendments to be moved on Second Reading upon request of any committee member;
- 4. draft committee bills;
- 5. review proposed legislation and advise the committee as to constitutionality, internal consistency, possibility of conflict with or duplication of existing provisions, and compliance with other bill drafting provisions such as grammar, punctuation, word choice, and

statutory sentence structure;

- 7. attend subcommittee meetings to perform the appropriate functions listed above;
- 8. attend conference committee or free conference committee deliberations as invited to perform the appropriate functions listed above; and
- 9. assist the committee or an individual committee member in obtaining data or any pertinent information from state or local agencies, the federal government, or other states pertaining to bills under deliberation by the committee.

Revenue bills are acted on according to a different schedule than general bills and resolutions. The following are the legislative days and calendar dates that apply to revenue bills:
