EXECUTIVE ACTION ON SENATE BILL 27

Motion: SENATOR SWYSGOOD MOVED SENATE BILL 27 DO PASS.

Vote: MOTION CARRIED.

EXECUTIVE ACTION ON HOUSE BILL 43

Motion: SENATOR BECK MOVED HOUSE BILL 43 BE CONCURRED IN.

<u>Discussion</u>: SENATOR WATERMAN asked why a budget amendment was needed between now and October.

SENATOR LYNCH said it was easier for the Code Commissioner if they have the normal date.

SENATOR KEATING said the bill facilitates the cash flow for their enterprises; they need to buy goods spontaneously as they never know what their sales are going to be.

SENATOR SWYSGOOD said page 2, line 19 says a budget amendment that is submitted to the legislature for approval during a legislative session may not include authority to spend money beyond the first fiscal year of the next biennium, which is probably why they want it effective on passage and approval. A budget amendment might not include that authority.

SENATOR AKLESTAD said that would be the gap between July and October.

Clayton Schenck said there was a change in the budget amendment law in the last biennium concerning emergency appropriations.

Vote: Motion CARRIED.

EXECUTIVE ACTION ON SENATE BILL 83

SENATOR KEATING said he talked to the Department of Agriculture about the Growth Through Agriculture Act and ascertained they needed money for grain marketing in the department, but they are not interested in the grants from the coal tax. He explained that he does not believe coal tax money should be given to private organizations in the form of grants. There are other funds that businesses can borrow from and other areas of grants to universities.

<u>Motion/Vote</u>: SENATOR KEATING MOVED THAT WE RECONSIDER ACTION ON SENATE BILL 83 FOR PURPOSES OF AMENDMENT. MOTION CARRIED.

Motion: SENATOR KEATING MOVED TO AMEND SENATE BILL 83. EXHIBIT 1

<u>Discussion</u>: SENATOR KEATING said the effect of the amendment would be that no coal tax money would be going to Montana Growth Through Agriculture. The money would return to the general fund, and then a direct appropriation would be made to Agriculture from the general fund if it was needed for marketing, which would be about \$250,000 to \$500,000. SENATOR WATERMAN said she was against the amendment.

SENATOR SWYSGOOD asked if it would automatically flow to the general fund.

SENATOR KEATING said it would. He also said that on page 9 of the bill the Growth Through Agriculture is struck from the statutory appropriation so that money will automatically go to the general fund.

SENATOR JACOBSON said if it gets appropriated to one of the other programs, it would not. Growth Through Agriculture is still on the books.

SENATOR KEATING said it is not being eliminated, and it is funded out of a different special account. If they want to get rid of the program, it will have to be repealed at some point.

SENATOR JACOBSON asked SENATOR KEATING if it was his intention to eliminate the program.

SENATOR KEATING said yes.

SENATOR JACOBSON questioned if the committee should have a bill drafted to do that.

SENATOR KEATING said if the committee was willing, that would be the best procedure.

SENATOR FRANKLIN said she felt additional testimony was needed on this issue.

SENATOR JERGESON resisted the motion. He said although the Department of Agriculture may be willing to give up the Montana Growth Through Agriculture Act, he is not convinced that the farm coalition, made up of all the farm groups in the state of Montana is prepared to give it up. They feel the program hasn't been as effective as it could be because so much of the money has been siphoned off and put into other programs.

SENATOR AKLESTAD said the motion before the committee now is to change the funding mechanism. A special committee bill would be needed to eliminate the program and at that time SENATOR FRANKLIN'S concern would be addressed.

SENATOR WATERMAN said this would lower the percentage by 2 percent. She voiced concern that they are not just striking Montana Growth Through Agriculture; they are lowering the percent from 22 to 20 percent.

SENATOR KEATING said on page 9, line 3, SENATOR GROSFIELD has added up all of the coal tax money that is being struck from the library, conservation districts, Growth Through Agriculture, etc. They are then lumped together above and given the total of coal

tax money that was appropriated into a lump sum. Because we are taking the 2 percent out, we have reduced the lump from 22 to 20 percent. The others are still dividing the amount of statutory appropriation that they had previously.

<u>Vote</u>: SENATOR KEATING'S motion CARRIED with Senators TVEIT, WATERMAN, JENKINS, JERGESON AND FRANKLIN opposed.

Motion: SENATOR KEATING MOVED SENATE BILL 83, AS AMENDED, DO PASS.

<u>Vote</u>: The motion CARRIED with SENATORS JENKINS, LYNCH, WATERMAN and MOHL OPPOSED.

<u>Motion</u>: SENATOR JACOBSON MOVED THAT THE COMMITTEE ASK FOR A BILL DRAFT REQUEST FOR A REPEAL OF THE GROWTH THROUGH AGRICULTURE PROGRAM.

<u>Discussion</u>: SENATOR AKLESTAD, explaining the motion, said there is statutory language that would take Growth through Agriculture out. A hearing would be held on a bill, which would cover Senator Franklin's concerns. He added that it takes a two-thirds vote for a committee bill.

<u>Vote</u>: SENATOR JACOBSON'S motion CARRIED on a roll call vote. SENATORS JERGESON, FRANKLIN, TVEIT AND JENKINS voting no.





(a) The amount of 25% of each driver's license fee and of each duplicate driver's license fee must be deposited into an account in the state special revenue fund. The department shall transfer the funds from this account to the Montana highway patrol officers' retirement pension trust fund as provided in 19-6-404.

(b) (i) If the fees are collected by a county treasurer or other agent of the department, the amount of 3.75% of each driver's license fee and of each duplicate driver's license fee must be deposited into the county general fund.

(ii) If the fees are collected by the department, the amount provided for in subsection (1)(b)(i) must be deposited into the general fund.

(c) (i) If the fee is collected by a county treasurer or other agent of the department, the amount of 5% of each motorcycle endorsement must be deposited into the county general

fund.

(ii) If the fee is collected by the department, the amount provided for in subsection (1)(c)(i) must be deposited into the general fund.

(d) The amount of 8.75% 35% of each driver's license fee and of each duplicate driver's license fee must be deposited into the state traffic education account.

(e) In addition to the amounts deposited pursuant to subsections (1)(b)(ii) and (1)(c)(ii), the amount of 62.5% 36.25% of each driver's license fee and of each duplicate driver's license fee must be deposited into the state general fund.

(f) If the fee is collected by the county treasurer or other agent of the department, the amount of 3.75% of each commercial driver's license fee must be deposited into the county general fund, otherwise all of the fee must be deposited in the state general fund.

(g) The amount of 95% of each motorcycle endorsement fee must be deposited into the state traffic education account in the state special revenue fund.

(2) (a) If fees from driver's licenses, commercial driver's licenses, motorcycle endorsements, and duplicate driver's licenses are collected by a county treasurer or other agent of the department, the county treasurer or agent shall deposit the amounts provided for in subsections (1) (b) (i) and (1) (c) (i) into the county general fund. The county treasurer or agent shall then remit to the state treasurer all remaining fees, together with a statement indicating what portion of each fee is to be deposited into the account in the state special revenue fund as provided in subsection (1) (a) and the state general fund. The state treasurer, upon receipt of the fees and statement, shall deposit the fees as provided in subsections (1) (a) and (1) (d) through (1) (q).

(b) If fees from driver's licenses, commercial driver's licenses, motorcycle endorsements, and duplicate driver's licenses are collected by the department, it shall remit all fees to the state treasurer, together with a statement indicating what portion of each fee is to be deposited into the account in the state special revenue fund as provided in subsection (1)(a), the state special revenue fund, and the state general fund. The state treasurer, upon receipt of the fees and statement, shall deposit the fees as provided in subsections (1)(a), (1)(b)(ii), (1)(c)(ii), and (1)(d) through (1)(g).""
