EXECUTIVE ACTION ON SB 284

Motion: REP. JOE TROPILA MOVED THAT SB 284 BE CONCURRED IN.

Discussion:

- REP. SAM KITZENBERG stated there are good quality jobs is Montana and he would like to see the competition strengthened. He didn't see replacements happening and he didn't want to see any more reductions taking place.
- REP. LILA TAYLOR stated this was a hard vote for her to make but she would vote for the bill.
- REP. PAT GALVIN read a letter to the committee. He stated the letter had raised two questions for him. The first being if this should be before the legislature and the second being if it is good policy to do this.
- REP. DICK GREEN stated he was in support of the bill. The \$7 million won't evaporate. He wanted to keep it in the state of Montana because if they had to sell it would be going out of state and Montana and the people would lose.
- REP. JAY STOVALL spoke in support of the bill. Montana Power had tried to work with the PSC on the bill. The criteria now is not workable and this is the best way for them to market the company.
- REP. GAY ANN MASOLO stated the legislature had started the PSC for change. Montana needs the jobs and they need to include the business into that.
- REP. MATT DENNY stated it is not a matter of jobs or state competition. The PSC gets its power form the legislature. He believed this was an appropriate way to evaluate.

<u>Vote</u>: Motion carried unanimously with REP. BILL REHBEIN voting by proxy.

EXECUTIVE ACTION ON SB 105

Motion: REP. HARRIET HAYNE MOVED THAT SB 105 BE CONCURRED IN.

Discussion:

Sheri Heffelfinger briefed the committee on what the bill would do.

- REP. STOVALL asked how often these people would meet.
- Ms. Heffelfinger stated they now meet twice during the interim. They are to meet at the call of the chairman.
- REP. STOVALL stated that wasn't much time.

REP. CAROLYN SQUIRES stated each rule is looked at by Mr. John McMasters of the Legislative Council. The committee members each receive a package about the rules. All rules are observed by the staff. There is not only a problem with finances, but not many comply.

Discussion:

Ms. Heffelfinger stated the constitutionality of this bill is challengeable.

REP. MATT BRAINARD stated the majority of the bill is a good idea.

REP. DENNY stated they needed to address the constitutionality of the bill. This bill would not have the same effect if some of it was summarized.

Motion/Vote: REP. TROPILA MOVED TO DELAY ACTION ON THIS BILL. The committee agreed to delay action until later that morning.

HEARING ON SB 279

Opening Statement by Sponsor:

SEN. LINDA NELSON stated this would provide the staff help with calls during the interim. This would include calls to the state government. This would cost no more than \$300. These people need the opportunity to educate themselves and this is the cost of being legislators.

REP. GALVIN asked what the prior figure for the cost of the phone was.

SEN. NELSON stated she had no idea.

CHAIRMAN SIMPKINS stated he could not remember either.

REP. MASOLO asked if the interim committee expenses would be reimbursed.

SEN. NELSON stated they would not be reimbursed.

REP. DENNY asked if they would receive credit cards or phone cards.

SEN. NELSON stated they would receive a phone card.

REP. DENNY asked if this was different than SEN. KLAMPE's bill.

SEN. NELSON stated with that bill they were to receive \$100 for any thing they wanted to spend it on. It was like an additional pay for them.

CHAIRMAN SIMPKINS asked what had happened to that bill.

SEN. NELSON stated the bill had been tabled.

Closing by Sponsor:

SEN. NELSON stated the Governor's office had said this was out of his budget. She believed this bill was long overdue. She asked the committee to give the bill their favorable consideration.

HEARING ON SB 220

Opening Statement by Sponsor:

SEN. SUE BARTLETT stated this was at the request of the Montana Supreme Court. They need to conform statutes. This would make it possible to have records recorded electronically from the Municipal Court to the Supreme Court. They would not be required to do this but it would give them the legal authority to do so if they wished.

Proponents' Testimony:

Pat Chenovick, Supreme Court Administration, stated this addresses a shortfall in the statutes. It wouldn't mandate that the courts do this but allows them the option. It would standardize filing and would allow for an increase in availability for storage. This would cut down on the damage that has occurred in the past to the permanent records and would increase efficiency. There would be no fiscal impact for implementing this idea because it would be optional.

Gary Spaeth, State Bar, stated this would make the court system more efficient. The people are moving into a new age and the courts need to make that move as well.

REP. MASOLO asked how this bill was different from REP. HAGENER's bill.

SEN. BARTLETT stated this would allow those people who want to do this to do it, and those who don't want to or don't have the capabilities to do this wouldn't have to do this. In REP. HAGENER's bill, which was more revised, she allowed for a \$5 surcharge to update the systems.

REP. DENNY asked if there was a master plan of how the judicial system would do this.

Mr. Chenovick stated the Supreme Court would have to establish the boundaries for standardizing. The courts recognize that the money is already being spent. The Supreme Court already recognizes that they will have to update the system to be standardized. They are doing this in order to be in accordance with one another.

REP. DENNY asked if this will allow for better service.

Mr. Spaeth stated they would generally get paid by the hour. This would save time and in the process it would save money as well.

REP. STOVALL asked if there would be any type of movement.

Mr. Chenovick stated although laws and some procedures are unique they haven't looked to other states to do this.

SEN. BARTLETT closed thanking the committee for their time.
