Committee Business Summary: Hearing: HB 600

HEARING ON HB 600

Opening Statement by Sponsor:

REP. PAUL SLITER, House District 76, Kalispell, stated that HB 600 would create a mechanism for counties to voluntarily enter into agreements with the Department of Fish, Wildlife, and Parks to make county funds available to match U.S. Coast Guard funds for boating safety related work. The program would fund county boat safety officers to perform recreational boat safety enforcement. Counties that have expressed interest in the program were Flathead Lake, Cascade, Yellowstone, and Missoula. He distributed copies of letters from different counties that supported the bill. One of the sections of the bill removed Lambeth State Park from the primitive parks list and replaced it with Greycliff Prairie Dog Town state park. He asked for favorable consideration of the bill. **EXHIBIT 1**

Proponents' Testimony:

Ken Hoovestal, Montana Boating Association, expressed support for the bill. It would be economically beneficial for counties to be involved in the program. There were several counties interested in the program. The termination date in Section 8 was approaching from HB 463, which was heard last session. They felt that FWP did a good job with the money and programs. He asked the committee to give the bill favorable consideration.

Howard Gipe, Flathead County Commissioner, expressed support for the bill.

Blake Wordal, Lewis and Clark County Commissioner, expressed support for the bill.

Charles Brookes, Yellowstone County, spoke on behalf of the commissioners and expressed their support of the bill.

Jim VanBlaricom, Lake Mary Ronan Association, handed in a witness statement in support of the bill. Lambeth State Park needed improvements. EXHIBIT 2

Arnie Olson, Administrator of the State Parks Division, FWP, distributed written testimony and a summary of boating projects. Because of limited personnel and budgets, the department has not been able to keep pace with the expanding recreational use of Montana's lakes and rivers. Public demand continues to increase for boat safety and law enforcement. HB 600 would allow FWP to enter into cooperative agreements with counties on a voluntary basis. Under this program, a county may designate fees collected in lieu of taxes on boats to be matched with federal Coast Guard funds. These funds would be used by counties to provide boat safety and enforcement. EXHIBITS 3 AND 3A

Opponents' Testimony:

None.

Questions From Committee Members and Responses:

REP. JACK WELLS asked **REP. SLITER** what gave him the idea for the bill. **REP. SLITER** said a portion of the bill appeared in SB 214. He took that idea and expanded on it. SB 214 experienced some complications and one county opposed it. The project as described in HB 600 would work well. **REP. WELLS** asked about the Lambeth State Park. **REP. SLITER** said that it had been designated as a primitive park during the last session. A primitive park may not be further developed but only maintained. Lake Mary Ronan needed road repairs, and the bill would benefit that park. **REP. WELLS** asked if Greycliff Prairie Dog Town state park was near Lambeth State Park. **REP. SLITER** said no.

REP. ROD MARSHALL asked **REP. SLITER** if any of the parks' names were being changed. **REP. SLITER** said no. **REP. MARSHALL** asked about other parks being removed from the primitive parks list. **REP. SLITER** said the current list would remain the same with the exception of Lambeth State Park. That park was stricken and Greycliff Prairie Dog Town park was inserted.

REP. BOB PAVLOVICH asked **Mr. Hoovestal** why a county did not want to support SB 214 during its hearing. **Mr. Hoovestal** said the reason there did not appear to be very much support for that bill at the hearing was because their letters did not get to the committee in time. There was also confusion regarding which committee it should be heard in. HB 600 was an improvement from SB 214 and was supported.

REP. BILL TASH asked **Mr. Hoovestal** asked about Beaverhead Rock State Park. He referred the question to the bill's sponsor. **REP. SLITER** said that it was currently a state primitive park and that would not change.

REP. PAVLOVICH asked if HB 600 covered the same subject matter as SB 214. **Doug Sternberg, Legislative Council,** said no. HB 600 went beyond the scope of SB 214 and was a broader bill. It reappropriated funds for the proposed program and included the primitive parks change.

REP. BOB REAM asked about the change in fees in lieu of tax found on page 2, line 21. **REP. SLITER** explained that 25% was the original amount that was deducted from the boat fee in lieu of tax and placed into the motorboat account. In HB 600, the 25% was being reduced to 20% and the remaining 5% would go toward matching funds with the Coast Guard money. This money would be sent back to the counties so that the sheriffs could enforce water safety laws. **REP. REAM** said that the full 25% was still being used. **REP. SLITER** said yes.

REP. EMILY SWANSON asked **REP. SLITER** how he was able to get two subjects into the title of one bill. **REP. SLITER** said it was felt that the Greycliff Prairie Dog Town park could be listed as a primitive park since Lambeth State Park needed improvements. **REP. SWANSON** said that she thought the rules allowed only one topic per bill. **REP. SLITER** said that since state parks would be improved by money coming from boat fees, Lambeth State Park could benefit from some of that money.

CHAIRMAN DOUG WAGNER asked about the fiscal note. REP. SLITER said he had signed it but did not have a copy of it.

CHAIRMAN WAGNER asked about the source of the Coast Guard money. REP. SLITER said that it came from a Coast Guard program for local water safety. The Coast Guard currently did not patrol nonnavigable waters in Montana, but provided funding for state and local governments to do so. CHAIRMAN WAGNER asked which county complained about SB 214 and had those concerns been addressed. REP. SLITER said Lake County protested it. However, for HB 600, they withdrew their objection and offered a letter of support.

CHAIRMAN WAGNER asked Mr. Olson about the source of Coast Guard money secured for Montana. Mr. Olson said Coast Guard money was made available to various states for water safety. It required a one-to-one matching of state funds. CHAIRMAN WAGNER asked if it was federal money. Mr. Olson said yes. CHAIRMAN WAGNER asked if he saw a possible problem if federal funds were revoked so that the federal budget could be balanced. Mr. Olson said it was always a possibility with any federal program.

REP. BILL REHBEIN asked **REP. SLITER** about the location of Medicine Rocks State Park. **REP. SLITER** said it was located near Ekalaka. **REP. REHBEIN** asked about the use of the boat funds. **REP. SLITER** explained that the money from boat fees was placed into the motorboat account. The money would be used in the county in which it was collected for the development and upkeep of boating access sites. The Lambeth State Park was in need of improvements. It needed to be taken off of the Primitive Parks list in order to make improvements because improvements were not allowed in primitive parks.

REP. REHBEIN asked if there was a certain amount of money available in Carter County, could that money be spent on Medicine Rock State Park. **REP. BOB RANEY** said that the Primitive Park Act was passed in the last legislature and 15 parks were given the primitive park status. These parks had not been developed beyond toilets, picnic tables, boat ramps, and roads.

If Lambeth State Park remained on the primitive parks list, no improvements could be made. **REP. JOHN MERCER** had expressed an interest in removing the park from the list, since it was in need

of repairs. This part of the bill had nothing to do with Coast Guard money.

REP. REHBEIN stated that the only purpose of Section 6 in the bill was to replace Lambeth State Park with Greycliff Prairie Dog Town state park. **REP. RANEY** said yes. However, he disagreed with the choice of park used to replace Lambeth State Park. **REP. REHBEIN** asked why there needed to be a list of 15 parks. **REP. RANEY** said originally it was a list of 20, but some of the parks were too far developed. **REP. REHBEIN** asked if the list could just be reduced to 14 parks rather than having 15 parks. **REP. RANEY** said the list could include only 14 parks.

REP. CHARLES DEVANEY asked **Mr. Olson** if improvements to fishing access sites would be done by region. **Mr. Olson** stated that the money had to stay within the region where the boats were used.

CHAIRMAN WAGNER understood that the money collected in Flathead County could be dispersed to other areas so long as it remained within Region 1. Mr. Olson said he was correct. There was a boating advisory committee to help make recommendations on where to spend the money based on public input.

REP. PAVLOVICH asked if Georgetown Lake would be included. **Mr. Olson** said it was not included for improvements. However, law enforcement could still be used for water safety.

<u>Closing by Sponsor</u>:

REP. SLITER stated fees paid by boaters would be used to improve areas for boat users and to enforce water safety. He asked for favorable consideration of HB 600.

EXECUTIVE ACTION ON HB 600

Motion: REP. SLITER MOVED THAT HB 600 DO PASS.

<u>Discussion</u>:

CHAIRMAN WAGNER asked Mr. Sternberg if it was within the legal rules to have two subjects in the title of one bill. Mr. Sternberg stated that his initial concern was that it appeared as if it were two different bills. Article 5, Section 11, of the State Constitution stated that, "Every bill, except a general appropriation bill and bills for codification and general revision of the laws shall contain only one subject clearly expressed in its title." He had attempted to clarify the reason for removing Lambeth State Park on page 1, line 14. Removing the park from the list allowed for road and facility improvements at the park. Ostensibly that could include an appropriation for boating facilities that could be funded from a portion of the money raised through the boat fee in lieu of tax. The fact that Lambeth is currently on the primitive parks list precluded that

kind of development. If it was the sponsor's intent to make improvements and use a portion of boat fees to accomplish that, it was legally necessary to remove Lambeth State Park from the list so it could be accomplished. After explanation and clarification from sponsor and FWP, there appeared to be enough of a relationship between the two parts of the law. If improvements were to be made, this was how it must be done.

Motion: REP. RANEY MOVED TO AMEND THE BILL.

Discussion:

REP. RANEY stated that the amendment would strike the proposed park of Greycliff Prairie Dog Town and replace it with Big Pine Management Area. Big Pine Management Area was on Fish Creek, 15 miles east of Superior. It was presently a primitive park, including eight camp sites. The main uses of the park were for weddings and fishing. FWP had indicated they had no intentions of developing the area. The word "primitive" referred to the level of development that was allowed. When a park was placed into a primitive park status, FWP could only take care of sanitation, provide weed control, and maintain existing roads.

REP. MARIAN HANSON commented that Greycliff Prairie Dog Town was a unique place. **REP. RANEY** stated that a small amount of money was collected from the park.

REP. WELLS asked if it was legal to remove Lambeth and replace it with another park. **REP. SLITER** stated that the bill needed to be cleared with Legislative Council and they stated that it was acceptable.

REP. RANEY commented that when a section of law was opened in a bill, that section was amendable in any chosen manner. **Mr. Sternberg** stated that the largest concern should be regarding the content of the Primitive Parks Act and if the proposed park fit under those criteria.

<u>Vote</u>: AMENDMENT DO PASS. Motion passed 13 to 3 with REPS. REHBEIN, FUCHS, and HANSON voting no. REPS. ELLIOTT and HIBBARD were absent for the vote.

Motion: REP. SLITER MOVED THAT HB 600 DO PASS AS AMENDED.

Discussion:

REP. REHBEIN stated that "rather than filling the gap with another park," the qualifications of the proposed park should be reviewed. He preferred to see only 14 parks on the list.

CHAIRMAN WAGNER asked if the road into Big Pine Management Area had been paved. REP. RANEY said no.

<u>Motion</u>: REP. REHBEIN MOVED THAT BIG PINE MANAGEMENT AREA BE REMOVED FROM THE PRIMITIVE PARKS LIST.

Discussion:

REP. REAM expressed opposition to the amendment. It was a primitive park and should remain that way. The state's largest ponderosa pine tree was there.

<u>Vote</u>: REP. REHBEIN AMENDMENT. Motion carried 16 to 1 with REP. REHBEIN voting yes. REP. JIM ELLIOTT was absent for the vote.

Discussion:

CHAIRMAN WAGNER asked how large of a boat would the Coast Guard be providing for safety patrols. **REP. SLITER** explained that the Coast Guard would not provide a boat but rather the funds to promote water safety. Federal money would be used for local control. There did not appear to be "strings" attached to the funds.

CHAIRMAN WAGNER was concerned about the money being used anywhere in a region. **REP. SLITER** stated that FWP had a priority list. The list was based on requests from boaters.

CHAIRMAN WAGNER asked about termination date of July 1, 2002. REP. SLITER explained that it would allow the program to continue for another seven years. The 2001 Legislative Session could review the program and determine if it was successful.

<u>Motion/Vote</u>: DO PASS AS AMENDED. Motion carried 15 to 2 with REPS. WAGNER and REHBEIN voting no. REP. ELLIOTT was absent for the vote.





House Bill No. 600 March 23, 1995 Testimony presented by Pat Graham Montana Fish, Wildlife & Parks before the House Fish and Game Committee

Because of limited personnel and budgets, the Department has not been able to keep pace with the expanding recreational use of Montana's lakes and rivers. Public demand continues to increase for boat safety and law enforcement and is putting increase pressure for facilities by boaters.

Section (1) of HB 600 will allow FWP to enter into cooperative agreements with willing counties to help with enforcement of boating laws. This is strictly a voluntary program. The House Appropriations Committee in HB 2 eliminated two water safety FTEs but left the federal funding to allow us to explore the potential of entering into agreements with local governments. Under this program a county may designate fees collected in lieu of taxes on boats to be matched by FWP using federal Coast Guard funds. These funds would be used by counties to provide for boat safety and enforcement.

This law is necessary because federal requirements specify that only state funds may be used to match Coast Guard money. This will allow us to return the money to the country with a like amount of federal money under an approved state grant. Coast Guard funds are matched one-to-one.

Cascade, Flathead, Big Horn, Lake, and Missoula Counties to date have expressed an interest in participating in such a program. The level of participation will be determined by the counties and the available funding.

Section 2 revises action by the 1993 Legislature. They passed HB 463, which temporarily allocated 25 percent of the fees paid in lieu of tax to FWP to provide boating facilities. This bill was passed at the request of boaters who desired that the fees they paid for boats be put into boating improvements. The remaining 75 percent of fees collected by counties remain with the counties for their use. HB 463 also created the Boating Advisory Council.

HB 600 continues the efforts started in 1993 but reduces the temporary allocation to 20 percent. The remaining 80 percent stays with the counties, a portion of which may be used as described in Section 1 for water safety grants. During the last two years FWP has been very successful working with the Boating Advisory Council and Montana boaters to put these funds to beneficial use. Unfortunately, the need for boating improvements and maintenance far outstrips our ability to respond to the needs of boaters. I have two attachments which show the projects we have accomplished as well as some existing boat facility needs. HB 600 can help provide for these needed improvements putting boaters fees into boating projects.

HB 600 also removes Lake Mary Ronan State Park from the Primitive Parks designation. This redesignation will allow Lake County to pave the county road through the park which serves the park as well as area cabins and residences. The Primitive Parks law currently prohibits the county from paving its own road. Lake Mary Ronan would be replaced on the Primitive Parks list by Greycliff Prairie Dog Town State Park, which is located near Big Timber on Interstate 90. The prairie dog town is by its nature a primitive park.

I urge your support and passage of House Bill 600.
