HEARING ON SJR 20

Opening Statement by Sponsor:

SEN. KEN MESAROS, Senate District 25, Cascade, stated that SJR 20 honored Doug Swingley, the winner of the 1995 Iditarod Trail Dog Sled Race. The state can be proud of this distinguished accomplishment. Mr. Swingley was the first non-Alaskan to win the 1,161 mile race from Anchorage to Nome, Alaska. Not only was he the first person from the lower 48 states to win, he also set a new record for completion of the race. He completed it in 9 days, 2 hours, and 42 minutes with the assistance of his sled dogs Vic and Elmer. Mr. Swingley has raced in the Iditarod four previous times and had also won two other sled dog races. SEN. MESAROS believed it was fitting that the legislature recognize Mr. Swingley for this major accomplishment. He urged the committee to concur in the resolution.

Proponents' Testimony:

Sheryl Motl, citizen, said she had worked with the Montana Race to the Sky Sled Dog Race for 10 years. There were two races. One was a 300-mile race and the other was a 500-mile race. She said it was an outstanding achievement that a non-Alaskan won the Iditarod race. Mr. Swingley and his brother were a team of mushers. The Swingley family was an old Montana family from the Great Falls area. Between the two brothers, they win almost every race that they enter. Mr. Swingley always gave credit to the dogs in helping win the race. Both of the brothers were tremendous athletes, which affords them national prominence. Ms. Motl thanked the legislature for sponsoring the resolution. It would help people in Montana and throughout the nation recognize Mr. Swingley's achievement.

CHAIRMAN DOUG WAGNER handed in a letter from Pam Otto, Board member and secretary for the Montana Sled Dog, Inc., in support of the resolution. EXHIBIT 1

Questions From Committee Members and Responses:

REP. JACK WELLS asked SEN. MESAROS about the previous record for the Iditarod. SEN. MESAROS said that it was about 10 days. REP. WELLS suggested that the old record be placed in the resolution. SEN. MESAROS agreed with the idea. However, there was a problem meeting all the bill deadlines.

REP. DAN FUCHS stated that an amendment could be drafted and the governor could add it when he signed the resolution. SEN.

MESAROS believed that the governor's amendments would have to return to the Senate for concurrence. Even though they were good amendments, he would resist adding them because of the problem with time.

REP. BRAD MOLNAR asked SEN. MESAROS if he knew who Mr. Swingley's sponsor was in the race. SEN. MESAROS said he was not aware of the sponsors.

REP. BOB REAM commented that the accomplishment of the musher and the dogs should be recognized. **SEN. MESAROS** said that the dogs were mentioned in the bill. They were essential to the successful outcome of the race.

Closing by Sponsor:

SEN. MESAROS stated that the resolution would send the message that Montanans were proud of the accomplishment.

EXECUTIVE ACTION ON SJR 20

Motion/Vote: REP. FUCHS MOVED THAT SJR 20 BE CONCURRED IN. Motion carried unanimously.

SEN. MESAROS said that REP. JOHN COBB would carry the bill on the House floor.
