Rep. Harper states that he has just heard two different interpretations of the word "reasonable". He feels for this reason that the term should be defined that way there could be no misinterpretation.

defensible".

Don MacIntyre says water rights is a separate issue. They are concerned with the permit aspect.

John Bloomquist says that he had concern with "reasonable" in the hearing, but with the additional amendments placed forth by Mr. MacIntyre he doesn't.

Rep. Harper is concerned that everyone whose been using water hasn't been doing so efficiently.

Rep. Story if the term "reasonable" isn't there then we go back to the problem of why this bill is here-- permit must go through adjudication court first before a permit is issued. This way a

person can have a permit while going through the adjudication process.

Don MacIntyre told the committee that the permit is
provisional/temporary until the process is complete.

Susan Cottingham, RWRCC, doesn't have any concern over the Legislative language dealing with Tribal issues since its understood that for Tribal disputes it is superseded by Federal. She feels its a good statement of intent.

Don MacIntyre states no they have not seen the amendments. He mentioned that they did invite the Tribes and the Federal Government to participate in the drafting of the Bill. {Tape: 1; Side: b; Approx. Time Count: 7.7; Comments: none.}

**Kathleen Williams, Staffer,** asked for clarification regarding subsection a and removing the whole phrase rather than just the word "prior".
