The council function can go forward with or without legislative funding. In answer to the question, do new programs need statutory authorization, Mr. Petesch said that all programs have to have some sort of statutory authorization. It can be as specific as the legislation that created the FAIM program. Or, it could be a program performed under a more general responsibility statutorily contained. It is important to note that in the event of a revenue shortfall, programs defined in statute are required by law to be more protected than those that merely exist without specific statutory definition.}
