HEARING ON HOUSE BILL 11

Ms. Nan LeFebvre, LFD, reviewed the Treasure State Endowment Program (TSEP) fund balance projections and grant recommendations for the 1999 biennium EXHIBIT 1 and distributed a TSEP hearing agenda. EXHIBIT 2

Mr. Robb McCracken, Department of Commerce (DOC) TSEP manager, gave an overview of the program. EXHIBITS 3, 4 and 5. Questions were asked.

Discussion regarding past and/or current projects took place. Mr. Jim Edgcomb, DOC TSEP Program, discussed the East Glacier project. Mr. McCracken EXHIBIT 6 and Mr. Edgcomb EXHIBIT 7 concluded the overview; questions were asked.

Mr. Steve Huntington, Mountain West Management consultant with DOC, spoke about the financial analysis system. **EXHIBIT 8** Questions were asked.

Mr. Huntington and Mr. McCracken discussed the local governments' role in the ranking process and how the limitations of a community's debt capacity are taken into consideration.

Mr. McCracken then discussed bridge project financial analysis. EXHIBITS 10 and 11 Mr. Edgcomb reviewed the two bridge projects currently applying for TSEP funds (Richland County and Lewis and Clark County).

Questions were asked. It was brought out that the Richland County Project had not been recommended for funding due to a technical flaw. There was general agreement to work with the department further to develop a better ranking policy for bridge projects.

Mr. McCracken discussed the provisions in SENATE BILL 88, which would place the TSEP on an annual cycle and modify the ranking criteria. EXHIBIT 12

Questions were asked. Community support and ability to pay was discussed, as well as proposed priority No. 6, which concerned infrastructure projects in low/moderate income housing projects. CHAIRMAN BERGSAGEL expressed opposition to SB 88. The role of the Governor's Office vs. the Legislature in the review of TSEP funding recommendations was discussed, as well as the issue of timeliness. The merits of SB 88 were argued.

Mr. Jeff Hintz, Interstate Engineering, Inc., and project
engineer, commented on the fluoride issue and addressed the areas
