Mr. Childress stated that FWP were the responsible department for endangered species.

Motion/Vote: REP. JOHNSON MOVED TO APPROVE ITEM 1, BEAR MANAGEMENT SPECIALIST WITH LANGUAGE IN HB 2 REQUIRING EVALUATION FOR THE NEXT BUDGET CYCLE AND SWITCH APPROPRIATIONS FROM FEDERAL FUNDS INTO STATE SPECIAL REVENUE USING FEDERAL FUNDS FIRST IF AVAILABLE. Motion carried unanimously.

Mr. Lloyd said there was still one license that was past the 5 year average.

EXHIBIT 12, Page C-25. Mr. Lloyd referred to Item 2, which the statute doesn't address what happens to the unspent or unobligated funds in the license account.

Mr. Lloyd explained that in Item 3, the statute doesn't address the account where the additional revenue from the sale of licenses should go. The department chose to place the funds into a separate account.

Mr. Lloyd stated that under Item 4, that statute doesn't direct what the increased license fees should be used for. The intent was to use those funds for the Hunter Enhancement Program, but the statute doesn't say that.
