Jerry Wells, Administrator Field Services Division explained the reason for the FTE request.

Mr. Graham stated that without the FTE, they could reduce the request to \$65,000.

Motion/Vote: SEN. KEATING MOVED TO APPROVE \$65,000 BIENNIAL APPROPRIATION FOR ITEM 3 AND RESTRICTED TO THE PUBLIC WILDLIFE INTERFACE MANAGEMENT PROGRAM. Motion carried unanimously.

Motion/Vote: REP. WISEMAN MOVED TO CLOSE THE HEARING ON FIELD SERVICES. Motion carried unanimously.

CHAIRMAN DEBRUYCKER asked if the Enforcement Division was in charge of game farms.

Ms. Galda replied yes.

CHAIRMAN DEBRUYCKER stated that there were a lot of unhappy people out there according to correspondence he had received. They stated that the permits took too long to process, sometimes 3 to 4 months after they had applied for them and were still waiting.

Ms. Galda responded that they do have time limits and said there were one or two problems, but they were trying to monitor those better.

SEN. KEATING asked what kind of animals were in the game farms.

Ms. Galda responded the game farms consisted of elk and deer, mostly whitetail deer.

Ms Galda state that a game farm near Darby had fenced 1,100 acres of the existing game farm and is proposing to add another 1,800 acres. That area winters a lot of mule deer and elk.

SEN. KEATING stated that game farmer was fencing approximately 5 square miles of his private property. However, that farmer was impacting the forest area and other private property with the migration of the game animals.

Ms. Galda stated that the farmer would have to obtain and EIS for a cost of approximately \$65,000.

SEN. KEATING said if the department wants to double the contacts they would have to double their force.

MS. GALDA replied that 50% go to the general funds and 50% goes to the counties for fines.

Mr. Lloyd stated that on Page C-44, Item 4 the request was for \$25,000 private funds for LCA. Therefore, that amount was unnecessary to be appropriated in HB 2 because the legislature does not appropriate private funds, so that amount could be reduced from the division's budget.

Motion/Vote: SEN. BAER MOVED TO ADOPT THE LANGUAGE PROPOSED ON PAGE C-38. Motion carried unanimously.

Ms. Galda stated that they would like the game farms budget of \$104,000 to be a biennial appropriation so they have the flexibility to use that in one fiscal year if necessary.

Motion/Vote: SEN. KEATING MOVED TO APPROVE \$104,000 BIENNIAL APPROPRIATION FOR GAME FARMS. Motion carried unanimously.

Mr. Lloyd said the increase the division was requesting was included in SEN. KEATING'S motion. He asked if Goal No. 3 would have to be changed.

Mr. Graham stated on performance based budget will they have to look at that in all divisions.

Mr. Lloyd said there was no specific direction in HB 2.

Motion/Vote: REP. WISEMAN MOVED TO CLOSE THE LAW ENFORCEMENT DIVISION. Motion Carried unanimously.

Page C-8 - Mr. Lloyd reviewed the program description and the funding.

Dave Mott, Administrator Administration and Finance Division reviewed his background training.

Mr. Mott stated that last year they licensed 450,000 hunters and anglers, residents and non-residents. He reviewed the businesses that sell licenses for the department.

Mr. Mott said that licenses for moose, sheep and goats were not sold over the counter. They were restricted to drawings.

He said the department also manages the vehicles such as those use by wardens.

8) Change in License Structure:

Mr. Lloyd reviewed the LFD Issues on Item 8.

Mr. Mott explained that they used to sell doe tags over the counter from license agents. However, because of declining population they would go through the license drawing process.

Discussion:

Mr. Mott said a license agent sold a license for .50. But with the drawing there has to be an application filled out. If that application was not drawn they would refund that fee of \$3.00.

Motion/Vote: SEN. KEATING MOVED TO APPROVE ITEM 8, CHANGE IN
LICENSE STRUCTURE. Motion carried unanimously.

10) Physical Inventory of Property:

Motion/Vote: REP. WISEMAN MOVED TO APPROVE ITEM 10, PHYSICAL INVENTORY OF PROPERTY. Motion carried unanimously.

11) Reimbursement to the General Fund:

Motion/Vote: SEN. KEATING MOVED TO APPROVE ITEM 11, REIMBURSEMENT TO THE GENERAL FUND. Motion carried unanimously.

12) Vehicle Account Transfer:

Motion: SEN. KEATING MOVED TO APPROVE ITEM 12, VEHICLE ACCOUNT TRANSFER.

Discussion:

Mr. Lloyd stated that there were 3 proprietary accounts that had to have the rates set. The vehicle and Aircraft account was one of those accounts.

Vote: Motion carried unanimously.

13) Legislative Contract Authority:

Mr. Lloyd reviewed the LFD Issues for Item 13.

Mr. Mott explained that there should be a \$30,000 adjustment in Other Base Adjustments which would be (3,790) each year.

Motion/Vote: REP. WISEMAN MOVED TO APPROVE THE ADJUSTMENT TO OTHER BASE ADJUSTMENTS LEAVING A BALANCE OF (\$3,790). Motion carried unanimously.

Motion/Vote: SEN. WISEMAN MOVED TO APPROVE ITEM 13, LEGISLATIVE CONTRACT AUTHORITY FOR \$30,000 EACH FISCAL YEAR WITH THE (3,790) ADJUSTMENT IN OTHER BASE ADJUSTMENTS. Motion carried 5 - 1 with SEN. BAER voting no.

14) Equipment Replacement:

Motion/Vote: SEN. KEATING MOVED TO APPROVE ITEM 14, EQUIPMENT REPLACEMENT. Motion carried unanimously.
