## HEARING ON HOUSE BILL 188

Ms. Mary Bryson, Director, Department of Revenue (DOR), gave an overview of the Department's proposed integrated tax systems.

MCCANN, Mr. Miller and Mr. David Owen, Montana Chamber of Commerce, discussed the projected \$13 million in cost savings within the "PRISM" component of the proposed changes. Ms. Bryson commented that the savings to state government would be six to fourteen full-time equivalents (FTE).
