# HEARING ON THE VOCATIONAL AGRICULTURE EDUCATION POSITION

REP. DON HOLLAND requested representatives from the Office of Public Instruction (OPI) and Montana State University (MSU), Bozeman be present to discuss the merits of funding the Vocational Agriculture Education (Vo Ag Ed) position at MSU rather than at OPI, as well as the continued funding levels required.

Mr. Bill Jimerson, Agricultural Teacher - Conrad, and Mr. Wayne Gephard spoke in favor of increased funding and the placement of the position at MSU. Mr. Taylor Brown, Northern Broadcasting

Systems, spoke of past funding levels and the current work load of the position.

Mr. Leonard Lombardi, Retired Vocational Agriculture Educator, spoke of his former duties and the need to maintain the position. Questions from REP. HOLLAND and the committee followed. Ms. Gayle Gray, OPI, stated the current inability to fund this position through OPI. She also stated that community response and/or complaints went to OPI even though the position is currently contracted through MSU. Questions from the committee followed.

Ms. Jane Karas, Office of the Commissioner of Higher Education, discussed the fact that Perkins Grant money cannot be used to fund the Vocational Agricultural Education position. Dr. Van Shelhamer, Montana Leadership Team for Agriculture, presented the role of MSU versus OPI, and the salary/benefits of the Vocational Educational staff at MSU. Dr. Shelhamer also presented the mission statement of MSU's agricultural education program.

Ms. Gray and Ms. Kathy Fabiano, OPI, responded to questions and comments from the committee. Mr. Bob Stevens, Montana Green Growers Association, addressed the committee as well. {Tape: 1; Side: B; Approx. Time Count: 1-8; Comments: .}

Continued questions from the committee. Mr. Wayne Gilman, Agricultural Teacher, and Ms. Laurie Stelter, Teacher of Family and Consumer Sciences, stated the need for access to specialists and professionals in the field of agriculture.

Mr. George Paul, Montana Farmers Union, described the lack of communication between MSU and others in the field of agriculture (the farmers). Mr. Paul stated reasons for supporting the placement of the Vocational Agriculture Education position at OPI. Ms. Meta Loftsgarden supported increased and continued funding of the Vo Ag position, and Ms. Lorna Frank-Karn of the Montana Farm Bureau presented the written testimony of Ms. Hertha L. Lund, of the American Farm Bureau Federation.

# EXECUTIVE ACTION ON THE MONTANA SCHOOL FOR THE DEAF AND BLIND

Mr. Bob Tallerico, Legislative Fiscal Analyst, stated the need to line item language for the Montana School for the Deaf and Blind (MSDB) which will be contained in HB2.

DARYL TOEWS MOVED THAT "ITEM [\$ 73,846 GENERAL FUND] IS A BIENNIAL APPROPRIATION AND MUST BE USED TO MAKE PROGRESS IN PROVIDING SALARY INCREASES FOR MONTANA SCHOOL FOR THE DEAF AND BLIND TEACHERS AND SPECIALISTS BASED UPON A MARKET RATIO CONCEPT SIMILAR TO THE ONE ADOPTED FOR CLASSIFIED STATE EMPLOYEES".

Vote: THE MOTION PASSED UNANIMOUSLY.

Motion: SEN. TOEWS MOVED THAT "ITEM [\$ 53,000 GENERAL FUND] IS A BIENNIAL APPROPRIATION AND MUST BE USED TO FUND A 0.5 FTE, GRADE 14, PROGRAM SPECIALIST POSITION AND RELATED OPERATIONAL EXPENSES IN SUPPORT OF BUS TRANSPORTATION SAFETY".

Vote: THE MOTION PASSED UNANIMOUSLY.
