Dr. Malone discussed the core laboratory classroom portion of the project and described the Computational Biology Research Program. Dr. Malone discussed plans to make the building an "environmentally smart" building.

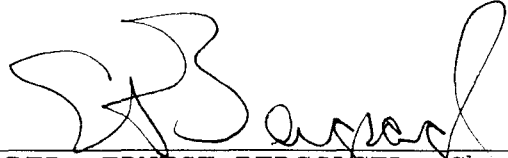
Motion/vote: SEN. BECK moved to accept the amendments contained in EXH. 23; motion carried unanimously.
