Mr. Simonich stated that because the committee reduced the staff in Personal Services in every division, means that there would be a percentage increase that would be in the Centralized Services Division. If the committee would consider the percentage rate that was negotiated with EPA there would be a decrease in Centralized Services Division staff because of less funding out of Personal Services.

Mr. Lloyd explained that Pages G-89 and G-90 explained the breakdown of Centralized Services that makes up the rate of 17%. He said that for every dollar that was reduced in the other divisions, Central Management would get .17 less.

<u>Motion:</u> SEN. KEATING MOVED TO APPROVE THE 17% RATE FOR CENTRALIZED SERVICES.

Ms. Hanson stated that because of the cuts in staff because of the committee's actions they would ask the committee to approve the rate at 19.5%. The difference between 17% and 19.5% would be approximately \$250,000.

Doug Schmitz, Budget Office said he had not heard anything on the bill regarding a fiscal note.

Mr. Simonich stated he did not agree that it would be the right thing to do to move that program to DNRC and leave the enforcement actions in DEQ. He stated that the Conservation Districts were more interested in the grants and there was only 1.1 FTE focused on that area. The others would come under the Clean Water Act.

Mr. Simonich said that to transfer that program to DNRC would severely hamper DEQ to carry out their responsibilities under the Clean Water Act.
