# HEARING ON SB 151

### Opening Statement by Sponsor:

SEN. KEN MILLER, SD 11, LAUREL, says SB 11 allows 100% deductibility for health insurance and long term care. He feels this bill is important because it is a fairness issue and it makes health insurance more affordable. He points out that the fiscal note does not have the long term benefits to the state calculated into it.

# Proponents' Testimony:

Mike Hansheu, (DPHHS), states the department is very supportive of expanding the tax deduction for long term care insurance. He says the bill promotes individual responsibility in that it gives people an alternative for controlling their assets.

Susan Good, HEAL Montana, Montana Association of Life Underwriters, strongly supports this legislation. She states long term care is one of the biggest issues in the State of Montana. Anything that can be done to encourage people to take care of themselves is a step in the right direction.

## Questions From Committee Members and Responses:

SEN. MACK COLE asks SEN. MILLER if \$3.17 million in taxes will be lost because of this proposed bill. SEN. MILLER responds it is the decrease in revenue to the state's General Fund. SEN. COLE questions SEN. MILLER as to how many people in the state will get a tax deduction. SEN. MILLER responds that 3,946 tax returns were filed last year that took the 50% deduction so he presumes that a similar amount will take the 100% deduction.

SEN. MIKE SPRAGUE wonders if this deduction can cross over state lines. SEN. MILLER states the bill presently reads if a Montana taxpayers parent is living in Idaho, long term insurance could be purchased and deducted from Montana taxes. SEN. MILLER reports an amendment could be written in restricting it from crossing state lines.

SEN. DOROTHY ECK asks SEN. MILLER if data can be obtained on the income break down of those people who are now taking advantage of the 1/2 deduction. SEN. MILLER comments he will see if that data is available.

## Closing by the Sponsor:

SEN. MILLER asks for a favorable do pass on SB 151.
